# **Chief Executive's Foreword**

As we begin 2023 and progress our ambitious work programme for the year, I would like to wish councillors and staff a very happy and heathy new year. I expect it will be a busy one and each month our Council and Area Committee meetings will have project plans and schedules to consider as we work to deliver our €989m capital plan with more than half of that budget to be spent on housing delivery.

This year as we implement our revenue budget of  $\in$  333m for 2023, we continue our focus on the delivery of key services to the people of Fingal, our budget equates to a spend of  $\in$  1,013 for each of the 329,218 residents of the county.

Maintaining and improving public realm spaces is a huge priority for the council and with that in mind, almost €20m has been set aside for the ongoing maintenance of over 5,000 acres of open spaces, regional parks and sporting facilities which are key elements of Fingal's green infrastructure. Funding is also included for the continued improvement of playing pitches, playgrounds and sports facilities with €1.2m being made available for minor improvement works in parks and open spaces under the Area Programme of Works which will be presented to the Area Committees in early 2023. The increase by 11% on last year's budget is in response to the needs of the people of Fingal and to ensure this remains an excellent place in which to live, work and do business.

In recent years, the significant benefits of Active Travel have come to the fore and I am very pleased to see the substantial investment in this area starting to come to fruition in towns and villages across Fingal. Ensuring we have a safe, accessible and sustainable Active Travel network is vital in encouraging people to embrace healthier and more climate friendly modes of travel such as walking, cycling and using public transport. Some Protected Cycle Lane projects have been completed in Fingal while others are under construction and still more in the planning stage. These specially designed lanes help protect road users during busy traffic periods by separating bicycles from other vehicles and pedestrians and play a major role in enabling users to access the locality in a safe and efficient manner. Providing access to facilities such as bicycle parking, eBikes, and trishaws for Cycling Without Age as well as championing initiatives such as Safe Routes to Schools and developing major greenway infrastructure demonstrate our ongoing commitment to Active Travel for the people of the county.

The Council has a strong focus on our responsibilities in respect of energy conservation. In an effort to both reduce running costs in our buildings and to adhere to our Climate Action Plan, some of the measures we have taken including reducing the heating temperature in our buildings to 19 degrees and converting 95% of street lighting in Fingal to LED's, will assist us to reach our target of reducing energy consumption by 50% by 2030. It is an ambitious target but one that we are committed to and on track to deliver. Our Environmental Awareness and Climate Action Teams regularly promote information on our website and social media channels around Carbon Footprints, Sustainable Living, Active Travel, Circular Fashion, Reuse & Repair, and Food Waste and highlight actions that people can take to reduce their impact on the environment.

There is much to anticipate in 2023 in Fingal – thank you for your continued support.

May I, again, wish you a very Happy and Prosperous New Year.

# **Wellbeing Strategy**

Since the strategies launch in Sept 2022 there has been a number of initiatives rolled out successfully. The Wellbeing Committee and Champions have been announced to staff. They are a point of contact of staff, a source information about wellbeing activities in the organisation and are also a means of increasing communication from staff regarding what they would like to see in their wellbeing programme.

A staff supports directory has been issued with a comprehensive list of contacts for many issues that staff or their families may face from addiction, illness, bereavement, abuse etc. The employee assistance programme was rolled out and our first report from Spectrum Life's CRM Digital Services Communications

Employee Assistance programme will be available in January and from this we can see the main issues facing our staff and plan effectively to support them. Mental Health Workshops took place in December and we received great feedback from staff and managers who attended. These will be repeated later in the year.

There are also a number of wellbeing activities planned for January including:

- A staff wellbeing pack will be issued to all staff across the organisation in January. This pack will be a great tool to increase positive staff engagement in wellbeing related activities.
- Wellbeing training seminars are taking place for Building resilience, Mental Health 101, and Managing stress/ Making Changes. On Jan 11<sup>th</sup>,12<sup>th</sup>,17, 25<sup>th</sup>. Deliver online and also broadcasting in Watery Lane training room for Outdoor Staff.
- Another round of depot visits will be arranged to increase communication channels with outdoor staff.

# Gender Pay Gap Report

Fingal County Council has published its Gender Pay Gap Report for 2022. The gender pay gap is the difference in the average hourly wage of men and women across a workforce. The 2022 report shows Fingal County Council has a Mean Gender Pay Gap of 4.58% and a Median Gender Pay Gap of 1.98%. Publishing our gender pay gap data helps to reinforce our focus on supporting an open and inclusive workplace.

Our organisation is a place where all employees have the same opportunities for recognition and career development and are treated fairly and equitably at work. We continue to be committed to addressing workplace barriers to equality and creating an open and inclusive workplace community. Many equality, diversity and inclusion initiatives and supports are already in place, and we will continue to work in this area.

# **Blended Working**

All employees were invited to submit applications for Blended Working arrangements for 2023 via the new online Blended Working App. All applications have been received and arrangements are being put in place.

# **Learning & Development**

Over the course of 2022 Learning and Development team has delivered 457 courses covering over 80 topics, with 4052 attendees adding up to a total of 4031 training days.

This has exceeded pre covid levels in 2019, so a very successful year for training. In 2023 there was continued high levels of training provided with new course and opportunities being added all the time. The staff scheme of assistance programme also approved 53 scheme of assistance applications ranging from certificate up to doctorate level. To assist our staff in furthering their studies.

# HSU – Health & Safety Unit

The HSU maintained monitoring of Covid-19 selfisolations during the month of December along with completing end of year tasks. VDU and remote VDU assessments were undertaken for new entrants to Fingal County Council and this task will continue into early 2023. In addition to 301 site safety inspections, 36 site safety audits and 34 ancillary safety statements were also closed out. At end of year the risk register counted 181 risk assessments while the SOP register closed at 140 standard operating procedures. 94 workplace incidents were investigated at the close of 2022. Staff queries to the HSU continued through the month of December with the majority of queries pertaining to requests for copies of individual remote VDU assessments





# **Digital Working**

In December, staff took part in 6,296 Teams meetings, 20,375 calls took place, and 730,826 emails were received or sent by the Council.

# **Digital Services Infrastructure & Support**

1,143 support calls were logged by Council staff with the Digital Services Service Desk in the past month and 22 calls were logged by Councillors with Sord. 100% server availability and 100% network availability was achieved in the month of December.

# Time4EU visit

The Digital Strategy Team was delighted to join Our Balbriggan and the visiting Time4EU group in the Irish Institute of Music and Song in Balbriggan. Aishling Hyland, Digital Programme Officer spoke to the group about the Smart Balbriggan District and highlighted the Balbriggan 3D model using a Virtual Reality (VR) headset. The Time4EU participants were given a chance to try the VR for themselves. The group were interested in the use of 3D models to enhance citizen engagement in major planning public consultations. They were impressed by Fingal's dedication to engaging with their citizens and with the Smart Balbriggan initiative.



#### **Chief Executive Orders System**

Fingal commenced the phased rollout of the new Chief Executive Orders system from April 2022, last year. All departments have now gone live apart from People Services Department, which is scheduled to go live next Monday 23rd January. The new CE Order system was commissioned by Fingal County Council and developed in partnership with Storm Technology. The complete solution has now been made available to all participating Local Authorities through the Build to Share Framework where it can be purchased at nominal rates bv anv other LA with identical/similar business needs in terms of a Chief Executive Order system. The solution incorporates a comprehensive workflow for the creation, recommendation, approval/rejection of any CE Order, and is secured through appropriate access rights depending on roles. Up to 31st December

2022, a total of 2199 Chief Executive Orders have been approved through the system.

# **Blended Working Application Solution**

The new Blended Working Application Solution was deployed in Fingal in November 2022. It was originally commissioned by South Dublin County Council and developed in partnership with Storm Technology. The solution was made available at nominal rates to all other Local Authorities through the Build-To-Share Framework. Fingal purchased and deployed the Blended Working Application Solution through this scheme. The application and its technical environment were fully deployed and tested within 2 weeks from November 5th. It was subsequently opened to all eligible staff for submission and approval/rejection of blended working applications, for a period of 3 weeks from 28th Nov to 16th Dec. The solution incorporates a automated workflow from fullv creation. recommendation and approval/rejection of applications and includes blended working notification and sign-off to all parties to the application.


# **Transition from CRM 2011 to Dynamics 365**

Following an in-depth Discovery Phase and Requirements Gathering Phase, the move from CRM 2011 to Dynamics 365 has now progressed to the Implementation Phase. The implementation of Dynamics 365 solution will provide for the migration of all service Departments from existing CRM 2011 to Dynamics 365. The system will be aligned to the current national service catalogue and will focus on the delivery of a standardised process framework across all FCC services. The project's implementation phase is expected to be complete by the beginning of Q2 2023.

# **Communications**

# Website

The Council's website, fingal.ie, saw an eight per cent increase in the number of visitors during 2022 with 1,327,373 logging on to the site and generating 3,559,922 page views which was a four per cent increase on the previous year. The amount of time spent on the site rose by 28 per cent to two minutes and four seconds. After the home page, the five most popular pages on the website in 2022 were Planning Applications, Choice Based Letting, Contact Us, Jobs and Find a Book.



#### Social Media

The Council's five corporate social media channels all saw their number of followers increase during 2022 with the You Tube recording the highest percentage increase as the number of subscribers rose by 39 per cent to 881. Facebook saw an increase of 4,723 followers to 29,542 while Instagram recorded a 23 per cent increase to 6,055. LinkedIn now has 6,500 followers after recording a 30 per cent increase in 2022. The end of the restrictions associated with the COVID-19 pandemic has seen social media figures for reach and impressions, which had spiked in 2020 and 2021, move back to levels last seen in 2019. The Council's Twitter account recorded 6.1 million impressions in 2022, which is down on the 11.6m and 11.1m recorded in 2020 and 2021 respectively, but slightly more than the 5.8m in 2019.

# **Podcast**

To date the Communications Unit have produced 21 episodes of the Inside Fingal podcast which gives listeners an insight into the work being done by the Council. The podcast recorded a total audience of 10,362 to the end of 2022. The first episode is still the most listened to programme followed by episode eight which was on the Fingal Development Plan and episode 10 which was about the various Greenway projects being undertaken by the Council.

# Media

The Communications Unit dealt with 28 media queries during December. Most queries related to Dublin Airport and the attack by dogs on the goats on Howth Head. Fourteen press releases were issued during December. These included an appeal for Fingal properties to house Ukrainian people, the launch of the Vacant Homes Strategy and the 2022 Gender Pay Gap Report.

# Video



The Communications Unit produced eight videos during December to bring the total produced for our You Tube channel in 2022 to 133. December's videos included the Mayor's Christmas Message and the Chief Executive's New Year's Message as well as videos on the Vacant Homes Strategy, Sailing Into Wellness and Balbriggan Men's Shed. # **Local Government Education Programme**

As part of the Department of Housing, Local Government and Heritage's campaign to increase the participation of women and people of diversity in Local Government, Fingal County Council has developed a Local Government Education Programme which is currently being rolled out in four modules every Tuesday evening in January. The programme, which is being delivered as a one-hour webinar featuring a presentation followed by questions and answers, commenced last Tuesday, January 10, with An Introduction to Irish Politics from Professor Gary Murphy of Dublin City University. The other modules are:

- January 17 The Importance of Inclusion in Local Government
- January 24 The Council
- January 31 Finding Your Political Home

There are 195 people registered for the programme which breaks down as 84% female and 16% male with 27% of participants coming from a diverse background.

# TRADFEST EVENTS AND LAUNCH




Tradfest events are due to take place across Fingal from 26-30th January.

# FINGAL FOOD STRATEGY

The EETCD Department is currently developing a Fingal Food Strategy, the aim of which is to support the food industry by building a Food & Drink Tourism Strategy aligned to the broader Fingal Tourism Strategy currently in development, including: the ongoing 'Dublin's Coast & Fields' development, implementation and promotion; creating & maintaining world class, sustainable, saleable food & drink experiences; and continued investment in food and drink festivals and events.

# NEWBRIDGE HOUSE AND ARDGILLAN CASTLE ROOF PROJECTS



The roof works at Ardgillan Castle are progressing well and on schedule. Following site mobilisation and the erection of hoarding and information signs before Christmas, the roof project at Newbridge House will begin in early January with the erection of scaffolding.

# **CATERING SERVICES**



Following the creation of a Dynamic Purchasing System for catering Services in Fingal, mini competitions were issued before Christmas in respect of the Coachhouse Café, Newbridge, Ardgillan Castle and the Seamus Ennis Centre.

The closing dates for all competitions are in early January following which evaluation of the tender responses will take place.

# THE CASINO MODEL RAILWAY MUSEUM — CHILDREN'S INTERPRETATIVE CENTRE



Fingal County Council have partnered with Irish Rail in the development of an exciting new project which will see the current educational room revamped into a children's interpretative centre within the Casino Model Railway Museum.

The concept proposed is a life-sized scaled representation of a train carriage, incorporating digital screens, integrated lighting and interactive touch points, creating an immersive experience across three themes:

- 1) Working on the railway
- 2) Staying safe on the railway
- 3) Environment & Biodiversity on the railway

The project is expected to commence on site in early February, with an expected completion date in Easter, when it will be officially launched to the public.

# OLD HOWTH COURTHOUSE AND TOURIST OFFICE



A variety of upgraded works have now been implemented at the old Howth Courthouse and tourist office to enhance security measures and the health and safety of staff and our citizens using this facility.

Works include the installation of CCTV cameras, a panic alarm, keypad access controls and a reconfiguration of the reception desk in the tourist office.

# LIBRARIES

'UNITED': Ukrainian Photographic Exhibition at Swords Library.

'UNITED', a collaborative photographic exhibition between Irish and Ukrainian photographers is currently on display at Swords Library. The exhibition consists of powerful images of the war in Ukraine as well as poignant portraits of displaced Ukrainian families living and settling in Ireland. The purpose of the exhibition is to highlight the war in Ukraine and to encourage Irish families to host displaced Ukrainian families in their homes.

UCCI is a volunteer led group providing help and support to people who have come to Ireland having fled the war in Ukraine. Blanchardstown Library provides members of UCCI with a meeting space and on Saturday 17th December, group members Olena Khaletska and Michael Baskin organised a special Christmas event for parents and children from Ukraine. There was lots of entertainment for children and parents alike, but the highlight of the day was a visit from Saint Nicholas, looking resplendent in blue! # Spring 2023 Programme of Events at Fingal Libraries

Fingal Libraries Spring 2023 programme features a wide range of talks and workshops, designed to reflect national and library led initiatives around themes such as culture, creativity, heritage, entrepreneurship and science. The programme will be reflective of the diverse and specific needs of our citizenry across Fingal.

This year's programme will include a financial wellness talk with "The Money Mentor" author and TV presenter Santis O'Garro, an interactive 4-week programme of talks to inspire our citizens to kick start a more sustainable lifestyle funded by Europe Direct, internet safety talks for children, teens and parents and a special One Dublin One Book 2023 event with RTÉ's Sinead Crowley, Andrew Hughes (One Dublin One Book author) and author Nicola Cassidy. There will be a full programme of Healthy Ireland at your Library events to inspire and motivate people to lead a healthier 2023, plus a range of family sensory friendly events.

The Spring programme also includes a series of Fingal Maker Space workshops which will facilitate STEAM learning in an informal setting for school students, and an array of events to encourage older people to meet and interact with others at their local library.

Fingal Libraries and Creative Ireland will collaborate on several new programmes in the earlier part of the year. "Viewpoints" a touring art exhibition on loan from The Glucksman Gallery will tour around each library from January to June with a full programme of creative workshops, culminating on the 10th of June at Cruinnú na nÓg. As part of the celebrations for St Brigid's Day 2023 there will be two special events to acknowledge the creativity and talent of Fingal women both past and present: four local entrepreneurs will discuss their lives and careers with pupils from a local secondary school, and a historical talk about Irish feminist Frances Power-Cobbe. The Fingal World Book Tour 2023 curated by children's author and illustrator Alan Nolan will be a fun and interactive schools and libraries programme allowing children to meet and engage with Irish authors in the lead up to World Book Ireland Day in early March: we hope to make this into an annual event for the children of Fingal.

# **ECONOMIC DEVELOPMENT**

### FINGAL SKILLS STRATEGY



Planning continues for a Student Skills Expo in 2023 with consultants engaged to assist with event planning. Three focus group sessions have been held with teachers from schools in Dublin 15, Swords, Balbriggan and Malahide/Portmarnock areas and education providers to gather their input into the plans for the Expo. Topics covered include dates, venue, content and best practice.

The Council has engaged with Balbriggan Chamber and local businesses to provide mentoring assistance to secondary schools in Balbriggan. Mentoring training has been provided to more than 16 no. mentors through the Trinity Access Programme.

Fingal County Council has been successful in an application for Interreg Funding as a partner in the SKYLA Project "Smart Specialisation Skills Ecosystems for the Twin Transition". The project will have a term of 4 years and will focus on enhancing the role of VET in smart specialisation sectors. Projects partners include Italy, Poland, Sweden, Lithuania, Bulgaria, Greece and Belgium. The project will be co-ordinated by the Fingal Skills Strategy Team.

### URBACT PLAYFUL TOWNS











Let's Play Rush held its final event of 2022 and of the URBACT NPTI Transfer Network on the 11th December in Kenure Park in conjunction with the local Scouts. Citizens participated in a boules competition and a very successful sock-snowball fight involving all ages. There was a penalty shootout, festive singing and buskers along with unstructured play activities provided from the Let's Play Rush playbags.



# OUTDOOR RECREATIONAL INFRASTRUCTURE SCHEME (ORIS)



The Department of Rural & Community Development under the Outdoor Recreational Infrastructure Scheme (ORIS) is providing funding of  $\in 23,400$  for the development of the Castleknock Historical Walking Trail. ORIS is also providing funding of  $\in 28,800$  for enhancements to the Balbriggan Historical Walking Trail. Consultation on both projects has commenced with local groups.

Turner & Townsend and Langan Engineers have been appointed to carry out a Feasibility Study for a tidal swimming pool/sea-swimming platform in Balbriggan with ORIS funding support of  $\in$ 50,000. An initial focus group consultation and a wider stakeholder engagement session have been completed to gather input from key stakeholders on the proposals.

# SUSTAINABLE FINGAL



The Council continues to work with SEAI Energy Academy to encourage businesses to apply for the Support Scheme for Energy Audits (SSEA) to access a €2,000 voucher towards the cost of a high-quality energy audit to help reduce energy bills. # **DUBLIN BELFAST ECONOMIC CORRIDOR**



Fingal County Council has been awarded €150,000 by the Department of Housing, Local Government & Heritage under the Shared Island Local Authority Development Funding Scheme for a Feasibility Study for the development of regional innovation/enterprise hubs along the Dublin Belfast Economic Corridor. The Council is leading on the project with the support of the eight local authorities and two universities of the DBEC partnership and is preparing the brief to engage consultants to carry out the feasibility study.

# OUR BALBRIGGAN 2019 – 2025 REJUVENATION PLAN – A SOCIO-ECONOMIC STRATEGY



The Our Balbriggan Programme Office continues to support the Leadership Group and its five pillars, who meet regularly, to progress work across a range of economic and social measures including: Growing the Local Economy, Public Realm & Infrastructure, Education, Skills & Employment, Community Integration, Health & Well Being and Community Safety.

The Education, Skills & Employment Pillar will coordinate its third edition of the Our Balbriggan Loves Learning Festival in March 2023. The festival, now in its third year, celebrates life-long learning opportunities, led by the Dublin and Dún Laoghaire Education & Training Board (DDLETB) it involves local schools, and a broad range of local, regional and national agencies.





The Quay Street & Environs scheme is in final detailed design phase with works anticipated to commence in late 2023/2024 and be completed on a phased based in 2025. 2 - 4 Dublin Street transformation as a centre of creativity, innovation & technology is in the final stages of preparing planning pack for Q1 2023.





In advance of the full transformation of the Harbour (former O'Sheas Night Club) the site has been levelled out to create a 'meanwhile space'. Steel Corten planters with timber framed seating, bins and bike racks have been installed. A temporary tarmac finish completes this newly defined safe allowing a free flow of pedestrians and cyclists. A package of minor work improvements on the harbour including seating, lighting, storage and additional harbour amenities will commence Q.1 2023.

# **Reclaiming the Arts 2022**





A series of launches and cultural happenings took place between the 15th – 17th December. The events are а culmination of early-stage commitments in the Local Economy Pillar & URBACT IPLACE EU project and a prelude to the launch of a Creative Arts Strategy in 2023 developing Balbriggan's value proposition as a premier destination for the Arts. The "Reclaiming the Arts 2022" events showcased the talented artists, creativity and culture in Balbriggan and saw the launch of 'Dear Balbriggan' by local artist Matthew Kelly at the Our Balbriggan Hub. All events were well attended and received great support.

# Time4EU

As part of the EU initiative Time4EU, colleagues from 7 other European large towns took part in a two-day visit to Balbriggan, the aim of the project is to combat social exclusion and integrating diverse profiles of young people, each participating city represents a theme, with Balbriggan's theme -"Balbriggan is our home" encouraging youth engagement through storytelling and placemaking. Delegates were hosted in the Irish Institute of Music and Song on Day 1 and Foroige, Flemington Community Centre on Day 2. The itinerary included interactive workshops with young people in Castlemill & Flemington.

# Local & Rural Development



The Fingal LCDC continues to oversee and administer the key areas of LEADER and SICAP and the various Local Development and Community Development funding programmes under its remit. The LCDC also manages the Healthy Ireland Initiative and the Social Enterprise Grants Scheme. The last Meeting of the Fingal LCDC was held in December.



# FINGAL LOCAL ECONOMIC COMMUNITY PLAN 2022-27

The Guidelines for preparing new LECPs have been published by the Department of Rural and Community Development. The new Fingal LECP will be a 'Whole-of-Council Plan' and will involve extensive consultation and engagement with internal and external stakeholders. Introductory seminars on the statutory role, consultation process and suggested thematic areas to be addressed in the new LECP have been held online and recordings of these can be viewed on the Department of Rural & Community Development's website. A presentation on the guidelines with detailed discussion on next steps was held at the December meeting of the Economic and Enterprise Development Strategic Policv Committee, following a similar presentation to the LCDC in October.

# SICAP



The resources and staff of the Fingal SICAP Programme continue to be leveraged to assist with the Ukrainian Refugee Crisis response. The SICAP Programme continues to help in the response to this crisis and is a central resource to the work of the Ukrainian Refugee Community Response Forum. Additional funding has been received from the DRCD to help with the delivery of services to Ukrainian Refugees in Fingal and additional staffing resources from the Ukrainian community have been employed on the ground to assist with this. Confirmation was received during December that the Fingal SICAP Programme has been allocated  $\in$ 304,369 in 2023 specifically for Fingal's Ukrainian Refugee Response. The KPIs and Annual Plan for the 2023 SICAP Programme were agreed in principle by the SICAP Oversight Committee in November and were fully approved by the Fingal LCDC at its meeting in December.

# LEADER PROGRAMME





In December, the Dublin Rural LEADER Local Action Group (LAG) approved in full the allocated LEADER 2021-22 Transition Programme for eligible projects in the administrative areas of Fingal, Dun Laoghaire Rathdown and South Dublin.

The Dublin Rural LEADER LAG also submitted its Expression of Interest to manage the new LEADER Programme 2023-27 for Rural Dublin. This Expression of Interest has the support of Fingal County Council, South Dublin County Council, Dun Laoghaire Rathdown County Council and Fingal LEADER Partnership, the LAG's Implementing Partner.

# **Enterprise Centres**

Fingal's Enterprise Centres continue to participate in ConnectedHubs.ie .

ConnectedHubs.ie is a one-stop-shop for remote working hubs throughout Ireland.



All three Enterprise Centres currently have space available to start-up businesses and businesses/ individuals who wish to avail of remote working options and facilities. Bespoke options or generic office fitouts can be considered.

Occupancy rates at the Council's three enterprise centres at the end of December were all over 90%.

The three Enterprise Centres currently support 65 businesses and over 320 direct jobs.



Demand for the new Remote Working Hubs in BASE and Beat remain strong particularly after the Connected Free Voucher Scheme during August. A second Connected Hubs Free Voucher Scheme has now also been launched generating further interest which will run until Christmas.

Fingal County Council was approved for €50,000 in new funding to promote Remote Working Hubs in the County under the Town and Village Renewal Scheme Marketing Measure. A cross-departmental team within the Council will be implementing numerous initiatives over the next 12 months to promote Fingal as a Remote Working Hub base for remote workers.

# Town and Village Renewal Scheme 2022

Confirmation was received from the Department of Rural and Community Development that Fingal has been approved for €100,000 for the Rush Streetscape Scheme and €36,000 for a new Donabate Streetscape Scheme.



LEO Fingal provides a broad suite of support services to stimulate enterprise and enable small businesses to succeed. Some of the LEO highlights for December 2022 are as follows:

# Local Enterprise Week 2023



Plans are underway for Local Enterprise Week 2023 which will run from 6th – 10th March 2023. The week will include daily events both in person and online where small business owners can learn new skills or partake in networking and other events. A full schedule of events in Local Enterprise Week will be published on our website and publicised to all small business owners in the Fingal area.

# Look for Local Shop Fingal Campaign



The Look for Local, Shop Fingal campaign was a great success this year with 12 hampers being won by members of the public who engaged with LEO Fingal Social Media platforms as part of the campaign. The hampers contained a selection of goods from LEO Fingal supported businesses.

# FINGAL ENTERPRISE AWARDS 2023



Applications are currently being accepted for the Fingal Enterprise Awards 2023. The Fingal Enterprise Awards competition is organised annually by the Local Enterprise Office to acknowledge the achievements of small businesses. This is part of a national competition in which one overall winner from each of the 31 Local Enterprise Office areas will compete for the National awards. The deadline for applications in the Fingal competition is 5pm on Friday the 13th of January 2023. Following an assessment of eligible applications, a shortlist of Fingal applicants will emerge to the judging phase. Each of the finalists

who complete the full judging process will be eligible to share in the overall prize fund of approximately €10,000 to be invested in their business. The Fingal winner will be announced and presented at an event to be held during Local Enterprise Week 2023.

# START YOUR OWN BUSINESS COURSE - UKRAINE



The Start your own Business course for Ukrainian Refugees will take place in the Riasc Centre, Kinsealy on Thursday January 19th. This initiative is being run at the request of the Irish Red Cross and will be open to all Ukrainian refugees within the Dublin area.

#### FINGAL BUSINESS BRIEFING



The Fingal Business Briefing has proven to be a popular way to interact with Small Business owners and will continue to be held in 2023. The first Briefing event of 2023 will be on Friday January 27th in the Riasc centre in Kinsealy. We plan to do a hybrid of online and in person Briefing sessions throughout 2023. At the Briefing events, information is shared about supports available to small business owners and Q&A plus 1-1 follow ups are also available on the day.

### FINGAL BUSINESS NETWORK



The next meeting of the Fingal Business Network will be held on Friday January 20th in the Riasc Centre in Kinsealy. The theme of the meeting will be "Meet the Board you can't afford" and will give the attendees a chance to pitch their business to a group of like-minded small business owners, receive feedback and hone their sales pitch. The Fingal Business Network encourages information sharing, discussion, peer to peer learning and facilitated networking among local businesses.

LEO Fingal has launched a new schedule of courses for 2023 which includes our flagship Start your own Business course and Digital Marketing & Social Media training. The training programme is one of the key services provided by LEO Fingal and consistently receives positive feedback from attendees. In 2023, we will launch a new Leadership Development programme aimed at owner managers to increase their skill levels in Leadership, Sales and other business disciplines.

# **TRADING ONLINE VOUCHER SCHEME**



An initiative under the Government's National Digital Strategy, the TOV (Trading Online Voucher) scheme continues to support small businesses by allowing them to enhance their online offering by providing a grant of up to €2,500 for ecommerce and digital marketing activities. 111 applications were approved in 2022, in the amount of €237,079. There is still strong interest in E-trading with applications and approvals running at nearly double pre-covid years.

# FINGAL ENTERPRISING WOMEN NETWORK

LEO Fingal hosted the fourth in-person Fingal Enterprising Women's networking event of 2022 "Circle of Friendship" on Thursday the 8th of December with Guest Speakers Helen Creegan Walsh and John Murray. This opportunity for Fingal Female entrepreneurs to connect with like-minded businesswomen in a warm and welcoming environment was attended by over 100 guests. Over 660 female entrepreneurs have attended FEWN Networking events in 2022.

# EVALUATION AND APPROVALS COMMITTEE

The December Evaluation and Approvals Committee (EVAC) meeting was held on Wednesday 14th December and was the final meeting of 2022. In 2022, 47 applications were approved for a total of  $\in$ 1,045,384 being the highest grant approval amount for Fingal LEO in a single year.

# **BUSINESS ADVICE CLINICS AND MENTORING**

Business Advice Clinics and mentoring services continue to be offered online and now have an option for clients to meet in person in the Business Advice Clinic based in County Hall, Swords. In addition, clients are continuing to receive one to one business mentoring with our panel of mentors. In December 2022 5 Business Advice Clinic days were held, offering advice and support to 41 clients in Fingal and in 2022 a total of 894 clients attended the Business Advice Clinic. The Mentoring Programme continues in 2022 a total of 444 clients have received One to One Mentoring.

# **MICROFINANCE IRELAND LOANS**

LEO Fingal provides a loan scheme through its partnership with Microfinance Ireland, with "soft" loans of up to €25,000. LEO Fingal is actively promoting the availability of loans from businesses that have difficulty raising finance from their bank. 14 applications have been processed, assessed and submitted to MFI (Microfinance Ireland) in 2022.

#### SHOWCASE IRELAND



Local Enterprise Office Fingal is continuing our support and commitment of the Home & Gift, Fashion and Jewellery sectors by offering a limited number of exhibition spaces to clients at Showcase 2023. Following a selection process, 11 LEO Fingal craft/design businesses have been offered a stand at Showcase 2023. Showcase Ireland 2023 will take place from 22nd – 24th January 2023 at the RDS, Dublin. Showcase is presented by Design & Crafts Council Ireland, Enterprise Ireland and Local Enterprise Offices and supported by the Department of Enterprise, Trade and Employment. This four-day trade show is recognised as one Ireland's largest international trade shows and offers manufacturers, designers and craft makers the opportunity to exhibit their new collections.

### STUDENT ENTERPRISE PROGRAMME



The 2022/23 Fingal Student Enterprise Programme is well underway with 26 Second level schools across Fingal participating in this year's programme. The savvy students will develop their own actual businesses, researching, resourcing, trading services and products, with the guidance of business mentors. Fingal LEO boasts the largest enterprise programme prize fund for second level students in the country with prizes including an international educational trip to a European City for the senior category winning student and teachers. The Fingal County Final will take on Wednesday 15th March 2023 in the Crowne Plaza Blanchardstown.

### **UKRAINE ENTERPRISE CRISIS SCHEME**



Assistance for business energy costs is being awarded to qualifying businesses affected by the increase in input costs or supply chain issues in relation to the Ukraine war. Clients are being advised to speak to the Local Enterprise Office to assess eligibility and to apply.

# Malahide Castle Demesne Works

Forestry planting of 1200 new whips has been undertaken in the grounds of Malahide Demesne. Whips are slender unbranched single young tree seedlings that are up to approximately 0.5-1.0 m tall. They are usually planted a distance of 1.5 times the maximum height that the tree will grow. This can vary depending on the tree species. The young tree seedlings have been grown in a nursery and are usually between 2-3 years old when planted out.






# **Road Opening Licences**


The new efficiency functionality with respect to automated granting of T3 licences is operating well. Since 1st June 2022, the majority of T3 ROL applications have been granted by way of automation and 3 Clerk of Works has been appointed to Swords/Balbriggan, Castleknock/Mulhuddart and Howth/Malahide areas to carryout improved post inspection of all road openings by utilities.

The Licensing unit continues to process and manage the licensing system for the County, applications are allocated by area for examination and conditioning which includes reviews of the existing carriageway, footpaths, cycleways, and grass verges. Applicants submit temporary traffic management plans for review to ensure all works are carried out safely within the public domain. Road Opening Licences are a cross functional process for the department and are essential for the asset management of Fingal County Council Road network.



# Framework for future of Water Services

A new framework for the future of water services developed through an engagement process facilitated by the Workplace Relations Commission was announced by the Minister on 24th June 2022.

The Framework will help to ensure a stable operational environment is maintained as the water sector completes the transition to a national water services authority, based on the full integration of public water services within Irish Water.

To facilitate the transition to a national water services authority, the Framework provides for:

1. Irish Water to assume responsibility for the management and direction of water services operation and activities

- 2. The voluntary transfer, of existing local authority water services staff to Irish Water as permanent employees between now and 2026.
- The identification of opportunities for water services staff not transferring to Irish Water to avail of opportunities to redeploy to other areas within Local Authorities.
- 4. The commencement of water services staff recruitment directly by Irish Water to fill vacancies arising in Water Services.
- 5. A voluntary redundancy scheme for local authority water service staff; and

A new Irish Water-Local Authority agreement, replacing the existing Service Level Agreement arrangements, to ensure that Irish Water has full accountability for the for the delivery of water services and direct management of the water services staff who choose to remain employed by their local authority under contract to Irish Water for the transitional period to the end of 2026.



#### **Planning Applications**

There have been 1300 planning applications received to the end of November 2022. 108 of these applications were invalid leaving a total of 1192 valid applications. The volume of applications received by Local Electoral Area (LEA) is detailed in the table below.

Between January and end November 2022, 20 Strategic Housing Development (SHD) applications were made to An Bord Pleanála totalling 10,776 units. 3 decisions were made by the board up to end of November 2022. Of these, 1 application was Granted in May (172 units), 1 application was granted in November (1,323 units). One application was Refused in March. There is a total of 20 SHD applications (13,038 units) currently in the formal application process.

Between January and end November 2022, 5 Large-scale Residential Development (LRD) applications were made to FCC totalling 1,689 units. 2 decisions were made up to the end of November, of these both applications were granted: 1 Change of Use to permitted SHD and 1 granted in Nov (432 units).



#### **Planning Decisions**

A total of 1101 planning decisions have been made to the end of November 2022. There have been 912 decisions to grant permission (83%) and 189 refusals of permission (17%). There have been 77 grants of permissions in respect of single house construction, 535 grants of permission for domestic extensions, 252 commercial/retail grants of permission and 22 grants of permission in respect of housing developments of which 12 relate to development of 2 - 20, 4 relates to 20 – 50 and 2 relate to 50 -100 and 4 which relates to 100+.

#### **Building Control Admin**


There were 113 Building Control submissions received in November 2022.

This was made up of 35 Commencement Notices, 53 Compliance of Completion Certificates, 18 Fire Safety related Certificates and 7 Disability Access related Certificates.

Commencement Notices and Compliance on Completion Certificates are submitted through the Projects module on BCMS.

Fire Safety, Disability Access, Regularisation and Dispensation/Relaxation Certificate applications can be submitted online via the Applications module on BCMS and can also be submitted by hard copy directly into the office. The BCMS system is the preferred option.

The Building Control Admin team processed 152 building control decisions in November 2022, relating to Fire Safety and Disability Access Certificates. This was made up of 50 decisions to grant and 102 extensions of time.



#### Enforcement

203 Warning Letters and 23 Enforcement Notices issued to the end of November in 2022. 3 new cases were referred to the Law Department during 2022 to initiate legal action bringing to 15 the number of enforcement cases currently with the Law Department or at varying stages in the court system.

The Derelict Sites Section issued correspondence to site owners/occupiers of 2 sites with on-going engagement arising from this. Statutory Notices issued under the Derelict Site Act with respect to 2 sites during 2022 with both sites placed on the Derelict Sites register.

#### **Strategic Policy Unit**

#### Draft Fingal Development Plan 2023 - 2029

The Draft Fingal Development Plan is now at Stage 3 of the plan-making process. This stage relates to the proposed Material Alterations to the Draft Plan. The proposed Material Alterations (Amendments) originated from the consideration of the submissions received between February and May 2022 on the Draft Development Plan 2023 -2029. The Chief Executive prepared a report on these submissions and the Elected Members considered the report at Special Council Meetings held in September and October 2022, where the members resolved to amend the Draft Plan.

The public consultation on the proposed Material Alterations to the Draft Fingal Development Plan ran until 22<sup>nd</sup> December 2022. 197 submissions

have been received. The Chief Executive's Report on submissions received is currently being prepared and will issue to the members by 15<sup>th</sup> January 2023. Meetings to discuss the submissions will take place in February 2023.

The Planning Authority envisages that the final Plan will be adopted in early 2023.

#### Lissenhall East Local Area Plan

The Lissenhall East LAP was formally adopted by Members at the December meeting. This Local Area Plan comes into effect on 23<sup>rd</sup> January 2023.

#### **Residential Zoned Land Tax**

The Government's 'Housing For All – A New Housing Plan for Ireland - proposed a new tax to activate vacant land for residential purposes as a part of the Pathway to Increasing New Housing Supply.

The Residential Zoned Land Tax was introduced in the Finance Act 2021. The process to identify land to which the tax applies is now underway and the tax will be payable from 2024.

The objective of the tax is to activate land that is serviced and zoned for residential use or mixed use, including residential use, in order to increase housing supply and to ensure regeneration of vacant and idle lands in urban locations. These locations have been identified within statutory land use plans as being appropriate locations for housing and they have benefitted from investment in the key services to support the delivery of housing.

Fingal County Council has prepared a draft map of the land considered to be in scope for the RZLT as of October 1, 2022.

A supplemental map will be published on 1 May 2023 identifying additional land considered to be in scope as a result of a change of zoning, servicing or where the local authority becomes aware of the fact that land, which didn't appear on the draft map, may meet the criteria for being in scope, such as where this has been identified during submissions. The supplemental map will also be on public display and open to submissions which may challenge the inclusion of additional land on the map.

#### **Parks and Green Infrastructure Division**

#### **Porterstown Park Recreational Hub**



Works on the All-Weather Pitch & Running Track which began in April 2022 are well advanced. Recent milestones achieved include the laying of the 3G pitch carpet to approved FIFA standards together with the completion of the shockpad layer of the 400metre running track and the installation of the LED public & sports lighting infrastructure. Works over the coming weeks include completion of the complementary path network, blue badge & bicycle parking provision.

One of the main outstanding project deliverables is the surfacing and lining of the running track. This specialist work is highly weather/temperature dependent, and it is anticipated that it may be March or April of this year when suitable conditions prevail to complete this works item. Following testing & certification it is planned to open the facility for public use shortly thereafter.

#### **Recreational Hub at Ward River Regional Park**



The construction of the all-weather 3G pitch and ancillary car & bicycle parking at the Ward River Recreational Hub are nearing the final phase of construction. The 3G carpet system is fully installed and has passed the relevant testing to confirm compliance with approved quality standards. The commissioning of the LED floodlighting system is anticipated to take place in January following the installation of meters by the ESB.

Other project milestones recently achieved include the landscaping to the perimeter of the all-weather pitch and car park and the resurfacing of the existing path leading to the cycle parking and the main entrance to the pitch. The installation of an automated gate system at the entrance to the car park is programmed to take place before the end of January.

Outstanding works, which are weather dependent, include the completion of a Go Games/training pitch facility at the north of the carpark and the completion of the surfacing of the shared route to the cycle parking. Notwithstanding these weather dependent works, it is planned to make the 3G pitch and car park available for use by the public in the coming weeks following certification of the facilities.

Play Projects at Lanesborough Park, Howth Harbour, Garristown Library and Bremore Regional Park



Four competent & experienced specialist firms have been shortlisted on conclusion of the first phase of a restricted tender process, to deliver quality play spaces at Lanesborough, Howth, Garristown and Bremore. The firms have since been invited to participate in the second and final phase of the tender, where they have been asked to submit four exemplary proposals for evaluation, a preferred tenderer will be chosen on foot of this. It is planned to complete the procurement phase of the project in the first quarter of the year with works to commence by the second quarter of this year.

This mapping & report will be updated over the coming months subject to new information (Tolka flood study) & submissions received from councillors/public.



# Multi-Party Framework Agreement for the preparation of Surface Water Management Plans (SWMP)

The procurement process has begun for the new Multi-Party Framework Agreement for the preparation of Surface Water Management Plans (SWMP) for the new County Development Plan. The SAQ for the above framework was posted on eTenders with a closing date for tender submissions set for 30/09/2022.

The tenders were assessed in November and a recommendation for progression to the next phase will take place in December.

#### **Housing Supply**

#### **Church Fields, Dublin 15**

The contractor is currently on site constructing the Church Fields Link Road and Cycle Network which will facilitate the development of the entire Church Fields landbank with the potential to deliver 1,000 mixed tenure homes. This project is expected to be completed in 2023.



The Stage 1 (Expressions of Interest/ Prequalification) of a two-stage procurement process for the appointment of a contractor to construct the 300 units has concluded. The Stage 1 submissions are currently being evaluated to decide which firms proceed to the second stage of the procurement process.

#### **St Ita's Portrane**

#### **Housing Loans Update**

The Local Authority Home Loan continues to attract a high level of queries and applications from members of the public seeking to secure a mortgage with the Local Authority. There have been 254 applications to date.

Also, to date,  $\in$ 16.9 million of lending has been approved, with applicants having gone sale agreed with  $\in$ 4.2 million of this approval in principle. The scheme remains popular.

#### **Housing Asset Management**

#### **Energy Efficiency/Retrofitting Programme**

Ninety-two properties were retrofitted under the highly successful 2022 programme, exceeding the DHLGH-set target of 81 for 2022 and which followed a pilot energy retrofit programme in 2021. Starting off in Jugback Estate, Swords, the project then moved to St. Paul's Balbriggan, Lissenhall in Swords and Whitechapel Clonsilla, where extensive works were carried out including electrical upgrades, attic insulation, installation of triple glazed windows and doors along with PV panels where required to reach a B2/Cost optimal standard. The 2023 programme will see further growth and expansion of this project throughout the Fingal region.

#### Planned Maintenance Programmes

#### **Cyclical Maintenance - Scheme Painting**

The Scheme Painting Programme provides for external painting and joinery repairs to Council housing stock and currently operates on a 6/7 year cycle. Works were completed recently in Moyclare and School Lane, Baldoyle along with one off properties in this area. Works are currently ongoing in Dromheath Avenue, Cruise Park and St. Brigid's Court/Park in Dublin 15.

#### Housing Assistance Payments (HAP)

In 2022, 382 HAP tenancies have been set up for Fingal housing applicants. The HAP team are on hand to deal with any queries from applicants and landlords in person at the Housing Department in the Fingal County Council Blanchardstown Office, by phone on 01 8905000 via the CCU or through email <u>hap@fingal.ie</u>

#### Rents

The new rent review process has commenced and batches of tenants will be receiving their Rent Assessment Form (RAF) over the coming months/year. Tenants are required to complete this form and return it to the Rents Section with relevant documents to ensure they are charged the correct rent. The rent will then be reviewed on a two-year cycle basis.

The Rent Arrears team are working methodically through accounts in substantial arrears to encourage tenants to engage with the Council in reducing their arrears. In cases where there is no engagement, despite repeated efforts, proceedings have issued through the legal arena and to date the Rents Section has secured one Possession Order with 4 others currently before the courts.

The Rents team encourage any tenant who is experiencing difficulty paying their rent to engage with the Council to examine possible solutions. However, there are instances where tenants do not engage or make alternative payment arrangements and, in those situations, the Council needs to take further action.

#### **Housing Adaptation Grants**

492 Grant Applications were received in 2022 with the full allocation of €3.4M approved.

#### **Housing List Position**

In accordance with Circular 32/2022 as released 11<sup>th</sup> August 2022, the Summary of Social Housing Assessment (SSHA) was returned to the Department of Housing Local Government and Heritage on Tuesday 29<sup>th</sup> November 2022. The online portal for the completion of this assessment proved popular.

The current list position is in preparation for all applicants.

This will be available through the CBL portal on fingal.ie in the new year. Applicants who do not have access to this portal should contact Choicebasedlettings@fingal.ie to request their unique username and password. The most recent list position issued on 1<sup>st</sup> April 2022 is available in the portal currently.

#### **Social Housing Application Form**

The new social housing application form is in use since 14<sup>th</sup> March 2022. Hard copies are available through the CCU. Amendments to the form – Part 8 of the housing application, identifying as an Irish Traveller is now being recorded on the Housing system, in accordance with Government policy.

In line with the Social Housing Assessment Regulations, the Housing Authority is required to assess a fully complete application within a period of 12 weeks of receipt.

#### **Changes to Income Eligibility Thresholds**

In accordance with Circular 48/2022 and changes being implemented via the Social Housing Assessment (Amendment)(No. 3) Regulations 2022, the Social Housing Eligibility Bands will increase with effect from 1<sup>st</sup> January 2023.

To access their unique username and password applicants must contact choicebasedlettings@fingal.ie with their housing reference number and phone number. The housing team continue to issue passwords and usernames. Applicants are actively encouraged to obtain their passwords and usernames to express interest in any properties advertised.

Approved Social Housing applicants log in each week to check the dwellings that are available using their username and password.


To date 2,569 passwords have been issued to applicants since the CBL portal opened (08/12/2021) of which 71 were issued in December, 2022. All new approved Housing Support Applications will receive their password and username upon approval. Housing Lettings will continue to encourage applicants to request usernames and passwords.

Since the portal opened, there has been over 10,000 expressions of interest in the various properties advertised. During the month of December there was 13 properties advertised on the portal. The schemes in Beresford, Donabate, Blackwood Square, Ravensmill and Hansfield advertised during November 2022 are currently being processed.

During 2022, a total of 219 properties were advertised through the CBL portal.

#### Allocations of Housing with FCC and Approved Housing Bodies

There were 717 allocations of social housing provided by Fingal County Council or Approved Housing Bodies in 2022, and this compares to 660 allocations in 2021.



#### **Homeless Services**

The Council's Homeless Team continue to engage with those experiencing homelessness to offer advice and support. Homeless Assessments continued to be carried out.

In December 2022 there were a total of 44 full **homeless assessments completed** - comprising **21** families and **23** singles/couples. There are a further **30 pending which** will be assessed by the Homeless team.

#### **Homeless Presentations**

From January 1<sup>st</sup> to 31<sup>st</sup> December 2022, the Homeless Officers have carried out **748** Homeless Assessments (380 families and 368 singles) – see Table below for breakdown by month.

Approximately 35% of these cases are because of a **notice to quit** having been served. Many of these notices to quit are served on families who have been renting the same property for an extended period (over 5 years). The main reasons given for issuing the notice are the landlord intends to sell the property (25%) or that a family member will move (5%) into the property.

There are also a considerable number of people making contact stating that they are Homeless due to **family breakdown** (18%). Anecdotally, these presentations are aged in their 20's/30's and have fallen out with family or state that they are living in

**overcrowded conditions** (11%) and state that they cannot/will not return to the property.

#### **Homeless Exits**

Homeless exits for the year are being collated and reviewed and will be advised on next month's Report.

#### **Emergency Accommodation (including Fingal County Council Family Hubs)**

There continues to be an extremely high demand for Emergency Accommodation across the region for both families and singles.

#### **Rough Sleepers**

The Homeless Services Team continue to liaise with the DRHE Outreach Team regarding any reports of rough sleeping.

The following table sets out the number of reports we have received to date in 2022:

\*On 30/12/22, seven new rough sleepers were discovered, and the Council's Homeless Services Team followed up with the DRHE Outreach Team, who visited the locations and offered supports and emergency accommodation. It has been brought to our attention that at the time of writing, all the persons are reluctant to engage with services and have already refused emergency accommodation. Of the seven rough sleepers, four were identified as applicants of other Local Authorities who have since been informed of these cases, and who are duly following up in relation to same. Our Homeless Team is currently liaising with the DRHE Outreach Team in relation to the three other rough sleepers establish their names to and circumstances to enable the Council to carry out homeless assessments and to encourage them to avail of homeless services.

#### Cold Weather Strategy 2022/ 2023

The Dublin Region Homeless Executive (DRHE) has activated its Cold Weather Strategy 2022/ 2023 which runs from November 2022 to the end of March 2023. This is to meet a likely increase in demand for homeless services and to have the appropriate contingency plan in place for cold weather conditions.

Should there be a cold weather or any emergency event, the DRHE will co-ordinate the response to homelessness on behalf of the four Dublin Local Authorities. Whilst services continue to operate throughout the year to support people experiencing homelessness, during the winter period, services are increased and enhanced to mitigate against the health risks that the bad weather poses.

#### Homeless Action Plan 2022- 2024

The DRHE, with the approval of all 4 local authorities in the Dublin region, has finalised the Homeless Action Plan Framework for Dublin 2022-2024. This Plan is the first plan to be put into operation since Ireland signed the Lisbon Declaration on combatting homelessness in June 2021, which aims to end homelessness by 2030. It will follow on from the previous Homeless Action Plan for 2019- 2021 and continues with the three key themes of **Prevention, Protection and Progression.** 

The Plan was developed based on a detailed consultative process including submissions from various Stakeholders, interested organisations, Service Providers, Members of SPCs of the four Local Authorities, the Dublin Joint Homelessness Consultative Forum and the Statutory Management Group.

#### Traveller Accommodation Plan

A significant programme of works in relation to the refurbishment and upgrading of existing accommodation on specific sites is currently in development with the County Architect. These works are in accordance with the objectives set out in the Traveller Accommodation Programme 2019-2024. Fingal County Council recouped over €1million from the DHLGH's budget of €18m for the provision Traveller Accommodation in 2022.

Regular site visits by Housing Inspectors continues on all Fingal County Council Traveller specific sites while checking on vulnerable residents and advising on the continued supports available. Council Official continues to liaise and engage with the Traveller Community, Traveller Advocacy Groups, Welfare Services, Child Services, Mental Health Services and other services and agencies to resolve issues when and where possible.

Circular 45/2022 requires the Council to carry out this year's "Annual Estimate of Accommodation of

Traveller Families 2022" and make returns to the Department in January 2023.

#### **Housing Welfare**

The Social Workers attached to the Housing Department are available to support vulnerable tenancies and to work with housing applicants who have medical/welfare needs.

The Estate Management Section continues to work with the most vulnerable and complex of our Tenants in collaboration with our Social Workers, Tenancy Sustainment Officers and external statutory agencies to protect and assist the most vulnerable of our tenancies through a range of support services.

#### **Housing Maintenance**



#### **Boiler Servicing Programme**

The Council provides an annual heating servicing facility, including all maintenance and upgrade works, for a nominal fee of €3 per week to participating Contractors tenants. progress batches of work throughout the course of the year. Contractors have been issued the full list of properties to be serviced by year end and are working across the County in areas such as Avondale Place, Domville Woods, Dromheath, Fortlawn, Sheephill, Portrane, Ballyboughal, Balrothery and Dún Saithne.

#### Anti-Social Behaviour / Inspectorate Unit

The Estate Management Section has reintroduced in-person Tenant Induction Training for our new Tenants to provide them with useful information and contact details to assist them settle into their new home and local community, the next induction training will be scheduled for Q1, 2023. The ongoing management and sustainment of social tenancies and good estate management falls within the remit of the ASB/Inspectorate Unit. Alleged breaches of Tenancy Agreements are investigated and pursued in accordance with housing legislation and policy.

There are occasions when the vulnerabilities, complexities and health related issues associated with a tenancy require tenancy sustainment and welfare intervention and supports. Ongoing case management and review with a variety of external agencies, including Approved Housing Bodies, An Garda Síochána, TUSLA and the HSE may be reauired to ensure all agencies work collaboratively with a view to achieving best outcomes for our Communities. This work is ongoing in relation to a number of Tenancies in the county.

Within the remit of the Estate Management Section, a project team has been assembled to focus on the effective use of Council stock, including illegal occupations, abandonments and legal matters arising with regard to breach of Tenancy Agreements. 



#### **Housing Ukraine Response**

The Government is committed to delivering a humanitarian response to welcome people fleeing the conflict in Ukraine and seeking protection in Ireland.

The Council's Fingal Ukraine Response Forum continues to meet regularly to assist co-ordinate the response of the various statutory agencies and voluntary groups in the county to assist the Ukraine community.

#### Liam Rodgers Rest Centre

The centre was re-opened as temporary accommodation for displaced Ukrainians on the 2<sup>nd</sup> November 2022 to cater for increasing pressures on the accommodation situation in the country for displaced Ukrainians. The centre is presently being utilised for new arrivals to the country with various statutory agencies linked with

the centre to provide support to the new arrivals. Every effort is made to move the rest centre occupants to more permanent accommodation as soon as possible. Supported by the Council and the Peter McVerry Trust (PMVT), 70 persons have moved from the centre to pledge accommodation across the country since the 2<sup>nd</sup> November 2022. An additional 44 persons moved to fully serviced\self - catering forms of IPAS accommodation on the 21<sup>st</sup> December meaning the centre was empty on that date but available to provide contingency for new arrivals to the country over the Christmas period.

The centre is expected to have full occupancy in early January 2023 and the PMVT will continue to engage with occupants to move on to pledge accommodation.

#### Pledge Accommodation

385 pledge properties (vacant and mainly house share) in the county were assigned to Fingal County Council by the Department of Children, Equality, Disability, Integration and Youth (DCEDIY) to assess if still available and suitable for occupation, which was on foot of a call for pledged properties in early 2022 operated via the Irish Red Cross (IRC). The Council sought to contact all 385 owners. The Council work with its implementing partner (PMVT) to match Ukrainian displaced persons to these properties where the properties remain available and suitable.

To date, 103 of these properties have been occupied. 16 house share properties remain to be occupied but are not immediately available for occupation or in a process of matching. The balance were deemed unsuitable following assessment for various reasons, including pledge withdrawn by the property owner, or the property owner has not responded to contact to date.

#### A new national call for vacant unoccupied

**properties** to accommodate Ukrainian displaced persons was launched on the 24<sup>th</sup> November 2022. In terms of the Fingal area, 7 properties have been pledged to date, with the Council engaging with 6 other property owners who have not formally

pledged a property but have made an expression of interest. 1 of the pledge properties has already advanced to occupation through the work of Fingal County Council and the PMVT with inspections of other pledged properties underway in dialogue with the owners. It should be noted that the monthly recognition payment has increased to €800 per month.

#### Vacant Homes

The Council's Vacant Homes Action Plan was launched on the 9<sup>th</sup> December 2022.

The Vacant Homes Plan will help continue to bring vacant properties back into use as a cost-effective and sustainable way to increase the supply of housing to meet housing need. In doing so, the Council believes it can help improve neighbourhoods, increase access to housing and help to improve quality of life for those living in the towns, villages, rural and larger urban areas within the county.



**Croí Cónaithe** 

The Vacant Homes office is accepting applications under the Croí Cónaithe Refurbishment Grant Scheme. This is a national scheme administered by local authorities introduced under *Housing for All*. This scheme provides new choices for people to live in towns, villages and rural areas in Ireland through the provision of a grant to support the refurbishment of vacant properties. Note the scheme is expanded to cover all parts of the country (urban and rural). Accordingly, applications are now accepted with respect to all areas in Fingal.

Subject to meeting eligibility criteria, a grant of up to a maximum of €30,000 is available for the refurbishment of vacant properties for occupation as a principal private residence, including the conversion of a property which has not previously been used as residential. Where the refurbishment costs are expected to exceed the standard grant of up to €30,000, a maximum top-up grant amount of up to €20,000 will be available where the vacant property is confirmed by the applicant to be derelict (i.e. structurally unsound and dangerous) bringing the potential total grant available for a derelict property up to a maximum of €50,000. To date, 8 applications have been received. 3 have been approved with works underway. In addition, staff are engaging with 16 other expressions of interest.

A separate Croí Cónaithe (Serviced Sites Fund) has also been launched. This fund allows local authorities to make serviced sites in towns and villages available to potential individual purchasers. These sites will be available at a discount on the market value of the site for the building of a property for occupation as the principal private residence of the purchaser.

The level of discount to the individual will depend on the level of servicing cost incurred by the local authority before the sale of the site with discounts up to a maximum of  $\in$  30,000. The amount of such discount will be reflected in the sale price of the site to the purchaser. The examination of sites that may be suitable for the scheme is under way and any relevant sites will be advertised on the Council's website when such sites have been identified. Engagement is taking place with the DHLGH on the operational aspects of the scheme and a process to identify suitable sites is underway.

#### **Community Development**

Community development is a process where community members come together to take collective action and generate solutions to common problems. Community wellbeing, economic, social, environmental and cultural challenges are often solved through collective action being taken at a grassroots level. Community development ranges from small initiatives within a local group to large initiatives that involve the broader community, Building community capacity, strengthening community participation and involving people in decisions that affect their lives is a complex process and can only be achieved by working with local communities and agencies who have responsibility to the people in those communities.

In November/December the Community Development Office worked in partnership with a number of community groups and partners to support the projects/Initiatives set out below.

#### **DUBLIN 15 CHRISTMAS EVENTS**

Dublin 15 was full of festive spirit this December. A number of groups and centres were supported by the Community Office to run a variety of events, from art and craft workshops, Christmas wreath making and Carol Singing. Mr. Claus and his Elves made an appearance them all and brought great excitement and joy to both the younger and older members of the community.







COMMUNITY WRAP PROGRAMME BALBRIGGAN

On the 7th and 8th of December 2022 Fingal Community Office in partnership with Suicide or

Survive supported fifteen community leaders in Balbriggan to complete the first stage of the Community WRAP programme. This group included; The Drugs Task Force, Daughters of Charity, Family Resource Centres, Annur Islamic Foundation, Cancer support service, community civic leaders and Fingal Community Development Office.

This programme enhances the skills of volunteers and community services that are already working with vulnerable members of our community as well as building community core strength. It supports our communities across Fingal to strengthen their resilience and build stronger, more sustainable and cohesive communities. This cross-county Initiative supports citizens of Fingal to build emotional, mental and physical resilience in order to support each other in a post trauma covid environment.



#### Dublin 15 Community Centre Manager Network

In December the establishment and initial meeting of the Dublin 15 Community Centre Managers network took place. This network will allow centres to communicate with, support and learn from each other, as well as update each other on events and initiatives being held in the centres locally and to avoid duplication.

#### WELCOME ROOMS – A WARM WELCOME

To help provide a network of friendly drop-in locations for people across north Dublin, Fingal County Council is supporting a pilot initiative at three key centres that will give a welcoming and comfortable environment where people can feel at ease and at home.

Rivervalley Community Centre, Parslickstown House and the Corduff Community Resource Centre will open their doors as part of its "Welcome Room" pilot programme running over the next three months. While the three centres have been the meeting point for many community-based groups over several years, the living room initiative will further help serve the needs of the local community. Each location will provide free, friendly, safe and supportive spaces for the public over this winter.

The Welcome Room concept will give visitors the opportunity for social interaction and a relaxing space to unwind, with food and drink available as well as books to read, board games to play and film sessions. Fingal will develop further activities as the initiative progresses.

#### HARTSTOWN COMMUNITY CENTRE

Hartstown Community Centre has now been taken in charge by Fingal County Council. A facility operator has been engaged to oversee the day-today operation of the facility on behalf of Fingal County Council and the board of management. The Community Development office are working very closely with all parties to ensure that the community can make full use of the facility. A management licence will be issued to the local board of management in 2023. Fingal County Council will support and work collaboratively with the Board of Management as they continue their work in 2023.

#### COMMUNITY FACILITIES SUPPORTING BARRETSTOWN HOUSE

33 community facilities from across the network are participating in the "Batteries for Barretstown" recycling project. This is another project that will further support the roll of Keen to be Green in Communities across Fingal.

European Recycling Platform (ERP) Ireland is powering positivity at Barretstown in a new threeyear initiative, 'Batteries for Barretstown,' aimed at increasing awareness of battery recycling and raising much-needed funds for Barretstown. Batteries can be recycled free of charge at any one of the 33 FCC supported facilities. All batteries collected will contribute towards a donation fund that aims to raise  $\in$ 120,000 for Barretstown over the next 3 years.

The project commenced on the 10<sup>th</sup> December and community centres have confirmed that they are being fully utilised by the local community.

#### INTERAGENCY

The Community Development office actively seeks to work in collaboration with agencies to maximise service delivery and resources to communities.

In October/November the CDO supported the delivery of the following:

#### **Fingal PPN**

The position of Fingal PPN Resource Worker has been advertised and interviews will be conducted at the end of January 2023. This position is an important element in supporting the PPN Secretariat in the delivery of key outcomes under the strategic plan.

- Linkage Groups submitted submissions into the 2023 SPC Policy Programme

#### **UKRAINE SUPPORTS**



The Ukrainian support unit has facilitated the rental of space in Applewood Community Centre by EMPOWER which will be used to host a Ukraine Jobs Club and English language classes. Currently arrangements are being made for a hot desk facility for EMPOWER to base a Ukraine Support worker on site.

The Support Unit is currently developing a network of key community people from Ukraine support groups as an information sharing platform and as to allow information be disseminated to Ukrainian community efficiently when required. All rest centres have been surveyed to establish a list of events that are planned up to and over Xmas period and to establish where help can be provided in social supports initiatives over the season. Transport was organised to bring our Ukrainian community members to Christmas Markets over two weekends in December.

The CNN members are excited to commence work on their new chosen topic, Education. Because the topic is very broad The FCNN commence discussion early in the new year on which aspects of Education they want to focus on.

The Steering Committee held their final meeting of 2022 in Parslickstown House. The committee congratulated the CNN members and the coordinator on their work through the year and especially on the work they put into the AGM, which was a great success.

The Fingal Integration Team works to deliver the Fingal Migrant Social Cohesion Strategy 2019-2024. The Team promotes inclusion and diversity in all areas of work and support delivery of actions through collaborative work / initiatives across the county of Fingal.

# College Connect Comes to the Women of Balbriggan



#### AGE FRIENDLY

Age Friendly Fingal is committed, through this strategy, to driving a collaborative, multisectoral approach which supports interventions that will significantly help to improve the quality of life of the current population of older people in Fingal and future generations.

#### Memory Makers Recipe Book – Tastes like Nostalgia



*Tastes like Nostalgia* captures favourite family recipes from older people in Fingal, together with short stories, poems, photographs and anecdotes that sum up the memories or feelings the recipes recall. It is more than just a recipe book, it's a social history of food and family life.

It contains recipes and memories from older people living Fingal including residents of nursing homes and users of day centres and meals-onwheels services, ensuring it is truly inclusive. While the official launch of the book was cancelled due to a severe weather warning, the book was distributed to all contributors and copies are available from the Community Department.

#### Fingal's Older People's Council

The OPC re-commenced in-person meetings at the beginning of 2022, although some were hesitant having 'cocooned' for months but as they settled back in, the work commenced. The year brought lots of challenges as well as many successes. The main activities included a very successful and well

attended Annual Conference in May, a "Give it a Go Day" in Newbridge House to celebrate Positive Ageing Week and the publication of *Tastes like Nostalgia*.



Following the success of the training on the **"ABC** of LGBTI+" delivered by Dublin Pride, training on the role of OPCs will be delivered by Age Friendly Ireland to FOPC in January. This will be followed by a meeting with representatives of Comhairle na nÓg in February to discuss their work plan and how they represent the voice of younger people in Fingal. A meeting with Dun Laoghaire Rathdown's OPC will follow before a 12-month workplan is developed by the OPC with the assistance of an independent consultant. This will ensure that the voices of older people and particularly those who may experience 'double disadvantage' will be represented by the OPC.

#### FUNDING

#### Jan 2022:

LCDC funding workshop for community groups 100 groups attended

#### March 2022:

Community Activities Funding 50 groups approx. attended

**October 2022:** Community Activities Funding 75 groups approx. attended

A number of changes were implemented in January 2022 and throughout the year to provide greater supports to community groups as they resume their activities post covid. The activity funding budget was increased from €200k to

€300k, the individual maximum grant increased from €2k to €3k per annum and funding was provided up to 100% of the cost subject to the maximum allowed.

These measures coupled with the frontloading of 50% of grants provided a well needed support to community groups as they remobilised across the County with a substantial increase in activity noted across all areas in comparison to pre covid levels of activity in 2019.

#### **EXTERNAL FUNDING**

18 applications for external funding leveraged on behalf of community organisations' and supported by the CDO team. This involved advising the group on completion of the application and in many cases completing and submitting on behalf of the group to the DRCD, Sports Capital and POBAL. 13 were successful €168,665.25 3 awaiting decision €172,500 (total value) 2 unsuccessful

#### SPORTS OFFICE

The Sports Office supports and delivers programmes aimed at increasing participation in sport, targeting specific groups such as children, youth at risk, disadvantaged groups, teenage girls, women in sport, older adults and people with disabilities

#### Try Track & Field Programme

6 schools and 900 children from Dublin 15 took part in Athletics Ireland's Try Track and Field Programme in partnership with the Sports Office. The programme included 6 weeks of in-class Track and Field activities culminating with 3 of those schools Ladyswell NS, Powerstown ETNS and Tyrrelstown ETNS highlighting their skills at the National Indoor Arena. This was a fantastic opportunity for children in disadvantaged areas to use the National facility and link in with Athletics Ireland coaches. The other 6 schools will get an opportunity to participate in the arena in the New Year.





#### **Olympic Handball School Programme**

Fingal Sports Office in partnership with Irish Olympic Handball Association brought the minority sport to 400 3<sup>rd</sup> class students for a 6week programme of skills and drills. After 6 weeks, 7 schools from Blanchardstown and Swords came together to showcase their skills in an Olympic Handball blitz. All students received a medal of participation from the Mayor of Fingal Councillor Howard Mahoney and Director of Housing and Community Robert Burns who attended the awards of the day.

For 2023, Fingal Sports Office will be training interested primary school teachers in the sport to continue the growth of the minority sport in the county with a Fingal blitz taking place in May.





Fingal HomeFit Pilates 2023 Live Sessions

We are delighted to welcome Jayne from Core Healthy back in January for a 6-week online Pilates course aimed at beginners, but all are welcome. Pilates is a non-impact form of exercise that focuses on controlled movements to improve posture, strength and flexibility. ### **Exercise Energise Come and Try Day**

Fingal County Council's Sports Office was delighted to host the Exercise: Energise "Come and Try" Multi-Sports Day on 23<sup>rd</sup> November for the first time since 2019.

Deputy Mayor of Fingal Cllr. Cathal Boland and Director of Housing and Community Robert Burns were in attendance at the National Indoor Athletics Arena in Abbottstown to see over 300 teenage girls from eight secondary schools from across Fingal take part in the day. The participants got to try out twelve different fun sports activities ranging from Frisbee Golf, Olympic Handball, Basketball, Unihoc, High and Long Jump and Tug O War. The Programme which is aimed at girls aged 12-15 years who are not involved in sport or physical activity has been running for over ten years with financial support from Sports Ireland's Women in Sport funding stream and the Fingal Sports Office.

#### <u>Active Travel</u> Protected Cycle Lanes

#### Baldoyle-Howth Protected Cycle Lane Scheme Phase 1

Minor concrete, line marking and bollards works were carried out over the past month. The scope of works for the protected cycle lanes has now been completed by the contractor. At present the project is currently going through snagging phase to progress the project to close out.

#### St. Cronan's Ave and Brackenstown Road Protected Cycle Lanes

The contractor has continued in the past month with the completion of junction upgrade works at the junctions along Brackenstown Road and St Cronan's. Works are substantially complete along Brackenstown Road to the shared surface in front of the school and church.

The new off-road cycle track on the Brackenstown road is now taking shape with final surfacing and markings to be applied in the coming weeks. We are continuing with ongoing consultation with the residents, schools and other local stakeholders regarding the works as they progress.

The project team is liaising with local councillors to ensure works are successfully implemented and to minimise disruption to the public. Resurfacing works are due to commence in the coming weeks and traffic management will be in place during this important work. Some delays may be expected.

#### **Towns & Villages**

Works are continuing in the development of an Active Travel Plan for a number of our Towns & Villages. Details are outlined below.

**Skerries Active Travel Plan** 2022 has seen the successful completion of the Non-Statutory Public Consultation regarding the Skerries Active Travel

Plan and over 565 submissions were received with circa 2000 suggestions. The project team are currently working through the submissions to categorise them and compile a report that will inform the next phase of the project. Our objective is to seek ideas and comments from residents of and visitors to Skerries that will inform plans for Active Travel schemes in the town was deemed to be a great success from the submissions received. The process of not presenting or designing any solutions initially was welcomed through our engagement, and people were given the chance to put their ideas forward in advance of any concept designs being developed. This provided the local stakeholders to have their input at a very early stage and this inclusive approach is valuable to the success of the project. During the Consultation period we have conducted on street surveys and several workshops with community members and with the local community school in order to capture the views of the whole community across all ages and abilities.

We have continued engagement with the ESRI who have been looking at best International and National practice regarding Behavioural Change and Economic Benefits from Active Travel measures introduced in similar towns and villages. The Active Travel Project Team together with their Communications Consultant and the ESRI are currently working through the submissions and compiling the reports to provide the necessary insight and guidance to the integrated Design Team and the next steps in our Active Travel journey in Skerries.

We are looking at some of the smaller and quick win ideas suggested to see if these can be

implemented through our current Operations and Active Travel department.

#### New Street, Malahide Public Realm project

The non-statutory consultations are completed. Designs have been developed and updated to take account of feedback collated to date.

Final data/surveys are due to be carried out in January to complete and verify the screening reports for Environmental Impact Assessment and the Appropriate Assessment.

Once determinations are completed, the appropriate planning process will commence.







#### **Connectivity/Permeability**

We are continuing to receive various requests for Permeability and Connectivity improvements from various stakeholders across the county. These requests are being recorded in detail for evaluated through a multi criteria analysis. The projects are then reviewed across the departments to identify if an appropriate means of delivery can be established on the ground.

Where other projects being progressed in the area at either design or construction stage; we endeavour to include these Connectivity and Permeability improvements within those projects. Greenway connectivity support teams have been convened to review, design, and deliver active travel infrastructure that will enhance accessibility between the proposed strategic greenways and residential, educational, amenity and commercial zones. These support projects have been set up for Fingal Coastal Way, Broadmeadow Way/Sutton to Malahide Greenway and Royal Canal Greenway. This will help to optimise the use of the proposed greenway by both leisure and commuter users.

#### Access Constraints

Following on from circular (NGS Circular 4/22), the guidance from the NTA (Access Control of Active Travel Facilities) the Active Travel Unit has mapped the access constraints (in particular kissing gates) within Fingal. We have put together a list of access constraints to be considered for removal and works proposed to improve for pedestrians, cyclists and disabled persons. This list is currently being reviewed by the various departments to ensure that the removal of these constraints provide a positive impact in these areas. On completion of the review Fingal County Council Active Travel in conjunction with Operations will be coordinating the removal of these access constraints across the county.

#### Secure Bicycle Parking Infrastructure

Our Contractor has returned from the Christmas break and is currently working across many areas constructing concrete bases for bike stands and expanding public bike parking facilities in the overall area. In the run into the Christmas period we have managed to deliver bike and scooter parking stands to schools, sports clubs and community centres who had submitted expressions of interest earlier in 2022.

Over 91 Bike racks and 89 scooter racks were delivered in all. Active Travel intend to send out another expression of interest to schools, sports clubs and community facilities again in 2023 to groups who previously did not respond. This will allow us to evaluate the submissions and distribute further bike parking facilities to these establishments.

#### **Road Safety**

#### Safe Routes to School

The Active Travel department have continued works on the 2022 Safe Routes to School Programme. Design works for the first 5 schools has now been completed with design works for the second tranche of schools ongoing, and these works will be progressing to construction phase over the coming months The Active Travel Department and our consultants have been busy meeting with schools and stakeholders to discuss the works.

A Contractor (Circet) was appointed in early November 2022 and commenced with works at each of the three school sites included in Tranche 1:

- (1) Rush and Lusk Educate Together
- (2) Castaheany ETNS & ST. Benedicts
- (3) Bayside Jnr & Snr School

Works to date have progressed well, with little or no disruption to the schools or traffic in each of the three areas. These works will progress during January and February to improve safety for pedestrian's, cyclists and vulnerable road users in these areas.

The upgrade of the existing junction at Hayworth Drive adjacent to Castaheany/St. Benedicts school has been completed. The contractor has also upgraded the existing zebra crossing to enhance pedestrian and cyclist safety. Works will continue to complete junction tightening and installation of tactile crossings.





In relation to Bayside Jnr & Snr School, the junction tightening has been completed at Alden Park, Verbena Lawn and Sarto Park. The tabletop ramp has been installed at the junction between Verbena Avenue & Sarto Park. Initial work has begun on installing rain gardens which will continue in the new year.

In mid December An Taisce announced Round 2 of the Safer Routes to School programme, with the following Fingal schools selected:

Holy Family Junior National School, Forest Fields, Swords

Scoil Bhríde Buachaillí, Church Avenue, Blanchardstown

Scoil Bhríde Cailíní, Church Avenue, Blanchardstown

St Helen's SNS, Limetree Avenue, Portmarnock

St. Colmcille's Girls' National School, Chapel Lane, Swords

The Active Travel team will shortly commence a review of our procurement strategy in this regard.

#### Mobility & Behaviour Change St Cronan's Walking Bus

Each Friday in December our Walking & Cycling Officers facilitated Walking Buses for St Cronan's JNS & SNS. This was part of the Safer Routes to School Treatment and aimed at encouraging pupils to use the improved infrastructure.

The idea behind the initiative is to identify parents who can volunteer and keep the Walking Bus going. This is a new approach to setting up Walking Buses and if it proves successful, will provide a model going forward. We had nearly 30 children take part over the 3 Fridays and plan to continue throughout the month of January to build momentum.



#### Learn 2 Cycle with a Disability

Since June 2022 we have undertaken 14 Learn 2 Cycle with a Disability Courses working with a total of 200 children with additional needs. This 6-week course provides children with differing needs the opportunity to take part in smaller sized sessions than traditional cycle right sessions and makes independent cycling a more achievable goal.

We currently have 18 courses in the diary for 2023 in various locations around the County.

To thank our school wardens for all their hard work and commitment throughout the year we held two Christmas breakfast days for them in December. One in Swords and one in Blanchardstown. Over 40 Wardens attended over the two days. This was just a very small way to show our appreciation, but it also provides them with a great opportunity to meet the Active Travel Team and each other and it is something we hope to do more of in 2023.



#### The Santa Cycle

On Sunday 4<sup>th</sup> December we hosted a very wet and cold Santa Cycle Event in the Phoenix Park in partnership with the OPW, Dublin City Council and The Dublin Cycling Campaign. 


Figure: The Santa Cycle

#### **Climate Action**

The Fingal Climate Change Action Plan 2019-2024 (CCAP) was launched in Sept 2019, and actions are ongoing.

The CCAP Third Annual Progress Report was presented to the Climate Action, Biodiversity, Environment Strategic Policy Committee SPC in December 2022 and was well received. The Report presents an overview of progress against each theme of the Plan in a very accessible format, and outlines progress in summary against all of the actions in the Plan.

The Council's energy efficiency targets have been met, and the Active Travel, Energy Management and other internal teams have been strengthened over the past year to deliver on the Plan. The Report can be viewed at:

#### **Environmental Awareness**

Tree-planting workshops were held in 3 secondary and 5 primary schools across Fingal in December and a mixture of native species were planted by the students and staff. Two Community planting days were also organised in Malahide and Newbridge House Grounds. These were attended by members of the public as well as schools, horticulture students from the Balbriggan adult education, and some local people who wished to plant trees in memory of loved ones. Over 700 trees were planted over these fun and informative events.

The Picker Pals program is currently running in 82 classes in primary schools all over Fingal. The program encourages families to get outdoors at the weekends and pick litter in their local areas.

The Balseskin Migrant Reception Centre residents were delighted to receive 10 kids bikes and 6 adult bikes from the ReUse and Repair program in December. The bikes were sourced at the Estuary Civic Amenity site and repaired by the Rediscovery Centre in Ballymun which is the National Centre for Circular Economy. Palm-oil-free chocolate was made available for sale in the staff canteens to promote sustainable and palm-oil free chocolate in advance of Christmas.

Used battery collections have been streamlined across Council services. Libraries and community centres across Fingal are collecting used batteries from members of the public, and there are also collection points for staff in offices and depots. Proceeds go to Barretstown for Children charity. Recycling of used batteries is important as they contain precious metals and are very harmful to the environment if not disposed of properly.

#### **Circular Economy**

The Climate Action, Biodiversity, & Environment, Strategic Policy Committee was presented with a Circular Cities proposal in December 2022, and it was well received. The SPC has recommended that the Council sign up to the Circular Cities Declaration in 2023. In doing so, the Council would be committing to work to accelerate the transition from a linear to a circular economy within the Dublin region.

#### **Bottle Banks**

#### Anti-litter anti-Graffiti Grant on Bottle Banks

An Anti-Litter Anti-Graffiti Grant was awarded to the Donabate Portrane Community Centre by the Environment Awareness section. As part of the project a Storage Container was painted, and two bottle bins painted. The Grant has improved the area greatly and we hope to roll this out to other Community Centres or organisations who wish to apply for the grant.

Environment rolled out a Christmas message on all Fingal County Council social media sites to inform the public on proper use of the Bring Banks over the Christmas period with contact details to report any issues re full Glass, Can and Textile banks.







#### **New Signage at Portrane**

Environment are continuing to improve signage at our Bring Bank facilities and will install new signage and replace old signage throughout 2023. Signage makes it clear to the public what can and can't be placed at our Bring Banks and that it is illegal to leave any waste behind.





#### Bottle Banks /Can Banks Blue Flag Award

Environment Recycling Section are currently consulting with Operations to assess the feasibility of providing Can Banks at Fingal Beach Facilities to assist the Council in achieving the Blue Flag award. Blue Flag is one of the world's most recognized awards for beaches, marinas and boats. The mission of the programme is to promote environmental education, sustainable development of tourism, environmental management systems and ensure safety and access for beach users.

The Blue Flag programme is funded in Ireland by the Department of the Housing, Local Government and Heritage. In order to qualify for this prestigious award, а series of stringent environmental, educational, safety-related and criteria must be access-related met and maintained. At beaches, the bathing water must comply with the excellent standard in accordance with the 2006 EU Bathing Water Directive. Beaches are awarded for the bathing season (June 1st to September 15th in Ireland) and marinas are awarded for up to 12 months, depending on their period of operation. The awarded sites for Ireland are announced at the end of May each year. Fingal County Council was awarded 3 Blue Flags in 2022: Velvet Strand, Portmarnock; Balcarrick Beach,

Donabate; and South Beach, Rush and have submitted applications for 2023.

Criterion 18: Facilities for the separation of recyclable waste materials must be available at the beach. This is classed as an imperative criterion.

• Should the community have a local recycling facility, containers must be made available at the beach for these materials, e.g., glass, cans, plastic, paper, etc. The receptacles should be properly designed and managed for the type of waste received, should be emptied regularly, and be well placed for accessibility.


• The recycling facilities should accommodate the collection and separation of as many different types of materials as possible, three being the minimum.

• On application, the local authority/beach operator must indicate whether the local authority has facilities for the recycling of waste. If no such facilities exist, the applicant must apply for a dispensation from this criterion.

• Blue Flag encourages all local authorities/beach operators to promote recycling and waste separation at the beach, even if the community does not have a local recycling facility.

# Glass Tonnage Report for December 2022 year to date compared to 2021


There were 526 tons of glass collected for recycling for the month of December 2022. This is compared to 586 tons which were collected in the month of December 2021. This reduction reflects the tonnages of glass collected returning to pre-covid levels.



#### **Textile Banks**

There were 18.27 tons of textiles collected for recycling throughout Fingal's network in November 2022. December figures not available until next month but as you can see the figures for textile recycling are up on this time last year.



We will continue to expand our network of Textile Banks throughout Fingal for 2023 as this is part of our commitment to the circular economy.





#### Litter Management

In December, the Litter Wardens continued their campaign to raise awareness of the issue of dog fouling in the Fingal area. They also erected anti dog fouling signage in areas where complaints were received.

A total of 268 planned route inspections on litter black spot areas were carried out.

They also carried out inspections on the bring banks in the Fingal area over the Christmas period to ensure that there was no dumping. Any dumping found was investigated under the Litter Pollution Act. They carried out investigation on reports of abandoned cars. Local businesses were inspected, to ensure they were keeping their premises free of litter.

In the district court in December 2022, three case was successfully prosecuted, and cost were

awarded on two other cases. Two cases were paid in advance and were struck out. Three cases were adjourned and will be heard in January 2023.

The Abandoned Vehicles Pilot scheme is continuing.

383 vehicles were reported to the Environment Department between  $1^{st}$  January 2022 –  $31^{st}$  December 2022.

The Litter Wardens carry out an initial inspection of all reported vehicles.


In 2022, 33 of the reported vehicles were deemed abandoned and were investigated by following a procedure of writing to the registered owners. Final inspection by the Litter Wardens were carried out before the vehicles were due for removal, 20 of the vehicles were reported as not insitu anymore and therefore not removed and 13 were reported as still abandoned and were removed by the Environment Department.

#### **Dog Warden Service**

Due to an increase in the number of dog complaints relating to breaches of the Parks and Open Spaces bye-laws received in November, the dog wardens have been focusing on issuing on the spot fines to any dog owners who they find in breach of the bye-laws and Control of Dogs Act 1986, operating on a zero tolerance policy.



10 Day Notices, fines that have been issued and paid during November and December are shown in the table below. It shows a decrease in the number of 10 Day Notices issued in December and is a reflection of the increased presence of the dog wardens in Fingal's parks.

Most of the on the spot fines have been issued for dogs being off lead in areas where they should be on lead. 7 fines were issued to dog owners for having restricted breed dogs unmuzzled while in a public place.

The dog wardens responded to 31 complaints made in December regarding the control of dogs, including the attack on the herd of goats on Howth head and one case of sheep worrying.

The wardens were also on call, 24/7 during the Christmas period.

#### **Dog Licences**

The below table shows the number of annual and lifetime licences purchased in December, compared to November. A yearly licence costs €20 and a lifetime licence costs €140. We will continue to promote the requirement for a dog licence on social media platforms. The total income from dog licences for 2022 is €317,120 (up to 19/12/2022) compared to €227,208 in 2021.

In December, four cases in relation to unpaid dog fines were successfully prosecuted. A total of €8,850 was awarded to Fingal County Council by the District Court judge on the day. Two cases were adjourned until January 2023.

#### **Dog Shelter Service**

The dog shelter holds stray dogs picked up by the dog warden and dogs who have been surrendered by their owners. At the beginning of the month there were 12 dogs in the shelter. During December, 16 dogs were found straying/seized and 1 dog was surrendered by their owner.

Of these 17 dogs, 7 have been reclaimed by their owners, 10 dogs have been rehomed to rescue and none have been rehomed to members of the public. At the end of December there were 12 dogs remaining in the shelter.



#### **Waste Enforcement Complaints**

Responding to waste related complaints continues to be a major priority for the Waste Enforcement Section in 2023. A total of 19 waste complaints were recorded for the month of December. The majority of waste complaints related to backyard storage of waste and burning of waste at **63%** while fly-tipping/illegal dumping accounted for another **37%**.





Awareness and education around the management of domestic waste in a sustainable and environmentally safe manner is crucial to ensure all households participate in a waste collection service as per the waste presentation bye-laws and use three bins (black, green and brown) to manage their waste. Illegally dumped waste costs Local Authorities hundreds of thousands of euro each year, money which could be better spent on providing services to businesses and local communities. #### **End of Life Vehicle Project**

When Fingal County Council commenced its End of Life (ELV) Vehicle Project in 2020, a total of 63 illegal ELV sites were identified which increased to 87 illegal ELV sites during 2022 (low and high–risk sites). Significant progress has been made to date with over 80 illegal ELV sites closed resulting in over 1000 ELV's brought to Authorised Treatment Facilities (ATF's) for recovery and disposal. A number of legal files have been prepared to tackle the more difficult high risk ELV sites where the site operator/landowner is refusing to remove the ELV's.





A recent court case heard in the District Court resulted in a site operator pleading guilty to offences under Section 39 and Section 55 of the Waste Management Act 1996 for illegally dismantling ELV's on site without the appropriate waste authorisation and for failing to comply with a Section 55 Notice to cease illegal activity and to clear the site of waste.

The Council were awarded legal fees and costs to the value of  $\in$ 5,000 as a result. The guilty party asked for an adjournment to allow them to regularise the site. The matter was adjourned for mitigation. However, The Court noted the plea of Guilty on the day.

The investigation and subsequent costs implemented against the guilty party will act as a strong deterrent to others involved in the unauthorised storage and illegal dismantling of ELV's.

#### **Regulation of Waste Activities**

At the end of December 2022, there are 18 facilities with a Waste Facility Permit in Fingal and 3 with a certificate of registration. One facility surrendered their permit during 2022.

The permitted facilities are 3 ATFs (Authorised Treatment Facilities) for car dismantling (2 of which are also metal recycling facilities), 2 Materials Recovery Facilities for skip waste, 4 soil recovery facilities, 1 paper shredding facility, 3 transfer stations (1 for used cooking oil, 1 for tyres and 1 for glass), 1 WEEE (IT) treatment facility, 1 plastic recycling facility and 3 metal recycling facilities. The facilities having a certificate of registration are 2 transfer stations for C&D waste and 1 soil recovery site.





All the facilities were inspected at least once during 2022 and a validation exercise on their annual return for 2021 carried out. Some facilities with ongoing non-compliances received additional inspection, with 1 facility visited 6 times during the year.



There currently is one Waste Facility Permit application being reviewed, with a decision due in early 2023.

#### **Commercial Food Waste Inspections**

It is estimated that up to 70% of the material in the general waste bins from the commercial sector contains recycling or organic waste. There is a legal obligation on all obligated commercial producers to source segregate Food Waste under the Waste Management (Food Waste) Regulations 2009.

'Waste Collection Household & Commercial' was a National Waste Enforcement Priority for 2022. The Waste Enforcement and Regulation section completed 11 commercial food waste inspections in 2022 under the Waste Management (Food Waste) Regulations 2009.

These inspections covered a range of premises – supermarkets, cafes, restaurants, fast food chains and delicatessens. Over 80% of the premises were compliant on the first inspection.



Under the regulations commercial food premises are required to segregate their food waste and there are three options for segregated food waste:

- The waste can be collected by a waste collector that is offering a brown bin collection service. The collector always must take it to an approved plant for recycling by composting or by another similar process;
- The waste can be transported by the business directly to a composting plant to other type of food waste recycling facility; or
- ✓ The waste can be dealt with by the business on site using an authorised composting unit.
