FORM OF COMPULSORY PURCHASE ORDER FOR THE PURPOSES OF SECTION 76 OF AND THE THIRD SCHEDULE TO THE HOUSING ACT, 1966, AS AMENDED BY THE PLANNING AND DEVELOPMENT ACTS, 2000 TO 2022

HOUSING ACT 1966 (AS AMENDED AND SUBSTITUTED)

LOCAL GOVERNMENT ACT 2001 (AS AMENDED AND SUBSTITUTED)

THE PLANNING AND DEVELOPMENT ACTS 2000 TO 2022 (INCLUDING SECTION 2.13 THEREOF)

AND ALL OTHER ACTS THEREBY ENABLING

WHEREAS Fingal County Council (hereinafter referred to as "the housing authority") propose for the purposes of the Housing Act, 1966, to acquire compulsorily the property hereinafter described:

15 Barnwall Court, Balbriggan, Co. Dublin, K32W838 comprised in folio DN183714F shown delineated in red and coloured light grey on the map referred to in this Order.

NOW THEREFORE it is hereby ordered that—

1. Subject to the provisions of this Order, the housing authority is hereby authorised to acquire compulsorily for the purposes of the Housing Act, 1966, the property described in the Schedule hereto which property is shown on a map marked Drawing no. 23-0140-PT-1001 entitled "Fingal County Council Compulsory Purchase (15 Barnwall Court, Balbriggan, Co Dublin) Order 2023" and sealed with the seal of the housing authority and deposited at the offices of the housing authority (hereinafter referred to as "the deposited map").
2. Subject to any necessary adaptations, the provisions of –
 - a) the Lands Clauses Acts (except sections 127 to 132 of the Lands Clauses Consolidation Act, 1845, and article 20 of the Second Schedule to the Housing of the Working Classes Act, 1890), and
 - b) the Acquisition of Land (Assessment of Compensation) Act, 1919, as amended by the Acquisition of Land (Reference Committee) Act, 1925, the Property Values (Arbitrations and Appeals) Act, 1960, and the Local Government (Planning and Development) Act, 1963 (as applied by section 26.5 (3) of the Planning and Development Act, 2000), and Planning and Development Acts 2000 to 2022 as modified by the Third Schedule to the Housing Act, 1966 (as amended) are hereby incorporated in this Order and the provisions of those Acts shall apply accordingly.
3. This Order may be cited as the "Fingal County Council Compulsory Purchase (15 Barnwall Court, Balbriggan, Co Dublin) Order 2023".
