FINGAL COUNTY COUNCIL COMPULSORY PURCHASE (15 BARNWALL COURT, BALBRIGGAN, CO. DUBLIN) ORDER 2023

Fingal County Council (hereinafter referred to as "the housing authority") in exercise of the powers conferred upon it by section 76 of the Housing Act, 1966, and the Third Schedule thereto (as amended by the Planning and Development Acts, 2000 to 2022), has made an Order entitled as above which is about to be submitted to An Bord Pleanála (hereafter also referred to as "the Board") for confirmation.

If confirmed, the Order will authorise the housing authority to acquire compulsorily the property described in the Schedule hereto for the purposes of the Housing Act, 1966.

Owners, lessees and occupiers of the property described in the Schedule will receive individual written notice.

If an objection is made in respect of the said acquisition by an owner, lessee or occupier of the property, and is not withdrawn, the Board may at its absolute discretion hold an oral hearing in relation to the matter. Before making its decision on an application to confirm the Compulsory Purchase Order, An Bord Pleanála must consider any objection made and not withdrawn, any additional submissions or observations made pursuant to Section 217A of the Planning and Development Acts, 2000 to 2022 and any report of the person who held the oral hearing, if such an oral hearing takes place.

Any objections to the Order must state in writing the grounds of the objection and be sent addressed to

An Bord Pleanála, 64, Marlborough Street, Dublin 1, D01 V902 so as to reach the said Board before 4.00 pm on the 19th October 2023.
