Chief Executive's Foreword

Just two weeks ago the night skies across Fingal were ablaze with incredible fireworks much to the delight of the thousands of spectators who witnessed the Festival of Fire at Balbriggan, Blanchardstown, Malahide and Swords on Halloween night. The fun was not only limited to spectacular fireworks displays as Community Centres, Library branches and local Resident's Associations ensured an enjoyable celebration was had by all by staging pumpkin hunts, Halloween themed arts and crafts events, spooky discos and scary storytime sessions as part of a jam-packed programme designed to thrill and engage children of all ages. Halloween is a much anticipated time of year but can put undue pressure on local authorities and the emergency services who have to deal with reports of illegal bonfires burning. Not only are these bonfires a hazard to public safety, but they also cause considerable damage to open spaces and public property which necessitates an annual clean-up cost of approximately €150,000. Each year, Fingal County Council's Operations Department assists the Fire Service, An Garda Síochána and other agencies by removing stockpiled bonfire material such as pallets, tyres and furniture as well as offering an annual Halloween amnesty where combustible materials can be disposed free of charge in the run up to Halloween. I am very appreciative of the diligent work undertaken by Fingal staff across all areas in planning for and overseeing safe and memorable events for communities to enjoy at this time of year.

I am very pleased that the Elected Members have adopted an increased budget of \in 361.9 million budget that will be invested in delivering over 900 different services in Fingal over the year. Adoption of the 2024 Budget sees an additional \in 28.1 million available from that received in the budget for 2023. Some of the highlights of the approved budget include;

- €16m increase for the housing department to help with the likes of provision of social housing, preventative maintenance works, homeless services and housing adaptation grants.
- An increase of €5.5m towards roads maintenance, parks, pitches, opens spaces and burial grounds.
- Around €3m to help develop and maintain libraries, tourism, arts, events and town centres.
- An additional €1.9m allocated to help invest in new and current community infrastructure and facilities.
- €1.7m towards planning and strategic infrastructure, including increased funding for biodiversity projects and initiatives.

I would like to express my appreciation to everyone involved in the preparation of a progressive and robust budget which will enable us to expand upon the work we carry out and which will enhance services, infrastructure and resources across Fingal.

With the festive season fast approaching, Christmas Markets in Fingal will provide the perfect setting to find unique and affordable gifts and to enjoy artisan food and drink whilst browsing through the ideally situated stalls. This year, there will be Markets at Swords Town Park, Bremore Castle Balbriggan and Shackleton Gardens Clonsilla with a wonderfully Christmassy atmosphere in each location guaranteed. The Markets will welcome festive shoppers from later on this month and you can plan your visit by checking out the opening hours on our website;

Finally, on behalf of the Elected Members and the Executive Management Team, I would like to congratulate Senior Parks and Landscape Officer, Kevin Halpenny, who has received the prestigious World Urban Parks Distinguished Individual Award for his exceptional contribution to the urban parks, open space, and recreation sector. This award recognises Kevin's many years of dedication to, and ambition for, the development of public green infrastructure and highlights the extraordinary vision, knowledge and experience which Kevin embodies through his work in Fingal County Council. We are very fortunate to have seen the fruition of the work of Kevin and his team in recent projects such as the Ward River Valley Recreational Hub, the rejuvenation of the Shackleton Gardens in Clonsilla and the commencement of construction of the Ballymastone Recreational Hub in Donabate. I am delighted that Kevin has been honoured with this well-deserved accolade and have no doubt that he will continue to deliver exceptional biodiverse, sustainable and healthy place projects for the benefit of the people of Fingal for many years to come. <u>HSU – Health & Safety Unit</u>


The HSU conducted and completed 28 site safety inspections and audits for the month of October, 8 VDU assessments for office and remote based staff along with carrying out incident investigations, formal engagement with the HSA following site inspections, and ongoing engagement with Uisce Eireann's HSQE staff and Fingal staff working for Uisce Eireann. Fingal County Council achieved a Higher Distinction Award along with an Exceptional High Achiever Award at the recent National Irish Safety Organisation & Northern Ireland Safety Group awards ceremony. This all-Ireland annual safety award ceremony has been in existence for 32 years. The award was on foot of the HSU's submission to NISO on the behalf of Fingal County Council earlier in the year. In addition the HSU ran a programme of work for European health and safety week 2023 [theme: safe & healthy work in the digital age] which included a H&S conference for safety reps and fire wardens, a staff quiz draw and a safety campaign ran through staff messages.



The table below shows the total number of Elected Members' representations assigned to each Department to date in 2023.




Digital Services

Digital Working

In September, staff took part in 9,203 Teams meetings. 29,377 Teams calls were made, and 1,089,343 emails were received or sent by the Council.

1,126 support calls were logged by Council staff with the Digital Services Service Desk in the past month and 24 calls were logged by Councillors with Sord. 100% server availability and 100% network availability was achieved in the month of September.



Communications

Website

There were 127,559 visitors to the fingal.ie website during October and 290,860 page views. The average time spent on the site was one minute and 55 seconds. This was a increase of more than 5,000 visitors from September and the rise can be attributed to the information page for the Fingal Festival of Fire which attracted 9,000 visitors. Other popular pages were during the month were Planning Applications, Recycling Centres and Jobs.

Media

The Communications Unit issued 13 press releases during October and the topics included the €1.35 billion Capital Programme, Halloween Safety, the TY Skills Expo and the Climate Friendly Celebration in Balbriggan.

The month also saw the release of episode 24 of the Inside Fingal podcast which featured an interview with the new Arts Officer Sarah O'Neill. The Inside Fingal podcast has attracted 12,312 listeners up to the end of October.

Fourteen videos were published on the Council's You Tube account during September and these included videos about the draft Climate Action Plan and the Digital Trails App.

Social Media

The number of followers on Facebook crossed the 32,000 mark during October and stood at 32,077 at the end of the month. The LinkedIn channel has 8,036 followers while Instagram has 8,056. X, the channel previously known as Twitter, now has 23,028 followers while there are 1,159 subscribers to our You Tube channel. The five corporate social media channels have a total following of 72,356 which is a 35% increase in the 22 months from January 1, 2022.



Events

The Communications Unit assisted several departments during the month. Among these was the Economic Enterprise Tourism and Cultural Department and their Xplore Your Future TY Skills Expo in The Helix at DCU on October 3 and the People Services Department who had a stand at the Jobs Expo in Croke Park on October 14.

The involvement in Job Expoled to a spike in traffic to the jobs page on the fingal.ie website where there was a 274% increase in the number of visitors compared to the previous weekend as 591 people logged on compared to 158 a week previously.

The group also enjoyed a tour of the kitchens and gardens in Newbridge House & Farm and attended a networking event with members of the Fingal Food Network. With presentations from Christine Baker on Fingal's Food Heritage, Declan Power on the Fingal Food Policy, Breda Leonard chair of the network, Country Crest, McNally Family Farm, and the Herb School the group were impressed by Fingal's pedigree as a food producing area. The delegates were also treated to tastings from Hope Beer, Feisty Ferments and Hella's Kitchen.


Exploring & Thinking Dublin Local Authority Partnership

The event, which took place at Swords Castle included the book launch, the screening of Echo's Bones the original film which was launched in the Lighthouse Cinema, Dublin in 2022 and a panel discussion featuring the young people, artist, drama facilitator Sarah Fitzgibbon and Beckett Interpreter Sarah Jane Scaife.



Echo's Bones takes its name from a previously unpublished Beckett Text written as a Sequel to his famous story "Fingal". The Artist and young people took inspiration from this text and presented it as a way neurodivergent people navigate the world. The Film has already toured across Ireland and has become part of the conversation around representation to Middletown, Centre for Autism's Annual international conference, The Aberdeen Art Gallery, Scotland, the University of Galway's Centre for Disbability and Law which focus on young people's rights and is currently featured in the annual Tulca exhibition programme. The Project was funded through The National Per Cent for Art Scheme under Fingal County Council's Public Art Programme – Infrastructure.

Thomas Brezing is an established mid-career, multi-disciplinary artist and poet who has exhibited his work nationally and internationally.

Draíocht

Draíocht launched 2 brand new choral projects in October - one for Dublin 15 adults taking place in 3 community centres weekly for 8 weeks; and one for Dublin 15 Primary schools, weekly in 4 local schools for 6 weeks.

Project 1 is Draíocht's **D15 Community Choir Project**, a partnership with the Fingal Community Development Office and three community centres; Huntstown, Parslicktown and Castleknock. The project is led by renowned Choir Leader Debra Salem. Choir members enjoy a fun and social environment, meeting for a cup of tea or coffee prior to each session, followed by a full 8 weeks of learning a variety of songs, all building to a performance at the end of the project in Draíocht in December. The project was supported by visits from special guests who sang along with gusto in the early weeks, including Paul Donnelly TD, Cllr Angela Donnelly, Cllr John Walsh, Cllr Siohhan Shovlin, Cllr Tom Kitt & Cllr JK Onwumereh.

Project 2 is running in tandem with the Community Choir Project, a collaboration between Draíocht & The Mobile Music School, for Dublin 15 Primary School pupils, and is called '**A Song Project**'. Designed especially for 3rd & 4th class pupils, this 6 week project is taking place in St. Brigid's NS, Castleknock; Scoil Bhríde Cailíní, Blanchardstown; St. Patrick's SNS, Corduff and St. Ciaran's NS, Hartstown. The project is led by renowned Choir Master Dave McGauran. <u>LIBRARIES</u> Fingal Festival of History 2023

Fingal Libraries' seventh annual Festival of History was held over a two-week period running from Monday 2nd to Thursday 12th October throughout the library branch network. Life in Ireland and Fingal in the early 1920s was the main theme of the Festival, as we now approach the end of the Decade of Centenaries Commemorations.

The highlight of the Festival was the History at the Castle Day on Saturday 7th October which featured some household names such as Dr David McCullagh who spoke about Éamon de Valera; and Flór MacCarthy whose talk was based on her book "The Presidents' letters: Visitors' Books at Áras an Uachtaráin". Other speakers on the day included Dr Declan Brady discussing political life in Fingal in the aftermath of the Civil War; and retired Garda Detective Chief Superintendent John O'Brien who gave an insight into how the Troubles in Northern Ireland, especially during the 1970s and 1980s, impinged on life in the South and on that of An Garda Síochána. Talks held at library branches included the role newspapers and the printed word played in the fight for Irish freedom; life in Fingal in 1923 and beyond; British military deserters in the Irish Free State; the Markievicz Family; the Spanish Flu of 1918 and the fight against infection; the effect of the revolutionary period on the lives of children; and the Anglo-Irish way of life.

As part of the Festival this year, Fingal Libraries collaborated with the Clonsilla & Porterstown Heritage Society in offering a ninety-minute guided walk of the natural and built heritage of Clonsilla and the Royal Canal on Sunday 8th October.

Blanchardstown Library launches Little Library at Bedtime



On Friday 6th October at Blanchardstown Library, Roderic O' Gorman, Minister for Children, Equality, Disability, Integration and Youth and Heather Humphreys, Minister for Rural and Community Development announced the Little Book at Bedtime initiative. Little Book at Bedtime is a collaboration with public libraries and the Local Government Management Agency, that invites parents and their children to visit their local library to pick up their free bedtime story book. The bedtime story books are available in English and Irish. This popular initiative aims to encourage families to join their local library, and parents to read stories with their children at bedtime.

Celebrate Halloween and Fingal Inclusion Week at your local Fingal Library



The Autumn/Winter events programme for Fingal Libraries is well underway and includes an exciting range of tailored events. Library staff across our network of 10 branches have organised spooky Halloween arts and crafts and story time to keep children entertained during the Halloween break.

For Fingal Inclusion Week (13th – 19th November) and linked to the new EU Strategy on Mental Health, psychotherapist Amber Roche will release a number of mental health podcasts which will be aimed at people with autism, parents of children with autism, adults with ADHD, and migrants/refugees. The podcasts will be released in November so watch the Fingal Libraries' social media pages for more details.

During Fingal Inclusion Week, the Immigrant Council of Ireland will facilitate interactive workshops in Balbriggan, Baldoyle and Blanchardstown Libraries on respect for human and cultural diversity. ECONOMIC DEVELOPMENT

Fingal Skills Strategy

The next Skills Strategy Implementation Group meeting is scheduled for 1st November.



The Explore Your Future Expo is an educational showcase initiative by Fingal County Council, as part of the Fingal Skills Strategy, which took place in The Helix on the 3rd October 2023 and was a great success with more than 1,700 TY students in attendance from 16 schools across the county.







The Expo was supported by DCU, Interreg Europe, Dublin Regional Skills Forum, City of Dublin Educational Training Board, Dun Laoghaire Education and Training Board, Solas and a number of public and private employers including the Air Corps, An Garda Siochana, daa, Irish Rail, Ballymaguire Foods, Keoghs etc. The event featured live and virtual reality demonstrations with practical hands-on learning experiences for TY students by a variety of exhibitors to showcase the educational and training possibilities and potential career paths available for students.





The SKYLA Project "Smart Specialisation Skills Ecosystems for the Twin Transition" is a 4-year project which focuses on enhancing the role of VET in smart specialisation sectors. Projects partners include Italy, Poland, Sweden, Lithuania, Bulgaria, Greece and Belgium. Work has commenced on a communication strategy and stakeholder engagement plan. The agenda for the visit of the SKYLA Project partners to Fingal on the 7th & 8th November has been finalised with a day of project work and a day of site visits planned to key educational facilities to showcase training and education development in smart specialisation.

Economic Development Strategy

Grant Thornton Consultants continue work to develop an Economic Development Strategy for Fingal. A presentation was made to the September meeting of the Economic, Enterprise, Tourism & Cultural Development SPC on the approach and timelines for delivery of the Strategy. It is anticipated that the draft Strategy will be presented to the SPC, CPG and Elected Members for consideration in Q4 2023.



Fingal County Council is leading the URBACT EcoCore Project which comprises a network of 9 small cities/towns in Europe focussing on challenges and opportunities for green growth and sustainable economic development along transport corridors.

Balbriggan is the lead town and the other partners committed to the network are Albu Iulia, Romania; Dubrovnik, Croatia; Kekava, Latvia; Ormoz, Slovenia; Parnu, Estonia; Santo Tirso, Portugal; Tuusula, Finland; Villena, Spain. Fingal County Council as Lead Partner and the Lead Expert have commenced city visits to prepare baseline studies of all partner cities with the cities of Balbriggan, Villena, Ormoz, Dubrovnik, Tuusula, Parnu, Kekava, Albu Iulia and Santo Tirso completed.

The first transnational city visit to Balbriggan is scheduled for the 20th – 22nd November and will involve discuss of the Roadmap for the next 2 years of the project, workshops on gender, digital innovation, active travel, DBEC and regional collaboration, the Fingal Skills Strategy, site visits and peer review and feedback sessions.

Citizen, Equality, Rights and Values Programme (Cerv)

CERV is an EU Funding Programme for citizens' engagement and the implementation of EU rights and values. Fingal County Council has been awarded CERV funding to participate in 2 separate projects, which commenced in January 2023 and will continue for 18 months.



Green It Your Work

The fourth Green IT Your Work meeting will take place in the Larnaca, Cyprus in December 2023. Representatives will be present from Romania, Spain Greece, Cyprus, Slovenia, Croatia, Italy and Ireland.



Work is continuing on the objectives of 'Green IT Your Work' which are:

• Youth Debates about European Digital Age project highlighting the role of young people in the green transition.

• Promote green jobs with the aim of contributing to greener European cities

InclusEU

The InclusEU project aims to encourage volunteer action as a social response for an inclusive Europe. Fingal hosted the event in Balbriggan from September 28th to October 1st 2023. This event highlighted the work being done by Fingal, Foroige, sports clubs and schools to encourage more young people to get involved in community volunteering. This collaborative project has seen 20 young people from local clubs and youth groups take part in leadership and sports education training during July with practical sessions tied into local Fingal-led projects. The Mayor, Cllr Adrian Henchy, Deputy Mayor, Cllr Grainne Maguire, Minister Joe O'Brien, local councillors, Benny Cullen, Sport Ireland and numerous community reps attended the 3-day event. The delegates from Italy, Poland, Hungary, Spain, Portugal, the Netherlands and Romania got an opportunity to meet, discuss, debate and learn about the issues facing Balbriggan, the Council's objectives for the area and how young people are contributing to the town. The visit included a visit to O'Dwyer's GAA club, Bremore Castle, the Seamus Ennis Centre and a walk around Balbriggan town as part of the Place Standard Workshop, hosted by Healthy Ireland and Healthy Fingal, which seeks to improve peoples' wellbeing by improving the place they live.





Woodlands for Health

Healthy Fingal have partnered with Mental Health Ireland and the Sports Office again to organise the 2nd set of Woodlands for Health walks. The programme will see the HSE mental health services in Swords & Balbriggan avail of the opportunity to introduce service users to walking in Newbridge Demesne while availing of mental health expertise in the calming and quiet atmosphere of the walking paths around the demesne. The walks are taking place every Friday and run until 24th November.



Sustainable Fingal



The Council has collaborated with DCU and DAA to submit two funding applications on sustainable projects:

- DIFFER is a proposal for a Feasibility Study of District Heating in Fingal & an investigation of the feasibility of district heating from data centres in Fingal to supply Dublin Airport which has been submitted to the SEAI. The application was not successful and work has commenced to re-orient the project into another funding stream.
- ATLAS is a proposal to consider AI real-time connect on-demand mobility as a service which has been submitted to SFI for the Sustainable Communities Challenge. The application was not successful and work has commenced to re-orient the project into another funding stream.



The Mayor signed the Circular Cities Declaration for Fingal County Council, which was approved by the Council at its meeting in January. Work is in progress to develop an action plan to advance the objectives of Circular Cities in Fingal. Fingal's profile has been published on the Circular Cities website and the first annual report on Fingal's transition to the circular economy under the Circular Cities Declaration was submitted in October 2023.

Dublin Belfast Economic Corridor



Fingal County Council has been awarded €150,000 by the Department of Housing, Local Government & Heritage under the Shared Island Local Authority Development Funding Scheme for a Feasibility Study for the development of regional innovation/enterprise hubs along the Dublin Belfast Economic Corridor. The Council is leading on the project with the support of the eight local authorities and two universities of the DBEC partnership. KPMG are finalising the feasibility study in November.

DBEC's ambition is to use innovation hubs to encourage the development of new and existing high-growth businesses to stimulate sustainable and climate-conscious growth along the Corridor.

LOCAL AND RURAL DEVELOPMENT



Fingal Local Community Development Committee

The Fingal LCDC continues to oversee and administer the key areas of LEADER and SICAP and the various Local Development and Community Development funding programmes under its remit. The LCDC also manages the Healthy Ireland Initiative and the Social Enterprise Grants Scheme. The LCDC met on the 25th October 2023 to consider progress on the LECP and other matters.



Fingal Local Economic Community Plan 2023 – 2028

Consultants Grant Thornton have prepared the socio-economic profile of the county for the new LECP, reviewed the last LECP, drafted high-level objectives and facilitated the consultation process with the public and key stakeholders and incorporated feedback on the draft LECP. Work is underway on the 2-year Implementation Plan of the LECP (2023-2028).

A series of stakeholder sessions on the Local Economic & Community Plan (LECP) 2023-2028 were held during September for the Council's Elected Members and a presentation on the LECP delivered to the Economic, Enterprise, Tourism & Cultural Development SPC. The draft LECP will be submitted to the Eastern Midlands Regional Assembly (EMRA) by the end of October for their input, and it is anticipated that the LECP will be brought to the December Council meeting.

Community Support Fund

The Community Support Fund (CSF) was launched in January 2023 and is funded by the Department of Rural and Community Development. Fingal was allocated €341,875 in funding for groups across the county. More than 270 applications were received from community and voluntary groups in Fingal for the current and capital funding streams by the submission deadline of 10th February 2023. The evaluation of the applications is completed, and payments of the grants to community groups/organisations is ongoing.

Community Recognition Fund

The Community Recognition Fund (CRF) was launched in January 2023 and is funded by the Department of Rural and Community Development. Fingal submitted project proposals to DRCD for approval on the 15th March 2023.

Fingal County Council has received an allocation of €1,748,912 under the Community Recognition Fund for 26 projects across Fingal.

There is an allocation of €850,512 for eight projects in Swords and €435,000 has been provided for four projects in Dublin 15.

Three projects in the Howth Malahide Local Electoral Area have received a total of \notin 92,000 while \notin 96,600 will be spent on four projects in Skerries, Rush and Lusk. Three projects in Balbriggan will be funded by grants amounting to \notin 44,000 while two projects in Balseskin will receive a total of \notin 30,200 and one in Santry will receive \notin 20,000.

All projects are required to be complete by 18th October 2024 and work is progressing on the implementation of project with the Council submitting an initial drawdown on October 26th of €178,000 in respect of works completed during 2023.

SICAP



The resources and staff of the Fingal SICAP Programme continue to be leveraged to assist with the Ukrainian Refugee Crisis response. The SICAP Programme continues to help in the response to this crisis and is a central resource to the work of the Ukrainian Refugee Community Response Forum. Additional funding has been received from the DRCD to help with the delivery of services to Ukrainian Refugees in Fingal and additional staffing resources from the Ukrainian community have been employed on the ground to assist with this. The Fingal SICAP Programme has been allocated €304,369 in 2023 specifically for Fingal's Ukrainian Refugee Response with an additional allocation of €65,000 recently granted.

Procurement for SICAP programme period 2024-2028 has commenced and the tender evaluation is in progress.





Leader Programme

In December 2022, the Dublin Rural LEADER Local Action Group (LAG) approved in full the allocated LEADER 2021-22 Transition Programme for eligible projects in the administrative areas of Fingal, Dun Laoghaire Rathdown and South Dublin.

Fingal LCDC was successful in Stage 1 to run the next LEADER Programme 2023 – 2027 for the Dublin Rural LEADER LAG and submitted the new Leader Development Strategy for evaluation in Stage 2. In October 2023 the Council was advised that the Dublin Rural LAG and the implementing partner Fingal LEADER Partnership CLG have been approved to deliver the new Programme.

ENTERPRISE CENTRES

Fingal's Enterprise Centres continue to participate in ConnectedHubs.ie.

ConnectedHubs.ie is a one-stop-shop for remote working hubs throughout Ireland.



All three Enterprise Centres have space available to start-up businesses and businesses/ individuals who wish to avail of remote working options and facilities. Bespoke options or generic office fitouts can be considered.

Occupancy rates at the Council's three enterprise centres are all over 90%. The three Enterprise Centres currently support 65 businesses and over 320 direct jobs.

Demand for the new Remote Working Hubs in BASE and Beat remain strong following the Connected Free Voucher Scheme run in 2022.

Fingal County Council was approved for €50,000 in new funding to promote Remote Working Hubs in the County under the Town and Village Renewal Scheme Marketing Measure. A cross-departmental team within the Council is implementing initiatives to promote Fingal as a Remote Working Hub base for remote workers.

Drinan Enterprise Centre is promoting the availability of a bespoke media studio facility available for immediate booking to all individuals, groups and business interests.



<u>TOWN REGENERATION</u> Our Balbriggan 2019 – 2025 Rejuvenation Plan – A Socio-Economic Strategy



The Our Balbriggan Programme Office continues to support the Leadership Group and its five pillars, who meet regularly, to progress work across a range of economic and social measures including: Growing the Local Economy, Public Realm & Infrastructure, Education, Skills & Employment, Community Integration, Health & Well Being and Community Safety. The Balbriggan Leadership Group, which is chaired by Professor Brian MacCraith, met on October 18th to officially begin the process of mid-term review of the Our Balbriggan Programme, its delivery timelines, governance and the realignment of the programme to the national URDF funding timeframe 2024 – 2030.



As part of the review of the programme, a combined workshop of the Community and Integration Pillar and the Safety Pillar was held on the 19th October.



The Quay Street, Harbour & Environs scheme is anticipated to be on site to commence end of Q1. 2024 and be completed on a phased basis in 2025. Tender request to source a suitable contractor to deliver the project were issued on e-tenders on October 9th with tender submissions due by 20th November. Irish Water are currently on site in the Quay Street Car Park to complete upgrade works on the pumping station located there, with alternative car parking currently available at Bath Road/Balbriggan & FC Bremore Castle. Communications to this effect have been issued on social media and other local channels in Balbriggan.



Part 8 Planning Permission for 2-4 Dublin Street was granted approval at full Council in October and the project will now progress to detailed design phase. 2-4 Dublin Street is to be transformed into a new Creative Hub with 8 workspaces at 2 Dublin Street and an ancillary connected space at 4 Dublin Street which will support STEAM education, training and enterprise activities supported by SMART Balbriggan and the Fingal Arts Office.



Demolition works on 14 Bridge Street (house known locally as Keelings) have been completed. Work on the installation of a temporary Pocket Park has commenced at the site. Landscaping, street furniture and fencing are due to be completed in early December. Annexes at the rear of DeBruns buildings are in the process of being demolished.

An Integrated Design Team will be appointed shortly to assist in determining the options for the long-term use and design of the site in line with site constraints. The evaluation of tenders received for this IDT is almost complete.

Donnelly Civil Engineering Ltd and MWP Engineering have delivered a package of improvement works at Balbriggan Harbour. The main Harbour upgrade works and shoreside services are almost complete, with some lighting improvements awaiting final completion further to new electricity connections.

The programme office working with the architect's department have initiated the Boathouse & Bathhouse Conservation & Sustainable Re-Use Project as part of the wider URDF Coastal and Promenade project.

Work will commence shortly on enabling Works, followed by procurement of topographical and measured buildings survey, a full ecological study and then preparation of developed design and pre-Part XI Planning proposal.



A comprehensive Balbriggan Public Realm Strategy - Masterplan & Design Guide and a Balbriggan Active Travel & Transportation plan are complete with both expected to be published shortly. The Our Balbriggan Office continues to generate regular and unique content across all social media channels, Facebook, Twitter, Instagram, LinkedIn with over 5.1k followers on Facebook.





Town Centre First – Lusk

The structure, membership and Terms of Reference for the new Lusk Town Team has been agreed. Together with the Town Team there are three Pillar Groups representing the Community, Business and Economy and Public Realm / Climate Action & Sustainability (to include Vacant & Derelict Buildings). The fourth meeting of the Town Team was held in October in Lusk Cultural Centre. A community briefing was held in early July to establish the Community Pillar which will support the Town Team in delivering a new Town Plan for Lusk with input from the local community. A local business briefing was held in July to establish the Business and Local Economy Pillar which will support the Town Team in delivering a new Town Plan for Lusk with input from the local business community.

The consultants to support the preparation of a new Town Plan have been appointed and are working with the Community, Businesses and Public Realm Pillars in Lusk to get their views for inclusion in the new town plan. Work on this progressing well, with a draft of the new Town Centre First Plan for Lusk currently being reviewed.



Town & Village Renewal Schemes

The 2023 Town and Village Renewal Scheme was launched during the Summer and the Town Regeneration Office is currently reviewing expressions of interest for the scheme, under its many project measures, in preparation for the submission of 5 applications to the Department of Rural and Community Development in early November. Details of successful project are expected to be announced in Q1 2024.



The Regeneration Office has completed the implementation of the Rush Streetscape Scheme. The Council had been approved for €100,000 in funding from the Department of Rural and Community Development for the Rush Streetscape Scheme and 30 properties in the centre of Rush have been supported with funding.

The Donabate Streetscape Scheme was launched in May and applications for this scheme were sought from properties in Donabate Town Centre. €36,000 in funding has also been approved from the Department of Rural and Community Development for this Scheme under the last Town and Village Renewal Scheme 2022. The Town Regeneration Office was successful in securing €7 million for a new revolving fund that will acquire vacant or derelict properties to renovate, bring back into use and sell back into the market for housing purposes. An initial 19 properties under this fund have been approved for purchase by the URDF Call 3 Fund / Department of Housing Heritage and Local Government.

The Derelict Sites Section which manages the Derelict Sites Register was moved to the Town Regeneration Office in August further broadening the capacity of the office to deal with town centre vacancy and dereliction. Reports for derelict sites can be made to <u>derelictsites@fingal.ie</u>.

LOCAL ENTERPRISE OFFICE



LEO Fingal provides a broad suite of support services to stimulate enterprise and enable small businesses to succeed. Some of the LEO highlights for October 2023 are as follows:

Evaluations and Approvals Committee

The Evaluation and Approvals Committee (EVAC) meeting met on 18th October and approved €123,700 in funding across Business Feasibility, Priming and Expansion Grants. Year to date €681,900 has been approved across thirty-seven applications from Fingal businesses. A further 2 Agile Innovation grants to the value of €101,000 have also been approved in 2023. The next EVAC meeting is Wednesday 13th December.

Management Development Programme



The second Leadership for Growth programme is continuing and feedback to date has been excellent. The participants are half-way through the programme and are due to complete in December with graduation early in the New Year. As part of the programme, the owner manager participants will each produce Work Based Assessments which document their businesses strategic plan and acts as a living document as well as a point in time reference for where their business is now and the actions they need to take to grow.

Fingal Business Network



The Autumn Fingal Business Network event took place at the Crowne Plaza Hotel in Santry, on 29th September 2023.

It focussed on the three "Es" which have been hot topics throughout 2023 – Employment, Ecommerce, and Expansion. Hosting the event was Noel Davidson from the Entrepreneurs Academy, who oversaw an engaging and dynamic panel discussion. Panellists included Michelle O'Keeffe from Platform55, David Butler from QBM, Sandra Hickey from Milkbath, and James Stewart from Celtic Candles. Each panel member then proceeded to share their business journey, delving into the background of their business, the challenges they encountered, their strategies for overcoming obstacles, and the driving forces that continue to inspire their perseverance. Upon conclusion, the room buzzed with animated conversations as attendees continued to network with one another where the networking continued over lunch. Fingal Business Network look forward to hosting another exciting networking event on 1st December in Roganstown Hotel.

National Women's Enterprise Day





Fingal businesswomen came together to celebrate National Women's Enterprise Day (NWED) at the Dublin regional NWED networking event on Thursday October 19th in collaboration with the four LEOs in the Dublin Region. This regional event is part of the wider national initiative, "Empower Business Together", which saw thousands of businesswomen participate in a host of women's events taking place throughout the country.

Speakers were joined by ambassadors, or "Leading Lights," from the various regions, including: Fingal's Giselle Makinde of Cream of the Crop, a pioneering food tech company dedicated to combating food waste. Giselle spoke about her experience in setting up her business, the support she got from Fingal LEO and ultimately the huge success she went on to enjoy and works hard to maintain today.

Fingal Business Briefing



The next monthly Fingal Business Briefing will run on November 14th for small businesses and entrepreneurs in the Fingal area. The briefings outline the supports and services available to small businesses and individuals seeking to start their own business, through the LEO and other state agencies. Year to date, 194 individuals have attended a business briefing in 2023.

Food Producer Showcase



Fingal hosted this year's showcase event for Dublin food producers, at the Crowne Plaza Blanchardstown on Thursday 26th October. 37 Food Producers from across the Dublin region showcased their products to over 30 key buyers from the large multiples, food service and restaurants.

The buyers were very impressed with the quality of the offerings with many engaging for follow up with orders and deals.

Energy Efficiency Grant Scheme



The first approval under the new Energy Efficiency Grant Scheme was granted in September 2023. The scheme, which is being rolled out throughout the 31 Local Enterprise Offices, will enable small businesses to invest in technologies and equipment to make their businesses more energy efficient. The grant will cover up to 50% of the costs to a maximum amount of €5,000. The goal is to reduce the impact of small businesses on the environment and help them to reduce costs to enable them to become more competitive. As part of the process, applicants complete the Green for Business Programme, a customised initiative whereby the business develops a strategy to become sustainable.

Trading Online Voucher Scheme



An initiative under the Government's National Digital Strategy, the Trading Online Voucher (TOV) scheme supports small businesses by allowing them to enhance their online offering by providing a grant of up to $\leq 2,500$ for ecommerce and digital marketing activities, as well as giving businesses a better understanding of how they can exploit E-Commerce opportunities for their business. So far in 2023, a total of 73 applications have been approved in the amount of $\leq \leq 158,925$. The next Trading Online Voucher seminar will be held online on Friday 10th November 2023

New Campaign Encourages Small Businesses to Engage with Local Enterprise Offices



The new "All in a Day's Work" campaign encourages small businesses to engage with their Local Enterprise Office (LEO) to learn about the supports available that can help them save time, money, and energy. The campaign focuses on three key areas: Lean, Green, and Digital. Attending the launch with Minister Neale Richmond was Heather Gilroy of Prints of Ireland, a client of Local Enterprise Office Fingal and Head of Enterprise Oisin Geoghegan.

Business Advice Clinics and Mentoring



LEO Fingal provides one to one business support services through Business Advice Clinics and a Mentoring programme, online and in person. The Fingal mentor panel consists of a variety of skilled and experienced mentors from a range of business backgrounds. In 2023 to date the clinics have offered one-to-one advice and guidance to 832 clients in Fingal. The Mentoring Programme continues with a total of 225 clients receiving mentoring year to date.

Microfinance Ireland Loans

LEO Fingal provides a loan scheme through its partnership with Microfinance Ireland, with loans of up to $\leq 25,000$ per approved applicant. LEO Fingal is actively promoting the availability of loans from businesses that have difficulty raising finance from their bank.

Applications are processed and assessed by LEO Fingal and submitted to MFI (Microfinance Ireland). Applications submitted through LEO Fingal are eligible for a reduced interest rate. LEO Fingal has processed and submitted 12 MFI loan applications YTD.

Training and Events

In October, there was sustained enthusiasm for LEO Fingal's training programmes, with nearly 200 individuals signing up for various programmes and seminars. The "Start Your Own Business" Courses continue to fill up quickly, and there is also a strong demand for the Social Media and Digital Marketing course, along with other finance, marketing, and sales related workshops included in the comprehensive training portfolio. In the run up to Christmas, LEO Fingal is running a special workshop dedicated to "How to Sell Food and Craft Products at Markets & Pop-Ups" which has booked out fully.

118 participants have embarked on one of 10 SYOB programmes year to date. There were a further 84 participants in the SYOB Bootcamp in Local Enterprise Week and 113 at the U-Start programme for Ukrainian nationals earlier in the year.

Internationalisation and Export Development

LEO Fingal is providing a further opportunity to small businesses that wish to develop export opportunities through its latest Export Development Programme which will commence in Q4 2023. In addition, the Exporter grant enables small businesses to explore and develop new market opportunities by providing up to €2,500 to businesses investigating and researching export markets. Export Grants have been approved for nine Fingal businesses year to date.

Showcase Ireland 2024



Showcase Ireland 2024 will take place from 21st -23rd January 2024 at the RDS, Dublin. Showcase is presented by Design & Crafts Council Ireland, Enterprise Ireland and Local Enterprise Offices and supported by the Department of Enterprise, Trade and Employment. This four-day trade show is recognised as one Ireland's largest international trade shows and offers manufacturers, designers and craft makers the opportunity to exhibit their new collections. LEO Fingal have been allocated 8 stands for this event. Following a selection process, the 8 successful applicants have been chosen to represent LEO Fingal: Stories by Ola (Skerries), Moss of the Isles (Swords), Nicola Weldon (Balbriggan), Clémence Prosen Art & Design (Balbriggan), Rob Stears Illustrations (Castleknock), Waylon & Flo (Skerries), Luxie Kids (Trading as BabyDub, Donabate). These craft & design businesses are also provided with training by LEO Fingal specifically on sales techniques for craft products who are displaying & selling their work at exhibitions.

Student Enterprise Programme

There was plenty of interest among aspiring young entrepreneurs at the LEO stand during the recent Xplore Exhibition hosted by FCC as part of the Fingal Skills Strategy. The Student Enterprise Programme featured with a theme of "Be Your Own Boss", attracting students interested in a career in entrepreneurship. The interactive LEO stand caught the eye of hundreds of transition year students and teachers who engaged in competitions and found out about what is involved in running your own business.







Licenses


Road Opening License's

The Licensing unit continues to process and manage the licensing system for the County. Applications are allocated by area for examination and conditioning which includes reviews of the existing carriageway, footpaths, cycleways, and grass verges. Applicants submit temporary traffic management plans for review to ensure all works are carried out safely within the public domain. Road Opening Licences are a cross functional process for the department and are essential for the asset management of Fingal County Council Road network.

221 Licences were granted in the month of **October**, **51%** of which were granted by way of automation. Clerk of Works in each area continue to carry out regular inspections following road opening works by Utilities.

Casual Trading License

Fingal County Council currently have 30 Casual Trading Pitches occupied throughout the Administrative Area.

Covering Hot Food/Tea & Coffee/Ice Cream and Flowers.

Fingal County Council is currently in communication with several interested parties who are interested in taking up additional pitches throughout the county, site inspections have been arranged.

The Castleknock/Mulhuddart Operations Department is in regular communication with our traders and area inspectors to assist in delivery of quality service and ensure compliance.

Street Furniture Licences





Fingal County Council currently have 34 valid Street Furniture Licence's throughout the county: 1 in Castleknock/Mulhuddart, 6 in Balbriggan/Swords and 27 in Howth/Malahide, this is a significant increase on previous years.

We are currently in communication with several applicants regarding the issuing of new SFL licences, pending site inspections in the coming weeks.

Castleknock/Mulhuddart Operations department have now fully completed refunds in accordance with S.I. 256 dated 22 of May 2023 for all Street Furniture Licence Holders in the area following engagement with the businesses.

Storm Water

Stormwater Capital Programme 2023-2025

Fingal County Council are continuing to progress projects adopted in the 2023-2025 Stormwater Capital Program. The 3-year program includes 14 projects initially valued at approximately €3.63 Million, although this is being kept under review. Below is a brief update in relation to the current status of some of the projects that have commenced and planned upcoming projects.

- Howth Stormwater Culvert

Topographical and Manhole Surveys are complete and satisfactory. Awaiting clarification and details from flow and CCTV surveys. Optioneering and Investigation Report is in progress. Preliminary design reports being updated with received survey information and updates of associated drawings.

- Bath Avenue Storm Water Pipe

This project involves the laying of a new Stormwater pipeline along Bath Ave in Malahide to alleviate localised flooding and allow for future capacity. Construction works started on 25/09/2023. A 10-week window has been allocated for the works which requires a full road closure. To date 135m of pipe has been laid, the existing network on Grove Road has been connected to the new network, 6 new gullies have been installed and 4 new manholes have been constructed.







Ongar Development Stormwater Remedial Works

Remediation works on the drainage network in Ongar following its Taking in charge are substantially complete. Additional works were identified flowing inspection by the Drainage section. The works are being undertaken by Formac Contractors with design and supervision by OCSC Consulting Engineers with an initial duration of five months starting in April 2023. The additional works should be complete by Mid-November.

Storm Water Maintenance

To support the Storm Water Preventative maintenance, a contractor has been procured with a Jet Vac Recycler truck and CCTV camera van. Survey works are ongoing in the in the Blanchardstown & Castleknock areas.

The Stormwater manhole cover and frame replacement programme for replacing assets at the end of life is ongoing. Assets have been replaced in Sutton, Howth Main St, The Naul and Balbriggan.

Following discussion with the Biodiversity section and Environment Department, safety concerns led to the partial removal in October of the **Portrane SW Outfall** which had suffered damage from recent storms. Care was taken to reinforce with rock armour a key upper section of intact pipe which serves to prevent sand drift.





Additional CCTV surveys are being carried out in **Rusheeney and Manorfields** estates to determine the Storm Water network condition ahead of works planned in November. These works will include of trenchless techniques and robotic cutting.





A contractor is being procured to undertake various remedial works including part-liner repairs on damaged sections of the storm water network along **Carpenterstown Rd** in Castleknock.

Following recent reports of road flooding along **Treen Hill & Minister's Road**. CCTV surveys were carried out and restrictions in the network around Kilhedge Lane have been identified. The results of these surveys are now being analysed to determine what steps are required to resolve the issue.





Jetting and CCTV surveying are ongoing in the **Ballykea and Loughshinny** areas to determine the cause of flooding following recent heavy rainfall.

Separation of a section of misconnected Storm water line from the storm water network in **Flemington Park, Balbriggan** was completed in October. This involved its diversion via a new manhole and the redirection of several road gullies to reduce the risk of odours. This work effectively removed a significant source of foul contamination from the catchment thus eliminating one of the risks to coastal and local bathing areas.





- Biodiversity

Ongoing assistance is being given by the Storm Water Unit to *Baldoyle Tidy Towns* who have secured funding for a Biodiversity project on the **Seagrange Park** stream, Baldoyle.



Storm Water Connections: To date 13 new connection applications have been processed in 2023.

Planning Applications

There have been 1038 planning applications received from 1st January 2023 to 30th September 2023, of these 137 applications were invalid leaving a total of 901 valid applications. The volume of applications received by Local Electoral Area (LEA) is detailed in the table below.

From 1st January 2023 to 30th September, nine Large-scale Residential Development (LRD) full applications have been made to the Local Authority. From 1st January 2023 to 30th September 2023 eleven decisions have been made on Large Scale Residential Developments. Of these eleven decisions made, ten have been to grant Permission (3,211 Units) and one decision has been made to request further information.

An Bord Pleanála have issued 17 decisions (4 Refusals & 13 Grants -5709 units) on SHD applications in the period from 1st January 2023 to 30th September. There are five SHD's (4,577 units) remaining with An Bord Pleanála for decision.



Planning Decisions

A total of 913 planning decisions have been issued to 30^{th} of September 2023. There have been 752 decisions to grant permission (83%) and 161 refusals of permission (17%). Included in the 752 grants there have been 60 grants of permissions in respect of single house construction, 417 grants of permission for domestic extensions/works, 65 commercial/retail grants of permission and 38 grants of permission in respect of housing developments of which 20 relate to development of 2 – 20 units, 6 relates to 20 – 50 units, 7 relate to 50 -100 units and 7 which relate to development of 100+ Units.


Building Control Admin

In September 2023, there were 150 building control submissions made via BCMS.

This was made up of 77 Commencement notices, 33 Compliance of Completion Certificates, 24 Fire Safety related Certificates and 16 Disability Access related Certificates.

Commencement notices and Compliance on Completion Certificates are submitted through the Projects module on BCMS. Fire Safety, Disability Access, Regularisation and Dispensation/Relaxation Certificate applications can be submitted online via the Applications module on BCMS and the Council accepts hard copy applications directly into the office. Most applications are now being submitted via the online system.

The Building Control Admin team processed 116 decisions in September 2023 relating to Fire Safety and Disability Access Certificates. This was made up of 35 decisions to grant and 81 extensions of time.



Strategic Policy Unit

Local Area Plans, Masterplans and Framework Plans

In July, the first round of Plans falling out of the development plan was agreed. This comprises Swords and Flemington LAP's, the Dunsink Plan, Kilbarrack and the Old School House Masterplans and the Stephenstown, Folkstown and Clonsilla Framework Plans.

Consultants have been appointed and work will begin on Flemington LAP immediately. This will be the first LAP. Consultants are due to be appointed in the next two weeks and work will start on the Clonsilla framework plan.

The Draft Donabate Framework Plan is almost complete and will be published this month, subject to the outcomes of the environmental assessment consultation which is ongoing.

Residential Zoned Land Tax

The Government's 'Housing For All – A New Housing Plan for Ireland ' proposed a new tax to activate vacant land for residential purposes as a part of the Pathway to Increasing New Housing Supply.

Draft Map Submissions:

- Number of submissions received on Draft map 121 submissions - 142 land parcels in total
- Number of rezoning requests 3
- Number of sites removed from the Draft map 26 removed, 3 part removed
- Number of sites retained on the Draft map 97 retained, 9 part retained
- Number of sites whereby there was 'no action' (residential property for example) – 7
- > (no action) 6 (part no action)
- > Number of appeals lodged to ABP 83
- Number of appeals decided (31st October 2023) 82, of which 71 confirmed the determination of Fingal.

The final map is due to be published on 1st December and this will identify all of the land considered to be in scope for FCC and will provide for the overall area in hectares. The RZLT was due to be due in 2024 but this has been deferred for a year. The draft for next year has to go on display on 1st February next year.

Built Environment Division

Building Control/Taking in Charge Section - 31/10/2023



- There were 16 building Control Inspections in October 2023 with 30 buildings inspected.
- There were 8 section 11 requests for further information following building control inspections, issued in October and there have been no enforcement notices issued.
- There were 2 roads taken in charge in the council meeting of the 9th October 2023 (Cnoc Dubh Phase 2 and Millers Glen Phase 2).
- There is 1 development up for taking in charge in the November Meeting (Cois Sruthain).
- The Ongar Remediation works contract is still ongoing and Formac Construction are currently carrying out works in Ongar Village. O'Connor Sutton Cronin are managing these works on behalf of Fingal County Council. The completion works have been further pushed out until the end of November to address Irish water works. We have also engaged Formac and O'Connor Sutton Cronin to carry out the remediation works in Mount Eustace and Cruise Park to bring these estates to a taking in charge standard. These works will follow on from the Ongar remediation works and will take approximately 2 months.
- Works are ongoing in the Gallops housing estate by a contractor carrying out "Taking in Charge" works for Fingal County Council.

Dangerous Structures

There was 1 dangerous structure notified in September 2023 and 2 dangerous structures notified in October 2023. There are a total of 87 dangerous structures active in our database.

 Sustainable Drainage System (SuDS) – The Fingal SuDS guidance document (Green/Blue Infrastructure for Development) has been reviewed to include changes in technical standards. This document along with the SFRA documents have been incorporated into the new development plan.



Incorporating Sustainable Drainage Systems in Residential Developments



The GDSDS has outlined SuDS as a sustainable way to manage surface water as we prepare to meet the challenges of climate change. This example of Millers Glen in Swords, shows an example of surface water being held onsite, providing treatment via appropriate planting, and then discharging at greenfield runoff rate. This is a move away from the traditional method of collecting all surface water via piped systems which can often no longer manage the intense rainfall`s being experienced.

Transportation



Staff from the P&SI - Transport Planning recently visited two Active Travel projects in Dublin City Council, the Royal Canal Greenway (Phase 3) & Clontarf to City Centre which are both currently onsite at Construction Stage.

The site visit allowed staff to gather learnings from the projects and knowledge sharing with colleagues in Dublin City Council.

Snugborough Interchange upgrade

The Snugborough Interchange is currently programmed to be completed during Q1 2024, as we have included additional elements in the scheme such as repairs to the access to Waterville Park and a new artwork in the underpass. Some traffic management will be required over the coming weeks to allow for resurfacing works. Resurfacing of the N3 off ramp will be carried out overnight at the end of November. A site visit for local councillors was arranged for the 24th of October. Updates will be posted on the scheme web site <u>www.snugboroughinterchange.ie</u>



Ongar Barnhill Link Road

Bam Civil Ltd. have commenced setting up a site compound and have carried out preliminary works in advance of the main works. Updates for the scheme will be posted on <u>www.fingal.ie/ongarbarnhill</u>

PSI-039 R132 Connectivity Project

Consultation with the National Transport Authority and with Transport Infrastructure Ireland regarding the connection with Metro Link is ongoing with Monthly meetings. The findings from the ground investigation works carried out in June and July was compiled and now will assist in the decision-making process for the detailed design stage. Meetings with a developer on a new access onto the R132 has also taken place. Modelling the impact of this junction is currently being undertaken. Detailed design stage is underway and progressing as programmed.

PSI-005 Harry Reynolds Road Pedestrian and Cyclist Route

Construction works is progressing on the Harry Reynolds Road Pedestrian and Cyclist Route for this key infrastructure project for Balbriggan. The work is ongoing at three locations on the project on Hamilton Road, Harry Reynolds Road just south of the R122 and at Moylaragh Road. Works is progressing with a new bus stop and a new shared area already installed on Hamilton Road. Another meeting has been arranged for December in relation to progressing the art installation piece has also taken place recently with Fingal's Art Officer, Local Councillors, Tidy Town Committee members and Our Balbriggan to progress the process of developing a theme and guidance's on commissioning of the art installation. Additional meeting with the ESB in Oct onsite with agreement reached on new connect point at 12 Controlled crossing points along the project. Also, relocation of existing ESB cables has been agreed on Harry Reynolds Road.





Consultancy Framework for Dublin 15 Walking and Cycling Projects

The Planning & Strategic Infrastructure Dept has commenced the procurement process for a Single Party Framework for Engineering Consultancy Services for Pedestrian and Cycling Route Projects in the Dublin 15 Area, with a closing date in late October 2023. The evaluation of submissions received as part of the stage one process will then be assessed in November to determine which firms will proceed to the stage 2 procurement process in Q1 2024. Proposed projects will include the Clonsilla-Damastown Cycle Route and Pedestrian & Cycling Bridge at Granard Bridge Castleknock.

PSI 063 Granard Bridge

A tender brief is currently being prepared for a Pedestrian and Cycling bridge over the Maynooth Rail line and Royal Canal at Granard Bridge on the Castleknock Road and will form an integral part of the walking and cycling route for Blanchardstown to Phoenix Park which is a proposed route in the NTA's Greater Dublin Area Cycle Network Plan. The tendering for this project will form part of the initial project for the Engineering Consultancy Services Framework for Dublin 15 Pedestrian and Cycling Route Projects which is currently at stage 1 of the procurement process.

PSI – 004 Royal Canal Urban Greenway

Dialogue continues to be held with landowners and with key stakeholders the National Transport Authority and Waterways Ireland along the route of the greenway to ensure a coordinated, high quality final design is achieved at interfaces between existing facilities and the proposed scheme. Landowner searches and land referencing are ongoing also. Following this process, the required documents including the Environmental Impact Assessment Report will be prepared for a planning application to An Bord Pleanála in mid 2024.

S2M Pedestrian and Cycle Scheme

The preliminary design drawings are being finalised. The recently published Cycle Design Manual has led to some improvements being incorporated into the overall scheme design. The new manual draws on the experience of delivering cycling infrastructure across Ireland over the last decade, as well as learning from international best practice, and has been guided by the need to deliver safe cycle facilities for people of all ages and A surveyor has recently completed abilities. topographical surveys of public and private lands within the proposed scheme. Ground Investigation Works will be required along the route at all locations where new structures are being proposed.

A tree surveyor will be procured in the coming months and a survey of all trees along the proposed route will be carried out. Following this process, the preliminary design can be finalised and documents will be prepared for a planning application to An Bord Pleanála. Engagement with potentially impacted property owners, businesses and stakeholders is ongoing.



Kinsealy Walking and Cycling Routes

The consultancy framework for various Swords & Kinsealy projects with the initial project being the Kinsealy Walking and Cycling Routes was recently awarded to Barry transportation. The appointed consultants are currently progressing the Kinsealy Walking and Cycling Routes Projects. The Options Selection phase is progressing on two routes, Kinsealy Lane and Chapel Road/Station Road to determine the draft preferred routes. A survey has been procured to carry out traffic surveys. In addition, a surveyor has been procured to carry out topographical surveys. Briefings will be undertaken with the local members at the next milestone stage. Non-statutory stakeholder consultation which will include road users will be targeted for 2024 whilst targeted stakeholder consultation, for example with potentially affected landowners, will be undertaken as needed.



Fingal Coastal Way

Liaison with landowners and residents' groups along the route of the Fingal Coastal Way is ongoing. Appointment of a contractor for the topographical survey of public lands should be completed in the coming weeks. This survey will allow design in the town and village centres to be progressed. Affected landowners with farming and horticultural businesses will be informed in the coming weeks with regard to the appointment of the scheme agronomist, at which point further liaison meetings will be held along the route. Searches continue for potentially affected landowners who have not been identified yet.

Broadmeadow Way Greenway

High level design options for the northern causeway are being developed using recently acquired ground investigation data from the ground investigation (GI) contract conducted over the summer months. These options will then be workshopped with Irish Rail to seek approval to proceed with single preferred design option that meets the project objectives and ensure the safety and integrity of the railway causeway.

A tender competition for the 12-span 180m long precast bridge deck units has gone out to market, the long lead in time is required to align with the approved May-September construction window in 2024 following the overwintering bird season. Stage 1 (SAQ) construction tender documents for a Works Contractor for the Donabate landward works are being finalised and will go to the market in November, this work package will include two additional bridge structures spanning across the Pill River and greenway works through Kilcrea farmland and the Kilcrea junction at Newbridge.

The Underwater Archaeology Unit in the Department of Local Government and Heritage have requested that Fingal County Council undertake an underwater archaeology desktop assessment as part of planning and foreshore commitments, the tender pack for this piece of work has been developed and will be issued to market in November.

In late September, the Planning and Strategic Infrastructure project team arranged a site visit for local councillors to the southern causeway and bridge site. This was facilitated by Irish Rail.



Church Fields Link Road

Works are continuing on phase 2 of the Church Fields Link Road and Cycle Network project, including the upgrade and reconfiguration of the existing Wellview Avenue and the installation of 670m of high quality pedestrian and cycling facilities through the eastern parklands linking up with existing networks and future proposed facilities in the vicinity.





PSI-026 Turvey Avenue & Portrane Road

Fingal County Council has lodged an application to An Bord Pleanála for a Compulsory Purchase Order (CPO) for the Portrane Road Enhancement Project and two landowner objections have been lodged with ABP in this regard. The project involves works to widen the existing narrow footpath on the northern side of Portrane Road in order to provide a suitably wide and safe footpath for pedestrians to use in the vicinity of two national schools (St. Patrick's Boys National School and Scoil Phádraic Cailíní). The project also involves works to provide safe pedestrian crossings and appropriate traffic calming facilities. Subject to approval from An Bord Pleanála, the CPO will allow Fingal County Council to purchase privately-owned land that is required to widen the path and deliver the project. A decision from An Bord Pleanála on the CPO application is expected later this year.

Separately, Fingal County Council has undertaken a tender competition to procure a works contractor to build a Footpath Enhancement project on nearby Turvey Avenue, in Donabate. The project will see the construction of a new section of footpath to improve pedestrian safety and increase connectivity for people walking between Donabate Village and the residential areas along Turvey Avenue, west of Donabate Train Station. A works contractor is expected to be appointed in November with construction work due to commence in early 2024.

PSI-027 Donabate Pedestrian Bridge

The detailed design for the construction of a new pedestrian and cycle bridge over the Dublin to Belfast Railway line at Corballis, Donabate has been approved by larnród Éireann and the Commission for Railway Regulation. The new bridge will cross over the railway line, facilitating a safe and segregated pedestrian and cycle route and will enhance connections between the development lands at Corballis, Donabate Village, the railway station and Newbridge Demesne. Heads of terms have been agreed and necessary licence agreements are being finalised with the developers of adjacent lands to facilitate access to, and construction of, the bridge. Procurement for a main contractor for the works is ongoing and construction is expected to commence in Q1 2024.

Donabate Transport Projects

Fingal County Council has appointed Roughan and O'Donovan, a leading multi-disciplinary consultancy firm, to provide engineering, planning and environmental services for the Donabate Transport Projects, which comprise a number of major projects with the objective of improving transport and active travel infrastructure and road safety on the Donabate-Portrane peninsula. The projects include:

- Phase 2 of the Donabate Distributor Road project, to improve access to Donabate and Portrane from the M1-Lissenhall Interchange for all road users, particularly vulnerable road users such as pedestrians and cyclists;
- Blakes Cross Junction Upgrade, to provide a safer junction layout that caters for both motorised traffic and active travel modes of transport such as walking and cycling;
- A study of the M1-Lissenhall Interchange, in collaboration with TII, to assess all technical and operational traffic issues associated with this strategic motorway junction;
- Donabate Active Travel Routes which encompass a number of related local projects which aim to increase local connectivity for pedestrians and cyclists.

Work on the initial data-gathering, concept development and option assessment stages of the Donabate Transport Projects is underway. Further stages of work, relating to environmental assessment, planning consent, etc. will follow on in subsequent years as appropriate.

Energy Efficiency/Retrofitting Programme

Fingal County Council's Energy Efficiency Retrofit programme is progressing well. Work has been completed on 96 properties to date in Strandmill Estate, Barnewall Estate, Rivermeade, and Glasmore Court. Works on a further 24 properties are currently underway in Strandmill Estate, Rivermeade, Glasmore Park, and Whitestown Gardens.

Investigative works are ongoing in several other housing estates across the county to include them in this program.

Planned Maintenance Programmes

Cyclical Maintenance - Scheme Painting

The Scheme Painting Programme provides for external painting and joinery repairs to Council housing stock and currently operates on a 6/7-year cycle. Works are reaching completion in Corduff Avenue, Corduff Gardens, and Corduff Way and are ongoing in the remainder of Corduff i.e Corduff Close, Corduff Cottages, Corduff Crescent, Corduff Green, and Corduff Place. Works have commenced in Domville Woods.

Housing Assistance Payment (HAP)

HAP continues to be the primary source of rent support for those in private rented accommodation. Fingal County Council has set up over 295 new tenancies in 2023 to date with approximately 3884 tenancies set up since HAP began in 2017.

The HAP team is on hand to deal with any queries from applicants and landlords in person at the Housing Department in the Fingal County Council Blanchardstown Office, by phone at 01 8905000 via the CCU or through email at hap@fingal.ie.

Rents

The new rent review process continues, and tenants are required to return their Rent Assessment Form with the relevant documents so that an assessment can be carried out and the correct rent charge applied to the account.

The Rent Arrears team is working methodically through accounts in substantial arrears to encourage tenants to engage with the Council in reducing their arrears. In cases where there is no engagement, despite repeated efforts, proceedings will progress through the legal arena, and to date, the Rents Section has secured two Possession orders with 6 others currently before the courts. Regarding the two possession orders secured, both tenants are engaging with the team to address their areas.

The Rents team encourages any tenant who is having trouble paying their rent to engage with the Council to examine possible solutions. However, there are instances where tenants do not engage or make alternative payment arrangements, and, in those situations, the Council needs to take further action.

Local Authority Home Loan

The Local Authority Home Loan (LAHL) continues to be popular among people who are unable to secure funding from commercial lenders to allow them to purchase a home.

The loan application process has been augmented by updates to our online loan application portal which has been upgraded in recent weeks to allow for easier submission of documentation and clearer information on what is required. Applicants can still submit a loan application and required documentation by post if they wish to do so. Since the LAHL was introduced on 4th January 2022, 127 Fingal applicants have received Loan Approval in Principle (AIP) with a cumulative AIP of 28.4m.

Private Rented Inspections

For 2023, following the rollout of annual registration by the RTB and a project to streamline registrations, the target for 2023 is set at 4,576, equating to just over a quarter of 18,000 registered tenancies within Fingal.

The team successfully reached 100.42% of the 2023 target by the end of quarter three. 5451 inspections took place across a total of 4595 dwellings.

The team continues to work with the contractor for the last quarter of the year to focus on improving compliance.



An email address has been established to facilitate the submission of appeals about housing support applications by applicants e.g., closure of social housing applications, transfer of tenancy, income limit queries, medical priority, and transfer applications. Housing Needs Assessment

Following Circular 26/2023 as released on 5th July 2023, the Summary of Social Housing Assessment (SSHA) is due for return to the Department of Housing Local Government and Heritage by 29th November 2023. Letters Issued to applicants on 15th September to all applicants required to complete the SSHA. Following the successful launch of the Online HNA System in 2022, applicants have been advised to complete the assessment where possible online. This system went live on Monday 18th September 2023 with initial uptake positive.

Reminder letters were issued to all applicants on 4th October. Applicants were advised in this letter, that if they have completed their assessment online, they don't need to take any further action. All SSHA received are undergoing a process of checking and assessment with requests issued for further documentation where required through the Portal. All facilitates remain available to applicants at the Customer Care Counters and in the Fingal Libraries for those individuals requiring assistance in completing their Housing Needs Assessment.







Lettings

The chart below depicts the total number of properties allocated since the beginning of 2023. 271 of these allocations have been in collaboration with several Approved Housing bodies. The other 341 properties were allocated using Fingal County Council's stock.



Of all the 612 allocations made to date, 221 were made via Choice Based Lettings.





This chart portrays a breakdown of the AHB, reflecting the nominations sent to them during 2023 thus far. Tuath received the most nominations from Fingal County Council in 2023. The collaboration between Local Authorities and Approved Housing Bodies is continuing to have a positive impact on the delivery of social housing.

Tuath Approved Housing Body and Fingal County Council's leasing section have taken delivery of 159 properties in Hansfield Dublin 15. A number of these properties were advertised via Choice Based Lettings and the lettings team is actively working on files for allocation.



Circle Approved Housing Body are managing 47 units in Donabate, North County Dublin, comprising 2, 3 and 4-bed properties.

Homeless Exits 2023

During October 2023, 21 households exited homeless circumstances into various forms of social housing support - including privately rented tenancies under the Homeless HAP Scheme.


Allocations to social tenancies account for 1 household, comprising 1 who exited emergency accommodation.

Homeless HAP accounts for 20 of these tenancies, comprising 14 homeless preventions and 6 who exited emergency accommodation.

Therefore, there were a total of 14 homeless prevention cases and 7 who exited emergency accommodation.




Homeless Presentations

Fingal's Homeless Team continues to engage with those experiencing homelessness to offer advice and support. Homeless Assessments continued to be carried out.

In October 2023, there were a total of 42 full homeless assessments completed – comprising 23 families and 19 singles/couples.

To date in 2023 there have been a total of 424 full homeless assessments completed.



During October 2023, of the 42 Homeless Assessments carried out, 25 cases resulted from a Notice to Quit (NTQ) having been served, equating to 60%.



Renting a room or licensee presenters are not protected by the Residential Tenancies Act and accounted for 5% of assessments during October 2023.

There are also a considerable number of people making contact stating that they are Homeless due to family breakdown (19%).

Most of the other presentations to the Homeless Section are from living in overcrowded conditions (5%) and state that they cannot/will not return to the property.

The remaining 11% comprise various reasons outlined in the chart below.



Emergency Accommodation (including Fingal County Council Family Hubs)

There continues to be a high demand for Emergency Accommodation across the region for both families and individuals.

Rough Sleepers

The Homeless Services Team continues to liaise with the DRHE Outreach Team regarding any reports of rough sleeping, to establish their names and circumstances and to offer support. Regrettably, some rough sleepers are reluctant to engage with service providers and may refuse offers to access emergency accommodation. Any rough sleeper who is willing to engage with the Outreach Team and/ or the Council or will be assisted.

The Council will carry out homeless assessments and every effort is made to encourage them to avail of homeless services.

A weekly Rough Sleepers Coordination Group monitors the reports of rough sleepers. The reports come from various outlets, including the DRHE Outreach Team, Elected Representatives, the FCC Operations Department, and the general public.

The progress of these cases is monitored until the needs of the reported rough sleepers are met and the cases can be closed.

Cold Weather Strategy 2023/24

In the event of cold weather or any emergency event in Dublin, the Dublin Region Homeless Executive (DRHE) coordinates the response to homelessness on behalf of the four Dublin Local Authorities. To meet the increase in demand for homeless services and have the appropriate contingency plans in place for cold weather conditions, the DRHE is activating the Cold Weather Strategy 2023/24 in the Dublin Region. The Cold Weather Strategy focuses on expanding the current capacity to meet the increasing demand for emergency accommodation whilst also providing a targeted response for people who are long-term rough sleeping.

Increase in emergency accommodation for singles/couples

In partnership with DRHE service providers, capacity for singles and couples has been increased and these beds will be available on a phased basis throughout the winter months. As these beds come on stream, they will be made available as needed, depending on the demand for homeless services on any given night.

Equally, they will provide vital capacity if an extreme weather event occurs. For all households assessed by an LA as requiring access to temporary accommodation, all residential services now operate on a 24-hour basis, with meals provided on-site and/or cooking facilities. The total additional capacity is 330 permanent beds and 40 extreme weather beds. The permanent beds are operated on a 24-hour basis with meals provided on-site.

Enhanced services operational during cold weather conditions

DRHE services operate throughout the year to support people who are sleeping rough. During the cold weather period, services are enhanced to mitigate the health risks that cold weather poses. The cold weather provides opportunities for more assertive engagement with long-term, entrenched rough sleepers and hard-to-reach groups, aimed at placing them in appropriate and long-term accommodation. Enhanced services operating for this cold weather period include:

- Dublin Street Outreach service provided by the Dublin Simon Community. The team provides a service 7 am – 1 am Mon- Fri and 9 am – 1 am Saturday and Sunday.
- The Outreach Mobile Health Clinic, operated by SafetyNet and funded by the HSE, delivers services two nights a week (Tuesday & Thursday) and every second Friday morning with the Dublin Outreach teams, to support rough sleepers with complex medical needs. This Outreach clinic offers a comprehensive primary health care service targeted at people who are experiencing homelessness in Dublin.
- The DRHE, Dublin Simon Outreach Team, Housing First, the HSE and An Garda Síochána will continue to work closely together during the winter period with the same goal of improving outcomes for people who may be sleeping rough.
- The DRHE has 40+ emergency beds that can be activated during extreme weather conditions or adverse events.

The DRHE in partnership with Dublin Simon Outreach and the PMVT Intake team are assertively working on the streets offering accommodation to all rough sleepers. The teams are very familiar with the locations of people sleeping rough across the Dublin Region and persistently work with individuals to support them into emergency accommodation. This process can take time and multiple contacts, as some people do not want to engage but the teams persevere with every person working to achieve a successful outcome.

The service operates 365 days a year, until 1 am. The Outreach Teams also ensure that people sleeping rough are linked with other appropriate health services such as addiction and mental health services to prevent further rough sleeping. PMVT's Housing First Intake team links rough sleepers to permanent accommodation with longterm support.

All emergency accommodation is now 24-hour, with food and shower facilities provided.

Homeless Action Plan 2022- 2024

The DRHE, with the approval of all 4 local authorities in the Dublin region, has finalised the Homeless Action Plan Framework for Dublin 2022-2024. This Plan is the first plan to be put into operation since Ireland signed the Lisbon Declaration on combatting homelessness in June 2021, which aims to end homelessness by 2030.

It will follow on from the previous Homeless Action Plan for 2019- 2021 and continue with the three key themes of **Prevention**, **Protection and Progression**.

The Plan was developed based on a detailed consultative process including submissions from various Stakeholders, interested organisations, Service Providers, Members of SPCs of the four Local Authorities, the Dublin Joint Homelessness Consultative Forum, and the Statutory Management Group.

Preventing Homelessness, Notices to Quit and Tenant In-situ Acquisitions

Fingal County Council is aware that households in the Fingal area who may have received a notice to quit, which is also referred to as a notice of termination, from their landlord may be worried or unsure of what to do.

Fingal County Council and the Dublin Regional Homeless Executive (DRHE) would like to advise anyone affected of the services that are available to them in these circumstances.

We strongly encourage tenants residing in the Fingal area, who have been issued with a notice of termination, to contact Fingal County Council as soon as they receive a notice from their landlord. The contact details for Fingal County Council are provided at the bottom of this page.

When the tenants contact Fingal County Council, staff in the Housing Department will take note of the termination date.

The Council advises the tenant to refer the notice to Threshold, a service funded by the DRHE to provide a Tenancy Protection Service for private renters in the Dublin Region, including Fingal. Threshold can also be contacted directly on Freephone 1800 454 454 or via their website <u>www.threshold.ie</u> which contains more information and advice on the validity of your notice.

The Council's first response will be to try to prevent homelessness. This includes assessing the person's position on the social housing list, providing advice on applying for Choice Based Lettings, advising the person on the level of Housing Assistance Payment (HAP) they may be eligible to receive, and, in some cases, assessing if the Council can acquire the dwelling where the tenants reside if it is being offered for sale.

Placement in emergency accommodation will be a last resort if no other alternative can be identified.

The Council has been engaging with tenants who have been issued with a notice of termination, as well as their landlords, and following assessment, 29 tenant in-situ properties are at the sale closed stage. A total of 104 properties are at the sale agreed stage with a further 63 cases in the negotiation process. In addition, the Council is assessing a further 304 queries concerning notices of termination and tenant-in-situ acquisition.

The Council will continue to deal with notice of termination queries and cases as expeditiously as possible and progress tenant in-situ acquisitions while taking account of circulars and guidance issued by the Department of Housing, Local Government and Heritage.

Fingal County Council continues to liaise with other Dublin and neighbouring local authorities to deal with tenancy issues that may require an interauthority approach. In particular, we are working closely with our colleagues in the other Dublin Local Authorities on the implementation of the Government policy and guidance, with a focus on the needs of tenants.

Whilst the Council will, in the context of current circumstances, adopt flexibility in dealing with potential acquisitions of properties with tenants in situ, any acquisition is subject to appropriate due diligence and checks before any commitment is made to acquire, including, for example, determining that a valid notice of termination is in place, the tenant has a social housing need, and the condition and valuation of the property.

The Government has put forward options to allow tenants who are not eligible for social housing to remain in their homes, including schemes to support the purchase of homes and a Cost Rental in-situ Scheme. The Cost Rental Tenant-in-Situ Scheme is available for tenants who are not eligible for social housing and are at risk of homelessness. The DHLGH has advised that local authorities are to be the first point of contact for this scheme, but it is managed by the Housing Agency. Under the scheme, the Housing Agency can purchase a property and rent it to the tenant. Fingal County Council will undertake an initial assessment of the tenant's circumstances and refer details to the Housing Agency for consideration, where the tenant is at risk of homelessness and the Cost Rental Tenant-in-Situ scheme applies. The Housing Agency will then contact the landlord about the purchase of the property.

Where a tenant wishes to purchase their home from the landlord, local authorities can provide advice about the Local Authority Home Loan scheme. The Government is examining implementing a 'right of first refusal' for tenants to purchase their homes, as well as expanding the First Home shared equity scheme. The Council will be able to provide more information on these when available.

Works around preventing homelessness, assessing notices of termination, and responding to tenant and landlord in-situ queries are being led on by the Council's Homelessness section, taking a tenant-centred approach, supported by staff dedicated to dealing with tenant in-situ housing acquisitions. 

The Council's Fingal Ukraine Response Forum chaired by the Mayor continues to meet regularly to coordinate the response of the various statutory agencies and voluntary groups in the county to assist the Ukraine community. The next meeting is on the 23rd November 2023.

Liam Rodgers Rest Centre

The centre is presently operating at full capacity utilised for new arrivals to the country with various statutory agencies linked with the centre to provide support to the new arrivals. Supported by the Council and the Peter McVerry Trust (PMVT), **319 persons** have moved from the rest centre to OfferAhome\pledge accommodation across the county and country since 2nd November 2022 with arrangements finalising concerning further moves to OfferAhome\pledge accommodation.

OfferAhome\Pledge Accommodation

In the Fingal area, all suitable properties offered are occupied. The monthly recognition payment is **€800** per month for vacant properties and **€800** to host a Ukraine person in your home. To pledge accommodation, please visit the national portal at <u>https://offerahome.ie</u> or for enquiries, e-mail <u>offerahome@fingal.ie</u>.

Vacant Homes

Three dwellings are currently advancing through the CPO process, one of which has a large associated site. An Bord Pleanala has confirmed that the CPO is to be operative concerning 2 of these properties.

A further two vacant properties have recently gone sale agreed upon under the Buy and Renew scheme.

The Croí Cónaithe Refurbishment Grant Scheme is also in utilisation to address vacancy and assist citizens in getting a home with increasing enquiries, applications, and grant approvals.

Croí Cónaithe Vacant Homes Refurbishment Grant

On the 1st May 2023, the scheme was further extended with the eligibility criteria now allowing for properties built pre-2008 to qualify and grants increasing to \leq 50k (vacant) and \leq 70k (vacant and derelict). The scheme now also allows for a grant for approved properties to be rented on the private market when refurbishment is complete. Before the recent change, the grant-approved property had to be the principal private residence of the grant-approved owner.

To date, **78 applications** have been received under the scheme, **37 of** which have been approved with other applications moving to the approval stage. In addition, staff are engaging with numerous other expressions of interest which have the potential to lead to further applications.



Promotion of the scheme is ongoing by the Vacant Homes Team who have been present at various Housing Information Events most recently the event held in the Carnegie Court Hotel, Swords on the 25th of September 2023.

Community Development Office

Community Development

Community development is a process where community members come together to take collective action and generate solutions to common problems. Community wellbeing, economic, social, environmental and cultural challenges are often solved through collective action being taken at a grassroots level. Community development ranges from small initiatives within a local group to large initiatives that involve the broader community.

Building community capacity, strengthening community participation, and involving people in decisions that affect their lives is a complex process and can only be achieved by working with local communities and agencies who have responsibility to the people in those communities. In October/November the Community Development Office worked in partnership with a number of community groups and partners to support many projects/Initiatives including;



Flemington Hub Primary Healthcare Outreach Clinic

Lusk Ladies Shed

Working with the local community officer since their beginning, the group have started a 6week tutored Introduction to Ukelele course for 10 of their members. Cross Border Intergenerational Initiative: Sharing Experiences







The Sports Office supports and delivers programmes aimed at increasing participation in sport, targeting specific groups such as children, youth at risk, disadvantaged groups, teenage girls, women in sport, older adults and people with disabilities

Marathonkids ambassador, David Gillick, visits schools in Dublin 15

On Wednesday 18th October, we had the pleasure of having Marathonkids Ireland ambassador and former Irish Olympian, David Gillick, visit Hansfield ETNS and St Francis Xavier SNS. David gave a wonderful insight into his career as a professional athlete and the importance of physical activity. He spoke about the physical, mental and social benefits of the Marathonkids programme

This year, there are 3,600 students from 33 primary schools across Fingal participating in the ever-growing Marathonkids programme. The 8-week programme for 5th & 6th class students includes daily runs, physical & mental health education, nutrition and exercise. Each student will record daily updates in their physical or digital workbooks. The topics tie in to the Social, Personal & Health Education (SPHE) module of the student's curriculum.



Primary Schools Multi-Sports Initiatives

October saw the re-start of Fingal Sports Primary school initiatives. These activities included Sports Conditioning, Try Track and Field and GAA Handball targeting D15 and North County Schools. Over 1200 children are taking part in the programmes across 16 schools. Teacher training is a key element of the programme. Teachers have been upskilled to continue elements of each programme and get children of a non-sporting background to engage in our two Saturday Multi-Sport Hubs in D15 and Balbriggan.

Children's Sport Hubs

Fingal's Children's Sport Hubs commenced in October in Flemington CC Balbriggan and Corduff Sports Centre D15. This is a follow-on programme for our primary schools' initiatives and attracts children from a non-sporting background to engage in sport and physical activity. The drop-in nature and multitude of activities every Saturday morning has attracted good attendance of children from diverse social communities every week.





Fingal's Parent and Toddler Programme

Balbriggan's Parent and Toddler programme dressed up for Halloween for this week's class. The programme has 20 – 25 toddlers and parents/grandparents each week participating in fundamental movements (run, jump, throw etc) with a yoga element for the parents to enjoy. The programme has been very successful and Fingal Sports Office hope to run a pilot programme in Swords shortly.







Woodlands for Health

Fingal's Sports Office in conjunction with Mental Health Ireland, Coillte, HSE and Healthy Fingal has been running a Woodlands for Health Programme in Newbridge Demesne over the last number of weeks. This programme sees people from Swords and Balbriggan attend the park for a guided walk and some mindfulness followed by a cup of tea on a weekly basis.





Football for All Blitz

During October Fingal Sports Office work collaboratively with FAI and Dublin City Council to run a large indoor Football for All Blitz with adults with intellectual disabilities from all over Dublin City and Fingal taking part.

Participants trained with their local service in preparation for the blitz and a successful day was hosted in Alsaa for all involved over the past few months.





Exercise Energise

The Fingal Sports Office launched the Exercise Energise Programme for 2023/24. The programme is aimed at girls aged 12 – 15 years who are not currently involved in sport or physical activity. The objective is to help combat the drop off from sport among this age group.

17 schools were successful in receiving funding to provide activities at lunch time or after school, in addition to the usual PE class. The girls will be involved in selecting the activity, which has proven to drive the success of the programme.



Launch of BoxUp

Fingal County Council has officially launched a pilot project with two BoxUP units, at Skerries Community Centre and Rush South Beach. Both stations are already proving to be popular with people of all ages and have had regular use since their installation this summer.

BoxUP is an outdoor locker system that allows members of the public to access and use sports and leisure equipment for up to three hours, through a dedicated app. The service is free of charge.

To access the equipment, users can simply download the BoxUp app and register their account and all that is required is a form of identification. Councillor Adrian Henchy, Mayor of Fingal County Council commented, "These innovative units will provide a valuable addition to our local recreational spaces that will enable residents, workers, and visitors to fully enjoy the outstanding amenities offered in our communities, fostering a healthy and vibrant outdoor lifestyle."

Protected Cycle Lanes: BLRS Areas:

St. Cronan's Ave and Brackenstown Road Protected Cycle Lanes

This project is now moving towards substantial completion with most of the works, landscaping, street furniture, new crossing points and junction upgrades complete. The new planting is starting to settle in nicely and establish itself within the community. Active Travel's Walking and Cycling Officers are continuing their work with supportingSt. Cronan's School to encourage as many school children and parents to travel to school on foot or by bike and leave the car at home.

R132 Ministers Rd to Blakes Cross + Kilhedge Lane

The contractor was busy during October installing essential drainage upgrades at junctions and known surface water ponding locations. Construction of new road islands is underway that will provide a physical barrier between motorists and the new shared surface space for pedestrians and cyclists. New bus stops along the route are currently under construction and will provide better connection to public transport. Ongoing engagement is continuing with Corduff National School, local farmers and residents in relation to the works.

Seatown Road Swords:

Engineering Consultants are finalising the Non-Statutory Public Consultation Summary Report which will be published on the Consultation Portal. Works are ongoing to finalise the Tender documents with the aim to go to the market in the coming weeks for a Contractor to complete the works proposed on the ground and progressing to Construction stage in early 2024.

Donabate Portrane R126 cycle paths:

An Engineering consultant is appointed to the project and several surveys have been completed to inform the design process. The Engineering consultant is currently working with the project team in developing concept designs and options report to assist with stakeholder engagement. The project will extend from the end of the distributor road in Donabate along the R126 right through to the coast at Portrane. The Project aims to provide walking and cycling infrastructure from Donabate to the coast at Portrane which will provide connectivity to the Fingal Coast Route.

Coney Hill Balbriggan R132 cycle paths:

An Engineering consultant is appointed to the project and several surveys have been completed to inform the design process. The Engineering consultant is currently working with the project team in developing concept designs and options report to assist with stakeholder engagement.

Pathfinder Pinnock Hill to Airport cycle paths:

An Engineering consultant has been appointed to the project and is currently working with the project team to finalise documents with the aim to go to the market in the coming weeks for necessary surveys to inform the design process. Further updates will be provided over the coming months.

Howth-Malahide Area:

Baldoyle-Howth Protected Cycle Lane Scheme Phase 1

Phase 1 of the scheme is substantially completed.

Baldoyle-Howth Protected Cycle Lane Scheme Phase 2

The Active Travel Unit are currently reviewing requests for funding for the 2024-2025 programme, for a review of the existing road network in Baldoyle, which will include Willie Nolan Road, Brookstone Road and Main Street. This will comprise an advancement of a previous study for the improvement of pedestrian and cycle facilities on the existing road network.

A brief will be developed for consultants in the coming months, in line with the Fingal County Development Plan, the Climate Action Plan and an Active Travel Strategy for Fingal. Once a further study and preferred option has emerged from the process, it is envisaged that the scheme will progress, subject to funding from the National Transport Authority (NTA).

Paddy's Hill to Broomfield via Naomh Mearnog GAA

Design brief is being finalised for the connectivity project. Internal consultation with other FCC departments has taken place. It is intended to run a tender competition to appoint a design consultant for the Feasibility/Options Selection stage. Enabling works to provide connectivity from Paddy's Hill Car Park to St. Helen's Junior School and Limetree Avenue, including footpath works, tree surgeon works, new access points into the school and the provision of ramps are underway.

Seamount Heights to Old Gold Course Link Park

A meeting took place with Resident's Association on 11th October, 2023 to discuss the revised proposal, following comments from residents, the Active Travel Unit, and internal FCC stakeholders. Following this meeting, tender documents are currently being prepared to progress the project to the next stages (preliminary and detailed design) as soon as possible.

Station Road Portmarnock Footpaths and Cycleway

Works have been substantially completed.

Feltrim Road Cycle Infrastructure

Design brief has been drafted and is being finalised. These works are expected to go to tender for a design consultant in Q4 2023.

Scoil an Duinninigh to Waterside Footpath and Cycleway

Planning permission has been granted for the school and Department of Education is to engage with Fingal County Council on planning conditions related to pedestrian access.

BMCO Area:

Snugborough Road – NAC to Ongar

The options report for the project has been completed after internal reviews by the Active Travel team and a workshop with the NTA. A Gateway 2 Report has been issued to the NTA for approval to proceed to the preliminary design phase of the project. A project appraisal report was prepared as part of this phase.

Clonee to Blanchardstown Shopping Centre

All data collection has been collated and has informed the initial development of the options report. The initial draft options report and drawings have been reviewed internally by the Active Travel team and has been issued back to the design consultant for consideration. Stakeholder meetings with Meath County Council and the TII have taken place.

Castleknock to Dunsink Lane

This project is split into 3 separate sections, namely: (a) Auburn Avenue linking into the Royal Canal at the 12th Lock, (b) Dunsinea Lane and (c) Dunsink Lane. The Options Report and relevant drawings for Auburn Avenue and Dunsinea Lane have been submitted to the NTA in compliance to the Gateway 2 – 5 Hold Point requirements. A draft options report has been submitted by the design consultant for Dunsink Lane and is currently being reviewed internally by the Active Travel team.

Hartstown/Huntstown/Mountview Road

It is proposed to use a newly formed SPF to progress design from earlier work carried out by the CDO. FCC will progress on finalising the detailed design for roundabout and junction upgrades. This is subject to revision of design standards.

Castleknock to Blanchardstown via Farmleigh

Stage 2 of the tender competition for a design consultant and assessment has been completed. Contract documents to be signed when standstill finished.

Towns & Villages

Works are continuing in the development of an Active Travel Plan for a number of our Towns & Villages. Details are outlined below.

New Street

An application was made to An Board Pleanála by members of the public in relation to the proposed public realm improvements, requesting EIA and AA Screening Determinations. As a result, the Statutory Process is on hold until after An Bord Pleanála has made its decision which was originally to be by the 11th of September 2023. However, no decision has been provided to date.

Balrothery Active Travel Plan

The tender competition has closed, and tender assessment has been completed. FCC are currently in the process of appointing a consultant and expect to hold a pre-contract meeting as soon as possible. It is expected that work will commence on an Active Travel plan for Balrothery, as soon as this process is finalised.

Skerries Active Travel Plan

Stage One of the tender competition for the appointment of an integrated Design Team is now completed with the tender assessment process completed and letter to successful and unsuccessful tenders to be issued. This will allow for stage 2 of the process to commence which will take 7-8 weeks to complete. The Project Team are also in the process of publishing the Consultation Report for the project together with the ESRI report that was carried out on Active Travel best practice Nationally and Internationally. This report will inform the overall design process when the integrated design team is appointed in Q4 of this vear.

Skerries Harbour Road:

The Project Team together with the Integrated design team have been working rigorously over the summer in developing concept drawings and options report to assist with stakeholder engagement. Internal workshops to discuss through the proposals occurred during the last few months and this feedback from these meetings have been taken on board. The project team and the Integrated design team are developing photo montages and video footage of the proposal to assist in the consultation phase of the project.

Connectivity/Permeability

We are continuing to receive various requests for Permeability and Connectivity improvements from various stakeholders across the county. These

requests are being recorded in detail for evaluation through a multi criteria analysis. The projects are then reviewed across the departments to identify if an appropriate means of delivery can be established on the ground. A number of projects identified through this process are being developed through the design phases for execution later this year.

Where other projects are being progressed in the area at either design or construction stage we endeavour to include these Connectivity and Permeability improvements within those projects. Greenway connectivity support teams have been convened to review, design, and deliver active travel infrastructure that will enhance accessibility between the proposed strategic greenways and residential, educational, amenity and commercial zones. These support projects have been set up for Fingal Coastal Way, Broadmeadow Way/Sutton to Malahide Greenway and Royal Canal Greenway. This will help to optimise the use of the proposed greenway by both leisure and commuter users.

Newtown Bridge, Balheary Road:

Engineering Consultants are finalising the Non-Statutory Public Consultation Summary Report which will be published on the Consultation Portal. Works are ongoing to finalise the Tender documents with the aim to go to the market in the coming weeks for a Contractor to complete the works proposed on the ground and progressing to Construction stage during Q4 2023.

Rush South Beach:

Engineering consultant currently preparing concept design and options report for new universal access path. Discussions with landowners have taken place during the summer, and we are working collaboratively with the property owners to find an optimal solution that caters for everyone's needs.

Access Constraints

Following on from circular (NGS Circular 4/22) and guidance from the NTA (Access Control of Active Travel Facilities) the Active Travel Unit has mapped the access constraints (in particular kissing gates) within Fingal. We have put together a list of access constraints to be considered for removal and works proposed to improve for pedestrians, cyclists and disabled persons. This list is currently being reviewed by the various departments to ensure that the removal of these constraints provide a positive impact in these areas. On completion of the review Fingal County Council Active Travel in conjunction with Operations will be coordinating the removal of these access constraints across the county.

Secure Bicycle Parking Infrastructure

Contractor is currently on site at various locations across the county and is progressing works to install a number of bike parking facilities across the county. Further works are planned in Swords, Skerries and Dublin 15 in the coming weeks. Locations are currently being agreed for expansion of virtual e-bike parking in public areas. The contractor has completed the installation of 5 bicycle stands at Seagrange Basketball Court, Seagrange Park, Baldoyle and 5 bicycle stands at the Playground, Racecourse Park, Baldoyle. This provides 20 additional bicycle parking spaces in the Baldoyle area.

<u>Road Safety</u> Safe Routes to School Round 1 – Tranche 1

The works contractor for the Safe Routes to School Tranche 1 contract is making great progress at each of the three school sites. Works to date have progressed well, with little or no disruption to the schools or traffic in each of the three areas. A brief update is provided below for each school site and associated construction works completed to date since the appointment of the works contractor.

Rush and Lusk Educate Together

Works are now completed on this SRTS Project. The contractor has recently carried out some snagging and maintenance work to the Rain Gardens and addressed issues that were identified through the independent Road Safety Audit.

Castaheany ETNS / St.Benedict's NS

Works are now completed at the school site, The contractor is due to carry out minor snagging and maintenance on rain gardens. Stage 3 RSA has been completed by independent auditor.



Bayside Junior & Senior School

Works are now completed at the school site, The contractor is due to carry out minor snagging and maintenance on rain gardens. Stage 3 RSA has been completed by independent auditor.



Scoil Choilm CNS

Installation of flexible bollards on Porterstown Rd. outside the school entrance is complete. These initial works took place before the new school year starts to alleviate poor parking near the school gates. The main works are due to start during Q1 2024.



Round 1 – Tranche 2

Detailed Design is nearing completion for the Tranche 2 schools (4 no.) with a view to progressing to construction in Q1 2024. Contract documents are being finalised to engage a contractor for the works.

Round 2

In mid-December An Taisce announced Round 2 of the Safer Routes to School programme, with the following Fingal schools selected:

- Scoil Bhríde Cailíní, Church Avenue, Blanchardstown
- St Helen's SNS, Limetree Avenue, Portmarnock
- St. Colmcille's Girls' National School, Chapel Lane, Swords

The Active Travel team are working closely with An Taisce in relation to data collection and engagement with the schools to develop briefs to enable the tender process for designers and contractors to carry out the works. An Taisce are due to provide delivery plans for each of the schools that will inform the design process. FCC are in the final stages of procurement of a consultants' team that will be working on the designs for these schools.

Mobility & Behaviour Change

Learn 2 Cycle with a Disability

Courses are continuing across the County with the latest two taking place in Applewood Community Centre & St Fintan's NS Sutton. These 6 week courses provide children with additional needs and their families with the opportunity to experience the joy of independent cycling.

Staff eBike Trials

Over 60 People have signed up to the Staff eBike Trials. The 1 month trial gives staff the chance to experience what it is like to 'own' and eBike. The feedback from the trial has been very positive so far, with the demand being so high that we have purchased two additional folding eBikes which will be delivered to Fingal on the 1st November.

Walking & Cycling Buses

Following on from our information nights we have began meeting with Parents Associations interested in setting up their own Walking and Cycling Buses. The Hansfield ETNS Walking Bus is currently being taken over by interested parents, with plans for a second walking bus on the opposite side of the estate in planning.

They held a fancy dress walk on the last one before the midterm break.



Staff Cycling Lessons

Throughout October we held a series of Staff Cycling Lessons in the Swords Office, these lessons gave staff the opportunity to get back in the saddle and rebuild their confidence on two wheels. The group were very successful and it is something that we hope to build on for 2024.



SRTS – Presentations

As part of our Safer Routes to School Programme we have designed a school's presentation to explain to the students, teachers and parents the reasoning behind the infrastructure. We are planning to roll out the presentation across all SRTS Participants, starting with Rush & Lusk ETNS

Climate Action at Flavours of Fingal

As part of Climate Action Week 2023, we teamed up with colleagues from Sustainable Fingal and Climate Action to host a Car Free Event on Railway Street in Balbriggan. The event was held on Saturday 21st October and saw us close the street to traffic from 7am to 6pm with a street party taking place from 10am to 5pm.

The theme for the event was to celebrate the works of LS Lowry, who famously painted a mural of Railway Street in the 1970s, the mural showed a street alive with people and activities.

We teamed up with the Scéal Arts Collective to organise an art exhibition, showcasing works from Local Artists, with their modern take on the LS Lowry Mural, we also had 9 local artists playing original and cover songs throughout the day as well as Recreate Ireland who were provided fun for the entire family with their street games made from sustainable materials. We took the opportunity to engage with the public on the draft Climate Action Plan, where we saw over 50 people express opinions on the plans to tackle Climate Change in the County.

The day was a massive success and showcased what is possible for the street in the future.







Study Tours

Over the course of October staff from Fingal visited Utrecht in Netherlands and London in the United Kingdom. These study tours provided staff and councillors with a valuable insight into what other similar local authorities are doing when it comes to Active Travel.



Cycling Without Age – Pop Up Event

On Friday 27th October we held a pop up Cycling Without Age event with Avista on the Navan Road, this allowed a large number of service users with limited mobility access to the Trishaw. The Pop up event was held on Avista's grounds which made it more accessible to people with profound disabilities.

The Cycling Without Age Season is drawing to a close, we are currently planning a roadshow that would see us bring Trishaws to various Disability Providers, Nursing Home and SEN Schools in Spring 2024, this will help us to promote the service to a wider audience.

ESB – Smarter Travel Site Visit

On Tuesday 24th Oct members of Active Travel and Building Facilities visited the new ESB Offices on Fitzwilliam Street. The facilities are a best in class solution for encouraging staff to use sustainable travel methods of commuting to work.



Learn 2 Cycle Track – Millennium Park

Construction work has started on the new Learn 2 Cycle Track in Millennium Park. This dual use location is a partnership between Parks and Active Travel and will also see it used as the location of the Dublin 15 Ice Rink for the Winter Months. The Facility once completed will offer young children a perfect location to move from Balance Bikes to pedal bikes while learning the rules of the road. The design of the track includes a Cycle Friendly Roundabout. Teaching Children how new infrastructure like this operates is vital for encouraging safe cycling.



Community Car

The Community Car in Skerries had 128 requested trips in September, we are currently going through a recruitment drive for new volunteers with Local Link, this will be vital for reducing the missed demand on the Community Car. Climate Action

Fingal's Draft Climate Action Plan 2024-2029 -Public Consultation phase.

An extensive public consultation process for Fingal's Draft Climate Action Plan 2024-2029 (CAP) began in mid-September and since then the Council's Climate Action Section have been busy hosting a series of public information events to actively engage with and inform the public and other stakeholders of the Draft Plan.

Public information events were held at County Hall - Swords, Civic Offices - Blanchardstown and the Marine Hotel - Sutton and Fingal staff working in the themed areas of the Plan including: Energy and Buildings, Transport, Flood Resilience, Nature-Based Solutions, Circular Economy and Resource Management and Community Engagement were on hand to demonstrates Fingal's continued commitment to climate action by highlighting the proposed actions which the Council intends to take. In addition, Fingal attended the main public information event at the Mansion House on 17th October which was hosted by Dublin City Council on behalf of the four Dublin Local Authorities. An opening speech was delivered by the four Mayors / Deputy Mayors and Minister Ossian Smyth – Department of the Environment, Climate and Communications. Each Dublin Local Authority hosted a stand showcasing the Draft CAP for their area and also in attendance were Dublin's Climate Action Regional Office CARO, Codema Dublin's Energy Agency, and Smart Dublin. Entertainment was provided from artists and performers under the theme of climate action. The event was very well received.

Public information sessions were also held at Balbriggan and Rush Libraries.

ENVIRONMENT Environmental Awareness


The leaf mould initiative is being run again this year with thirty community and resident's groups across the County having received training and leaf mould cages this month. Leaves are collected locally and will decompose into a valuable compost for local use. Global Action Plan Climate and Environmental workshops are ongoing in schools. In addition, swap shops have been funded for ten Fingal schools, and several secondary schools have signed up for the ReLove Fashion Competition in partnership with the Rediscovery Centre.

Litter picking supplies were also given to several schools and community centres as an ongoing initiative to tackle litter in Fingal.



The Textile Tonnage Report for 2023 compared to 2022 is shown below. The amount of textiles collected for September 2023 was 21.51 tonnes compared to 17.61 tonnes collected in September 2022.



The volumes of Glass collected in October 2023 was **387 Tonnes**. This compares with a total volume of Glass collected in October 2022 of **401 Tonnes**.

A new contract for the Collection and Recycling of Glass and Aluminium for the four Dublin Authorities will commence on the 1st of November 2023.



The total volume of Textiles collected in September 2023 was **21.51 Tonnes**. This compares with a total volume of **17.61 Tonnes** collected in September 2022.

Litter Management

In October as part of their role to increase the public interest in keeping their areas clean and free of the litter, the Litter Wardens continued with their daily patrols, and inspected all known litter black spots. A total of 276 planned inspections were carried out on litter black spot all over the Fingal County Council area.



The Litter Warden also attended tenant induction courses to outline to new Council tenants their role in keeping their estates clean and free of litter.

The Litter Management Section receiving numerous complaints regarding the removal of pallets and bonfire materials for Halloween. The Litter Wardens called to the businesses in Fingal to remind them of their responsibility to secure any pallets and materials.

They also dealt with reports of dumping of pallets, tyres, mattresses, sofas, and other bonfire materials, checked for evidence, and arrange to have it removed.



The Litter wardens continued to raise awareness of the issue of dog fouling on beaches and the potential impact to water quality. They engaged with dog owners and dispensing dog poo bags, making people aware of their responsibilities to clean up after their dogs. They also erecting anti dog fouling signage in areas where complaints were received.

They carried out walking patrols, engaging with businesses regarding their responsibilities to keep outside their premises clean and free of litter. The Litter Wardens also checked to see if any issues had arisen for the Operations crews, they carried out inspections and followed up with fines/warning notice if evidence was found.

All the bring banks in the Fingal area were inspected daily to ensure that there was no dumping. Any evidence found was dealt with under the Litter Pollution Act. The Litter Warden also carried out investigation on reports of abandoned cars, taking photographs and updating the CRM system.



There were 2 cases before the district court in October, which were successful prosecuted, and costs awarded.

Dog Warden Service

The dog wardens continue to carry out enforcement in relation to breaches of the Control of Dogs Act 1986, Control of Dog Regulations 1998, Parks and Open Spaces byelaws and Beach and Foreshore byelaws. They also educate dog owners on the responsibilities of keeping a dog and remind owners to pick up after their pets when in public places. The dog wardens also increase their patrols of the beaches during the summer months to optimise bathing water quality and retain the status of Fingal's Blue Flag beaches.

The dog wardens are also continuing with door-todoor licence checks. Dog owners should ensure that they hold a valid licence for their dog and if issued with a 10-day notice by the dog wardens, should present their licence to controlofdogs@fingal.ie within the 10 days provided on the notice. Failure to do so may result in a fine being issued for failing to produce a dog licence when requested to do so by a dog warden and keeping a dog without a valid licence. The fine per offence is €100. 241 x 10 Day Notices were issued by the dog wardens during October 2023. 40 fines were issued during October 2023.

Failing to hold a valid licence for a dog that you are own or are responsible for can incur a \notin 100 fine.

Dog Breeding Establishments

During the month of October, the dog wardens conducted investigations on dog breeding establishments in the Fingal area and 17 dogs have been seized.

Dog Shelter Service

Dublin County Dog Shelter holds "Meet and Greet" visits for anyone looking to rehome a dog. Visits can be arranged by calling the shelter and arranging an appointment. These visits can be arranged from Monday – Friday from 11am to 1pm and from 2pm to 3.30pm. The shelter is also open on Saturday from 11am - 1pm. The shelter is closed to the public on Sundays. The dog shelter holds stray dogs picked up by the dog warden and dogs who have been surrendered by their owners either to the dog wardens or directly to the shelter. At the beginning of October there were 30 dogs in the shelter. During October 2023, 20 dogs were brought to the shelter by the dog wardens as stray or surrenders and no dogs were surrendered by a member of the public. Of these 50 dogs, 6 have been reclaimed by their owners, 17 dogs have been rehomed to rescue, 3 has been rehomed to members of the public and 1 was PTS. At the end of October there are 23 dogs remaining in the shelter. The shelter has a Facebook page Dublin County Dog Shelter and Instagram Account **@dublincountydogshelter** which they actively update with strays and dogs wishing to be rehomed.

Horses

Weekly inspections continue to take place on Dunsink Landfill to monitor the numbers and welfare of the horses onsite. There are 10 hay feeders being filled by the Operations Department on a weekly basis to ensure adequate forage for the horses on the landfill. In October there was 1 seriously welfare compromised horse taken from the landfill and 1 horse seized from the public realm.

Environment staff attended the DAFM Urban Horse Project seminar on Thursday 26th October.



Water Quality

EU Water Framework Directive - River Bracken Investigations

Fingal County Council has continued investigative river sampling of the River Bracken and is currently searching for potential pollution sources in the upper reaches of the catchment and whether there are any significant pollution sources in the Upper Catchment that could be having a detrimental impact on Balbriggan Bathing Area.

Initial results indicates that there are a small number of potential pollution hotspots in the Upper Catchment which will be subjected to closer investigation and inspection over the coming weeks.



EU Water Framework Directive – Agricultural Inspections

The Water Quality team has recently carried out a number of farm inspections in the River Delvin, Matt, Gaybrook and Balcunin Catchments. Fingal County Council found a number of minor non compliances at some locations and 1 significant non-compliance at 1 farm. All non-compliance farms are being addressed with appropriate enforcement action



Historical Landfills

St. Doolagh's and Burrow Road Historical Landfills

Tier 1 Risk Assessments for St. Doolagh's and Burrow Road Historical Landfills have recently been completed. The Tier 1 assessment for St. Doolagh's found that this historical landfill requires further assessment. Fingal County Council has commenced the process of appointing contractors to carry out the Tier 2 assessment for this historical landfill.

The Tier 1 assessment for Burrow Road found that the landfill poses no threat of pollution to the environment and that the file for this location can be closed out.

Waste Enforcement & Regulation Waste Complaints


A total of 25 waste complaints were recorded for the month of October. Waste complaints investigated primarily related to the illegal dumping of waste, backyard storage of waste and the backyard burning of waste. Other waste complaints investigated related to unauthorised C&D sites, unauthorised ELV sites and non-routine inspections.


Awareness and education around the management of domestic waste in a sustainable and environmentally safe manner is crucial to ensure all households participate in a waste collection service as per the waste presentation bye-laws and use three bins (black, green and brown) to manage their waste. Any information in relation to unauthorised sites/collectors can be forwarded to <u>environment@fingal.ie</u>.











End of Life Vehicle (ELV Project)

In October 2023 Fingal County Council Waste Environment and Regulation Section successfully prosecuted an illegal ELV site in the Dublin District Court. The unauthorised site was operating in the Lusk area for several years. The site operator was prosecuted under Section 39 and Section 55 of the Waste Management Act 1996 for illegally dismantling ELV's on site without an appropriate waste facility permit. The site has now been cleared and all illegal ELV activities have ceased.

A total of 87 illegal ELV sites (low and high-risk) were identified as part of the End of Life (ELV) Project. All sites have now been dealt with and closed resulting in over 1,700 ELV's brought to Authorised Treatment Facilities (ATF's) for recovery and disposal.



The Waste Enforcement Section are working in close co-operation with and the Planning Department to ensure that sites previously cleared remain closed and that all illegal car breaking activities cease on a permanent basis.

Waste Presentation Bye Law Project 2023 - 2025

Waste Bye-Laws (Segregation, Storage and Presentation of Household and Commercial Waste) were introduced back in January 2020. The key objectives of the Waste Bye-Laws are:

- To encourage households and businesses to manage their waste in an environmentally responsible manner.
- To promote better segregation of household and commercial waste.
- To ensure only authorised waste collectors are used to dispose of waste.
- To reduce illegal dumping and backyard burning of waste



The Waste Enforcement Section have initiated a project to assess compliance with the Waste Bye-Laws. Phase 1 comprises the establishment of a register of households who currently have a waste collection service in place to facilitate a reverse register to be developed identifying households who don't have a bin collection service in place using Eircodes.

Information was requested (addresses, bins provided, last lift date) from each of the 8 waste collectors operating within Fingal to establish the register in accordance with Section 34 of the Waste Management Act, 1996. Information in relation to 88,810 customers was received in response to the Section 18 notices issued.

Dataconversion Direct Ltd were engaged to cleanse the address information to facilitate Eircodes to be appended to each address. A number of different automated and manual techniques were employed to achieve a **98.5%** match rate such as high-quality batch encoding to analyse and transform the specific data set (addresses) to create matching rules based on unique properties.



A reverse register including GIS mapping are currently being developed to identify households who currently don't have a waste collection service. Phase 2 of the project will commence in 2024 whereby information will be sought from householders listed on the reverse register to confirm how they're managing their waste. Where householders do not engage in the process, directions and fixed payment notices will be issued to encourage householders to comply with the Waste Bye-Laws and to help improve waste segregation and recycling rates including food waste. Anti-Dumping Initiative 2023

€50,000 in funding was secured by the Waste Enforcement Section under the ADI 2023 to develop an awareness campaign in relation to the Waste Presentation Bye-Law Project. A video ad was created to encourage compliance with the Waste Bye-Laws and to explain the important of the Waste Bye-Law Project 2023 – 2025 for use in a cinema awareness campaign.





The video highlights the importance of the Waste Bye-Laws in terms of managing and segregating your waste to help increase recycling rates and reduce illegal dumping. It focuses on the requirement to participate in a waste collection service, to bin share or to bring your waste to an authorised facility that accepts it. As part of the project householders identified as not currently availing of a waste collection service will be asked to confirm how they are managing their waste. Breaching the Bye-Laws can result in a \in 75 on the spot fine or a \notin 2,500 fine and a criminal conviction if found guilty in court.

The video ad is available to view on FCC's website and social media sites, within FCC buildings and as part of a cinema awareness campaign across 5 different cinemas (Movies @ Swords, Omniplex Balbriggan, Odeon Charlestown, Odeon Blanchardstown and IMC Santry). The video ad will be shown over a 6 month period (October 2023 – March 2024) with 500,000 guaranteed viewings. Open House Dublin Festival

Swords Cultural Quarter

A tour that included Swords Castle, showing work undertaken over the past six years, related to consolidation works on the masonry, improved public access and landscape improvements to enhance the setting and provide interpretation of the site.

Malahide Castle


Tours focused on conservation works undertaken last year in the Great Hall- the finest state room in the historic castle building. This work involved complex conservation works of reroofing, stone and joinery repair, interior redecoration, and improved internal environmental systems to facilitate improved conditions and the display of the important collection of artworks on loan from the National Gallery of Ireland.

Newbridge House

In Donabate, the Newbridge House tours highlighted current conservation works, showcasing façade repair works nearing completion, along with completed reroofing of the house and the joinery conservation. The tour included the house's interior, visiting some of the principal rooms.

Public Housing-Rolestown & Mulhuddart

This year for the first time, we had Public Housing Tours that included two recently completed schemes.

Church Fields, Mulhuddart

Tours of New Public Housing at Church Fields, Mulhuddart presented the completed Phase 2A of the wider housing Land Management Plan for the Church Fields development. Phase 2A includes 67 dwellings in a mix of one-, two-, three, and fourbed dwellings in three urban blocks.

The proposal includes two- and three-storey units integrating with the existing Avondale Park, to include single storey houses to the west of the site, overlooking the Pinkeen River.

The new public housing at Rolestown tours highlighted the special age-friendly features of this initiative.

Conservation Grants

The Conservation Office based in the Architects Department has been overseeing the completion of heritage works in connection with the various Grant schemes operated by Fingal namely:

- o Built Heritage Investment Scheme
- o Historic Structures Fund
- o Architectural Heritage Fund
- o Stitch In Time Grant scheme
- o Stewardship Grant Project

On completion of all works and payment of the grants, a full report will be brought to Council in January 2024.

Age Friendly Award Nomination

Fingal County Council's social housing scheme at Rolestown has been shortlisted for the 'National Age Friendly Recognition and Achievement Awards 2023'. The scheme of 26 houses was designed by the Architects Department, and construction was completed in 2020.

Approximately half of these houses were allocated to housing waiting list tenants with medical priority, including some older people. It was designed to be fully accessible and lifetime adaptable.

The development also includes a large open space area and new civic square across the road from the Rolestown church which benefits the larger community.

The architects made a presentation to the judges earlier in October with a winner to be announced at an awards ceremony in Wexford on the 30th November.
