### **Wellbeing Update**

Fingal County Council Digital Gym Monthly timetable will be issued to staff including Yoga, Pilates, Combat fitness, Family Fit, Active Agers. Providing something for all staff to keep fit and improve their Wellbeing. Over 150 classes are available on demand.

We successfully secured funding from the LGMA for our 'Creativity for Wellbeing' programme launching in March. We are providing guided art sessions for staff. Artistic activities such as painting have been proven to Enhance mental health, Reduce Stress, Foster Resilience, Fuel Joy.

International Women's Day takes place on March 8th a wellbeing message will be issued raising awareness of events throughout the county and nationally.

In collaboration with the new integration officer, we are in the process of procuring Debriefing Training for staff and managers who deal with traumatic or critical incidents. This vital tool will assist in improving the wellbeing of staff who work in difficult circumstances such as Housing, Integration, Community, Customer Care, Inspection roles and Operations staff.

#### **HSU - Health & Safety Unit**

The HSU generated a number of risks assessments early this year covering handling of waste materials likely to turn up in FCC recycling facilities and as waste material on public open spaces. These included assessments on the handling of WEEE, batteries, paint, motoring products, aerosols, gas cylinders and chemicals. A number of procedures were created / revised in the same period covering the reversing of vehicles, responses to unreasonable behaviours and vehicles tail-lifts. The unit carried out 67 site safety inspections and audits from the start of 2024 to date in addition to 52 VDU assessments for office and remote based staff. 20 incidents and dangerous occurrences were reported to the HSU 18 incident investigations date with completed. Overall there was a drop [of 4] in workplace incidents compared to the same period in the previous year.









#### Seachtain na Gaeilge

We are halfway through Seachtain na Gaeilge with a broad ranging programme taking place in Fingal. Thursday saw the Ardgillan Demesne Bilingual Walk with Irish Officer Bernie Kelly and Head Gardiner Dominica McKevitt. The recently awarded Best Irish Language Initiative at the LAMA awards. On Wednesday in County Hall the Annual Oiche Cheol for Seachtain na Gaeilge will take place with musicians Ellie Fhionnghaile, Dónal Kearney agus Fergus Cahillane. Announced during Seachtain na Gaeilge were the 10 recipients of the new Fingal County Council Gaeltacht Scholarship Scheme for second level students while a further 14 Fingal Staff commenced the Certificate in Professional Irish.



#### Website

The fingal.ie website attracted 130,915 visitors during February which was almost 10,000 up on the figure for January and 34,126 more than in February 2023. The number of page views, at 312,179, was up by 5% from January and by 26% from the same month last year. The month visited pages during February were the Home Page, Planning Applications, Jobs, Contact Us, Affordable Housing and Playability of Pitches.

#### **Social Media**

A post promoting the housing information evening in Donabate on March 7 and the various schemes to support people trying to own a home such as Affordable Housing, the Local Authority Home Loan and the Vacant Property Refurbishment Grant got very good traction across our various platforms.

It had a reach of 30,506 on Facebook and a 6.76% engagement rate.

On Instagram there was a 6.46% engagement rate from a reach of 2,711. On X the post had 4,908 impressions and 105 engagements. The number of followers on Facebook has risen to 33,176 while Instagram now has 8,900 followers and LinkedIn has 8,656. The X account saw its followers rise to 23,314 from 23,233.

The five corporate social media channels now have a cumulative following of 75,296, having risen by 758 from last month.

#### **Videos**

Nine videos were produced during February and uploaded onto the Council's You Tube channel. They included a video about the photo shoot artist John Byrne held to create a Fingal version of a painting by French artist Eugene Delacroix from 1830. There were also videos produced about the sod-turning for 300 social and affordable homes in Church Fields, the opening of the Carnegie Library in Swords and the visit by the Minister for Housing, Local Government and Planning to housing developments in Malahide and Swords.


#### **Press Releases**

#### **LAMA Nominations**

The Communications Unit received two nominations at the recent All Ireland Local Authority and Community Awards organised by the Local Authority Members Association. The Ardgillan Demense Bilingual Walk won the Best Irish Language Initiative Award while the Inside Fingal Podcast was nominated for the Communications Award.

#### **Resident's Booklet**



A 24 page Irish-English booklet has been produced by the Communications Unit and delivered to every home in Fingal. The purpose of the booklet is increase awareness of the work being done by the councillors and staff of Fingal County Council to make Fingal a great place to live, work, visit and do business in. The booklet highlights some of the major Capital projects the Council is delivering and how the Council is addressing housing challenges as well as focusing on the work being done by some of the sections within the Council.

#### **Media Queries**

The Communications Unit received 26 media queries during February. Among the topics covered were Dublin Airport, Corduff Park, the R132 and restricted dog breeds.

#### **Building Facilities / Energy Improvements**

Condensing high-efficiency Calorifiers (hot water heaters) are in the process of being installed and commissioned. Five Units in total. Two which are now in situ in County Hall. Three in Grove Road which are due to be installed in the coming week. These units will show a 20% gas reduction per unit on the efficiency compared to the previous unreliable models that were in place.

The new units will be operated by the BMS and have a range of functions to ensure energy controls while delivering hot water throughout the buildings.

Heat pump primary heating solution are been pursued as part of the general decarbonization of the Civic Offices.

# TOURISM DEVELOPMENT Launch of the Fingal Tourism Strategy



The Fingal Tourism Strategy 2024-2029 was officially launched at Ardgillan Castle on Thursday 8<sup>th</sup> February. The event brought together key representatives from across the tourism stakeholder community and the Strategy was formally launched by the Mayor in the presence of the Minister for Housing, Local Government & Heritage, Darragh O'Brien and Paul Kelly, CEO of Failte Ireland. Despite the inclement weather, over 60 people attended the successful launch that included traditional Irish music, an archery demonstration and an opportunity to sample a golf simulator as well as a much-praised lunch provided by The Salty Buoy food truck.

A small delegation will participate in a visit to New York from 18th to 21st March which will coincide with the premiere of the Fingal Sessions on US TV. The sessions were filmed in January 2024 and will be broadcast on almost 100 TV stations across the US. The visit will include a launch of the Fingal Sessions and the Fingal Tourism Strategy and will include opportunities for economic and tourism promotion with local elected officials, media, cultural and business representatives. Meetings have been arranged with Tourism Ireland's North American team, IDA and the Irish Business Organisation of New York. Meetings are also proposed with the County Dublin Society of New York and other groups with a view to strengthening the Council's links with the Fingal diaspora.

#### **Fingal Food & Drink Network**



The Fingal Food Network undertook their first Familiarisation visit of 2024 on Friday 23rd February to Belfast to learn best practices in creating food tours. Over 15 members attended the very successful visit which took in the inspiring Belfast Taste Tour sampling the best of produce in Northern Ireland. There was a great opportunity for members to network and discuss possible collaboration projects for food related businesses in Fingal.

The Fingal Food and Drink policy will be launched at Flavours of Fingal at the end of June.



# Malahide Castle - Boiler upgrade incl. Rainwater Harvesting/CHP

The Mechanical & Electrical consultants are finalising the tender package for the Boiler upgrade incl. Rainwater harvesting/CHP.

The works will consist of a full replacement of the boilers, reintroduction of the CHP and Rainwater Harvesting System, thus providing enhanced efficiencies over time by reducing costs and by promoting energy and water conservation.

It is envisaged that works will commence in Q2 2024.

#### **Carnegie Library**

After a year of extensive works, the Carnegie Library in Swords has been officially reopened, marking a key advancement in the extensive Swords Cultural Quarter. The Arts Office will now begin to develop a programme which will feature a diverse array of exhibitions, multi-disciplinary residencies, performances, and workshops. A Programme Development Manager has been appointed and a public launch will take place later this year.

#### **Public Art**

John Kindness visited Balbriggan for a site visit and a meeting with the project teams for Harry Reynold Road and Quay Street as we plan for a new Public Art Commission for the town. While in Fingal he visited Swords to look at some of his work and the new Carnegie Library where artist John Byrne was making plans for his installation of new work featuring 60 Fingal residents planned for later this year.





#### **Draíocht**

Draíocht's major project, NEST, formally launched on February 17th. This was the first time we gathered everyone involved in the project. Our 48 hosts (a host being a person who lives in Dublin 15), their families, our 5 visual artists, curator, 41 theatre/dance/music artists and our production team were all present. Our hosts are between the ages of 7 weeks old to 22 years old. Our 48 hosts include one class group from PobalScoil Setanta (22 children).

On March 1st, our 23 shows will be performed 3 times, 69 performances in total. These performances will take place in schools and homes all over Dublin 15. It is estimated that they will be seen by 1,500 people.

Our Festival 'Spreacha Soar', where all of the 23 shows will be performed in Draíocht takes place from 11th to 16th March.

April 13th will be the final event of the NEST project. This is the day we formally handover the NEST Portrait project works to Fingal County Council's collection.

This is the second year of the popular Fingal Libraries World Book Tour, which gives primary school children the opportunity to meet some of their favourite authors. The children will be gifted a copy of the author's book and get fun World Book Tour-branded activity sheets full of puzzles and games.

# Launch of Sensory Resource Back Packs in Fingal Libraries

Backpacks full of sensory-friendly resources are now available in Baldoyle, Swords and Balbriggan Libraries. This has been funded by the Community Recognition Fund. The roll out of the sensory resource backpacks was launched by the Mayor with a photo call in Swords Library on Monday 19th February. The Mayor was joined by the County Librarian and children from St. Cronan's Junior National School in Brackenstown, Swords. The children, who were in the Library for a fun sensoryfriendly slime workshop, got some hands-on experience trying out the resources in the backpacks, including fidget kits, fibre optic lights and an ocean wave projector with sounds and speaker. The sensory resource backpacks continue the Libraries' Dept commitment to making our spaces and services inclusive of neurodivergence, through the provision of materials and resources, training for library staff, programming, and sensory-friendly quiet hours.





### **Inclusive Creativity**

Prosper Fingal is taking part in creative workshops in Malahide Library and Swords Library as part of an ongoing Inclusive Creativity project. The workshops include creative writing, photography and illustration. St. Michael's House is also taking part in creative workshops, including painting, arts and crafts, and illustration classes in Swords Library. These workshops give participants an opportunity to express their creativity and interact with others in a supportive and friendly environment.

#### Seachtain na Gaeilge

Fingal Libraries is presenting a range of events for all ages to celebrate Seachtain na Gaeilge. Balbriggan and Baldoyle Libraries will host Irish traditional music and singing from Antaine Ó Faracháin and Nollaig MacCarthaigh. Children and adults alike will get the opportunity to learn how to play the bodhrán with champion bodhrán player Niall Preston. Gaeilge i mBaile Brigín will host a bilingual poetry evening in Balbriggan Library. Donabate, Malahide and Blanchardstown Libraries will screen a 3D Irish language film, Ar Ais Arís, on Oculus Virtual Reality headsets. Created by James Riordan from the Brú Theatre in Galway, this visually stunning film features the Irish language, culture, dance, and music.

Storyteller Seosamh Ó Maolalaí will tell stories in Irish for all the family in several libraries. Róisín Murphy will recount Irish legends and folklore that have been passed down through the generations. Illustrator Tarsila Krüse will read Ná Gabh ar Scoil followed by a children's drawing workshop. Fingal Libraries Seachtain na Gaeilge programme features several workshops for schools, including yoga sessions as Gaeilge and comic strip drawing workshops with cartoonist Aidan Courtney of Coimicí Gael. High Rock Productions will present an Irish speaking performance workshop featuring school children. in Skerries and Donabate Libraries.

# **Creative Ireland: Creative Communities Open Call 2024**

Following a significant increase in queries relating to Creative Ireland funding through Fingal since the start of 2024, the Creative Fingal team performed an evaluation of the existing process. Following this, the team engaged with consultant Sinéad Begley to develop an Open Call application form and guidance document for Creative Communities Grants for 2024. This should streamline the process for both applicants and evaluators going forward.

The Open Call is due to go live on 22/02/2024 on the Fingal Submit platform. It will remain live until the deadline of 5:00 pm on 29/03/2024. Information on the funding scheme and how to apply will be available on the Fingal website and it will be advertised across social media channels.

There will be four awards within this scheme. Each award is to the value of €5,000 - €10,000 (max.). Applicants are asked to link their projects to the key strategic themes of the Fingal Culture and Creativity Strategy 2023 – 2027. Applications will be evaluated in early April and successful applicants notified and supported to begin preparations on their projects.

#### **ECONOMIC DEVELOPMENT**

#### **Fingal Skills Strategy**

Planning has commenced for the 2024 "Xplore Your Future Expo" which will be held in The Helix, DCU on the 15<sup>th</sup> of October 2024.



Tenders for consultants to prepare the next iteration of the Fingal Skills Strategy 2024 – 2029 are currently under evaluation.







The SKYLA Project "Smart Specialisation Skills Ecosystems for the Twin Transition" is a 4-year project which focuses on enhancing the role of VET in smart specialisation sectors. Projects partners include Italy, Poland, Sweden, Lithuania, Bulgaria, Greece and Belgium. Reporting for Period 1 of the Project has been completed and the identification of good practices in Fingal is in progress with key stakeholders – DRSF and Baldoyle Training Centre – which will be shared with the Project Partners and presented at the next transnational meeting scheduled to take place in Florence in March 2024.

**Economic Development Strategy** 



Grant Thornton Consultants have completed work on the Fingal Economic Development Strategy 'Future Fingal' which was agreed at the February Council Meeting. Work has commenced on a Marketing Plan, with consultations with key stakeholders taking place in January and February 2024. Preparations are underway to launch the Economic Development Strategy in April 2024.

#### **URBACT - EcoCore**



Fingal County Council is leading the URBACT EcoCore Project which comprises a network of 9 small cities/towns in Europe focussing on challenges and opportunities for green growth and sustainable economic development along transport corridors.

Balbriggan is the lead town and the other partners committed to the network are Albu Iulia, Romania; Dubrovnik, Croatia; Kekava, Latvia; Ormoz, Slovenia; Parnu, Estonia; Santo Tirso, Portugal; Tuusula, Finland; Villena, Spain.



The EcoCore Project baseline study and roadmap for the project for the next 2 years has been approved by the URBACT Secretariat. As Lead Partner, Fingal is proceeding to schedule the transnational city visits in collaboration with our Project Partners and to plan Balbriggan's small-scale actions for 2024.

The next core network meeting is scheduled for the 12/13<sup>th</sup> March in Santo Tirso, Portugal where members of the Balbriggan URBACT Local Group (ULG) will attend the two-day transnational meeting.

As the project is entering the action planning stage for 2024 a series of masterclasses on key topics for partners has commenced, with the following masterclasses delivered to date:

- Facilitation Skills delivered by Louise O'Meara of Queens University on the 16<sup>th</sup> and 23<sup>rd</sup> February 2024

Fingal County Council attended an Urbact Irish Networks Meeting held by EMRA in Limerick on the 21<sup>st</sup> February 2024 to present progress on the EcoCore Project and connect with representatives of the Irish local authorities involved in other Urbact Networks.



The Balbriggan Project Team is examining a further application to the Urbact European Urban Initiative (EUI) to inform the development of plans for Balbriggan under the EcoCore Project.

# Citizen, Equality, Rights and Values Programme (Cerv)

CERV is an EU Funding Programme for citizens' engagement and the implementation of EU rights and values. Fingal County Council has been awarded CERV funding to participate in 2 separate projects, which commenced in January 2023 and will continue for 18 months.





#### **Green It Your Work**

Fingal is hosting the fifth Green IT Your Work international meeting on the 6/7<sup>th</sup> March 2024 with a focus on "It's Time For Green Start"

Fingal County Council will host partner representatives from Romania, Spain Greece, Cyprus, Slovenia, Croatia, Italy and Ireland.

Work is ongoing on the objectives of 'Green IT Your Work' which are:

- Youth Debates about European Digital Age project highlighting the role of young people in the green transition.
- Promote green jobs with the aim of contributing to greener European cities

#### InclusEU

The InclusEU project aims to encourage volunteer action as a social response for an inclusive Europe. Work continues on the project with partners from Italy, Poland, Hungary, Spain, Portugal, the Netherlands and Romania. Representatives from Fingal's Sports Office and Foroige attended Lasi, Romania, in February with the Portugal event taking place in April 2024.

#### **Sustainable Fingal**



The Council met with representatives from DCU and daa in February to discuss a work programme for 2024 to progress sustainable projects. A follow-up meeting is scheduled for March 2024 to prioritise projects.



Work continues on the development of an action plan to advance the objectives of Circular Cities in Fingal. Fingal's profile has been published on the Circular Cities website and the first annual report on Fingal's transition to the circular economy under the Circular Cities Declaration was submitted in October 2023.

#### **Dublin Belfast Economic Corridor**



Fingal County Council was awarded €150,000 by the Department of Housing, Local Government & Heritage under the Shared Island Local Authority Development Funding Scheme for a Feasibility Study for the development of regional innovation/enterprise hubs along the Dublin Belfast Economic Corridor. DBEC's ambition is to innovation hubs to encourage the development of new and existing high-growth businesses to stimulate sustainable and climateconscious growth along the Corridor. The feasibility study has been completed and was submitted to the Department. Drawdown of the eligible funding has been completed and the Council is liaising with DBEC to consider potential funding streams to progress the implementation of the Study's recommendations.

Fingal County Council continues to liaise with DBEC on a series of potential projects for DBEC.

#### **Enterprise Ireland - Smart Regions Funding**

The Council has commenced preparations of applications to the Smart Regions Fund. The application deadline is 31<sup>st</sup> March 2024. The Council is reviewing potential applications under Stream 1 for Capital Infrastructure and Under Stream 4 for a Feasibility Studies/Priming Grants and is liaising with key stakeholders such as DBEC and the Council's Enterprise Centres on the applications.

#### LOCAL AND RURAL DEVELOPMENT



# Fingal Local Community Development Committee

The Fingal LCDC continues to oversee and administer the key areas of LEADER and SICAP and the various Local Development and Community Development funding programmes under its remit. The LCDC also manages the Healthy Ireland Initiative and the Social Enterprise Grants Scheme. The LCDC met on the 7<sup>th</sup> of February 2024 and reviewed progress on various programmes under its remit, discussed a join application from the Fingal LCDC and Fingal CYPSC for a pilot project under the EU Child Guarantee Ireland's National Action Plan and approved the SICAP end of year 2023 review and discussed the annual plan for 2024.



# Fingal Local Economic Community Plan 2023 - 2028

The LECP was adopted by the Council in January 2024 and includes a two-year LECP Implementation Plan with actions to implement the Goals and Objectives set out in the LECP.

The LECP was launched on the 26<sup>th</sup> February 2024 by the Mayor Councillor Adrian Henchy and Minister Joe O'Brien with internal and external stakeholders attending the launch at County Hall along with Minister Darragh O'Brien.





#### **Local Enhancement Programme**

The Local Enhancement Programme is funded by the Department of Rural and Community Development. Fingal was allocated €220,842.98 in funding for groups across the county. A call for applications has been advertised by the Council with a closing date for applications from community groups/organisations of 8th March 2024. The evaluation of applications will take place in March with a deadline of 28th March for the submission of proposed allocations to the Department of Rural and Community Development for approval.



#### **Alcohol Education**

Healthy Fingal in collaboration with the North Dublin Drugs Task Force are piloting an alcohol education programme with Lusk Utd AFC from January 2024. The pre-crisis education programme targeting men over 35 will run for 8 weeks in tandem with an exercise programme to encourage men to evaluate their drinking levels and potentially reduce their consumption levels.



#### We Can Quit

Healthy Fingal have teamed up with Empower to deliver two pilot We Can Quit programmes with the Blanchardstown Training Centre (to start in Q1) and the Tolka River Project, Mulhuddart. The We Can Quit programme, was developed by the HSE and is aimed at encouraging people to quit tobacco/vaping. The programme with the Tolka River project started in January 2024 and will run for 10 weeks with participants enrolled both quit smoking sessions and weekly yoga sessions to encourage a healthier lifestyle.

#### **Community Recognition Fund**

The Community Recognition Fund (CRF), funded by the Department of Rural and Community Development, approved the Council's project proposals in March 2023. Fingal County Council has received an allocation of €1,748,912 for 26 projects across Fingal.

There is an allocation of €850,512 for eight projects in Swords and €435,000 has been provided for four projects in Dublin 15. Three projects in the Howth Malahide Local Electoral Area have received a total of €92,000 while €96,600 will be spent on four projects in Skerries, Rush and Lusk. Three projects in Balbriggan will be funded by grants amounting to €44,000 while two projects in Balseskin will receive a total of €30,200 and one in Santry will receive €20,000.

All projects are required to be complete by 18<sup>th</sup> October 2024 and work is progressing on the implementation of the project with the Council submitting an initial drawdown in 2023 of €243,000 with a further drawdown to be completed in Q1 in respect of works completed to date in 2024.

**SICAP** 



The resources and staff of the Fingal SICAP Programme continue to be leveraged to assist with the Ukrainian Refugee Crisis response. The SICAP Programme continues to help in the response to this crisis and is a central resource to the work of the Ukrainian Refugee Community Response Forum. Additional funding has been received from the DRCD to help with the delivery of services to Ukrainian Refugees in Fingal and additional staffing resources from the Ukrainian community have been employed on the ground to assist with this. The Fingal SICAP Programme has been allocated €304,369 in 2023 specifically for Fingal's Ukrainian Refugee Response with an additional allocation of €65,000 recently granted.



The new contract for the provision of the SICAP programme over the period 2024-2028 has been awarded to Empower CLG and contracts have been signed. The annual SICAP budget for 2024 is €1,520,811 and there is a separate funding provision for new arrivals to the value of €375, 372 for 2024.





#### **Leader Programme**

Following the outcome of the Local Development Strategy (LDS) selection process Fingal LCDC and Fingal LEADER Partnership were selected to run the LEADER Programme 2023 – 2027 in the Dublin rural area. The Dublin Rural LEADER (LAG) includes rural areas in the administrative areas of Fingal, Dun Laoghaire Rathdown and South Dublin.

The new LEADER programme launched at the end of February, following the signing of the LEADER Funding Agreement by the Minister for Rural & Community Development, Heather Humphreys, TD. The new Dublin Rural LAG met for the first time on the 27<sup>th</sup> February 2024 and were briefed on the new LEADER Programme by Fingal LEADER Partnership. A number of workshops are planned in March 2024 to promote the new LEADER Programme.

#### **ENTERPRISE CENTRES**

Fingal's Enterprise Centres continue to participate in ConnectedHubs.ie.

ConnectedHubs.ie is a one-stop-shop for remote working hubs throughout Ireland.





All three Enterprise Centres have space available to start-up businesses and businesses/individuals who wish to avail of remote working options and facilities. Bespoke options or generic office fitouts can be considered. Occupancy rates at the Council's three enterprise centres are all over 90%. The three Enterprise Centres currently support 65 businesses and over 320 direct jobs.

Fingal County Council was approved for €50,000 in new funding to promote Remote Working Hubs in the County under the Town and Village Renewal Scheme Marketing Measure. A cross-departmental team within the Council is implementing initiatives to promote Fingal as a Remote Working Hub base for remote workers with a marketing campaign now underway across various media platforms and includes an article in the Business Post. Drinan Enterprise Centre is also promoting the availability of a bespoke media studio facility available for immediate booking to all individuals, groups and business interests which is also being promoted with a podcast which is planned in March from Drinan Enterprise Centre's Creative Studio by the bilingual podcasters "How to Gael'.

The Our Balbriggan Programme Office continues to support the Leadership Group and its five pillars - Growing the Local Economy, Public Realm & Infrastructure, Education, Skills & Employment, Community Integration, Health & Well Being and Community Safety. The Balbriggan Leadership Group, provides oversight and stewardship for the plan's implementation. A 'Review and Renew' meeting of the Leadership Group was held in February. The next meeting will be held in March 2024 where the review and renewal of the Our Balbriggan Programme will continue to progress.



Tenders submitted to appoint a contractor for the Quay Street, Harbour & Environs Scheme are being evaluated. Following successful selection and appointment, the appointed contractor is anticipated to be on site in April 2024, the project is to be completed on a phased basis in 2025. Irish Water are currently on site in the Quay Street Car Park to complete upgrade works on the pumping station located there, with alternative car parking currently available at Bath Road/Balbriggan FC & Bremore Castle. Communications to this effect have been issued on social media and other local channels in Balbriggan.



Part 8 Planning Permission for 2-4 Dublin Street was granted approval at full Council in October and the project has now progressed to detailed design phase. 2-4 Dublin Street is to be transformed into a new Creative Hub with 8 workspaces at 2 Dublin Street and an ancillary connected space at 4 Dublin Street which will support STEAM education, training and enterprise activities supported by SMART Balbriggan and the Fingal Arts Office.



Demolition works on 14 Bridge Street (house known locally as Keelings) have been completed and a temporary Pocket Park has been installed. Demolition contractors are on site and have implemented a programme of works to demolish the rear of the De Bruns Buildings. The front facade of the buildings facing Bridge Street are to be kept to maintain the street line. An Integrated Design Team has been selected and will look at preparing a design based on best possible uses and options in line with site constraints. Early and on-going stakeholder engagement will take place shortly and throughout the design process.



Donnelly Civil Engineering Ltd and MWP Engineering have delivered a package of improvement works at Balbriggan Harbour. The main Harbour upgrade works and shoreside services are complete, with some lighting improvements awaiting final completion further to new electricity connections.

The programme office met with Project Management Consultants in February to initiate the phase 2 element of the Balbriggan Tidal Pool and Swimming Platform Feasibility Study. Potential funding options and funding models will also be investigated and identified and necessary environmental studies, site investigations will form part of the phase 2 stage.

An Internal Project Team has been established from the Town Regeneration Office, Our Balbriggan and FCC Architects to progress the Boathouse and Bathhouse project. FCC has met with local stakeholders and potential end users for the Bathhouse and Boathouse. Enabling works commenced in February. Works include full surveys and assessment of the site, which will inform the full works design and planning proposal.




A comprehensive Balbriggan Public Realm Strategy - Masterplan & Design Guide and a Balbriggan Active Travel & Transportation plan are complete with both expected to be published shortly.





The Our Balbriggan Office continues to generate regular and unique content across all social media channels, Facebook, Twitter, Instagram, LinkedIn with over 5.1k followers on Facebook.





#### **Town Centre First - Lusk**

The structure, membership and Terms of Reference for the new Lusk Town Team were agreed in the third quarter 2023. Together with the Town Team there are three Pillar Groups representing the Community, Business and Economy and Public Realm / Climate Action & Sustainability (to include Vacant & Derelict Buildings). Consultants to support the preparation of a new Town Plan were appointed to work with the Community, Businesses and Public Realm Pillars in Lusk to get their views for inclusion in the new town plan. Work on this has progressed well, with a draft of the new Town Centre First Plan for Lusk currently being reviewed, with final sign-off on the plan expected shortly. The plan will then be published.





#### **Town Centre First - Rush**

At the National Town Centre First Day held 28<sup>th</sup> February in Limerick, the Minister for Rural and Community Development, Heather Humphries T.D. announced that Rush had been selected as Fingal's second Town Centre First Town. The Town Regeneration Office welcomes the selection of Rush as a Town Centre First Town and will be engaging with the Local Elected Members, the Community and the Business Sector in Rush to establish a new Rush Town Team. This new Town Team will prepare a new Town Centre First Plan for Rush.

#### **Town & Village Renewal Schemes**

The 2023 Town and Village Renewal Scheme was launched during the Summer 2023 and the Town Regeneration Office submitted 5 applications to the Department of Rural and Community Development for consideration in November. The outcome of these applications is awaited.



In 2023, the Town Regeneration Office completed the implementation of projects in Rush, Donabate, Oldtown, Naul, St. Margaret's and Balrothery. With respect to these 6 schemes, the local authority has invested €282,276.00 in total funding drawn down from the Department of Rural and Community Development to support the revitalisation of our Rural towns.



#### **Outdoor Recreation Infrastructure Scheme**

An application under the Outdoor Recreation Infrastructure Scheme for a feasibility study for facilities for sea swimmers in Skerries was successful in November. As of February 2024, the Town Regeneration Office has commenced the study process by engaging with local stakeholders, gathering and collating feedback to inform future options and study scope.


#### **Urban Regeneration Development Fund Call 3**


In 2023, the Town Regeneration Office was successful in securing €7 million for a new revolving fund that will acquire vacant or derelict properties to renovate, bring back into use and sell back into the market for housing purposes. An initial 19 properties under this fund have been approved for inclusion by the URDF Call 3 Fund administered by the Department of Housing Heritage and Local Government. A further 5 properties were approved by the Department of Housing, Heritage and Local Government in February. These are being assessed and progressed where appropriate. A further 20 properties are under consideration to be added to the list of properties going forward.

#### **Derelict Sites**

33 statutory notices have issued to owners of Derelict properties to the end of February 2024. This equates to 71% of the total notices issued in 2023 and the team are gaining momentum as they work through referrals throughout the County. 25 new sites have been identified to the end of February 2024 which are actively being progressed in line with the Derelict Sites Act 1990.





The Derelict Sites Section actively encourage the reporting of potential derelict sites. Referrals can be made by accessing the Report Form on Fingal County Councils public website and emailing the completed form through to derelictsites@fingal.ie

#### **Upcoming Fingal Business Briefing Sessions**



A second Business Supports Briefing for 2024 was held on 6th February where 60 small business owners and entrepreneurs heard about supports and services available to them. The briefings outline services and supports for small businesses and individuals seeking to start their own business, through the LEO and other state agencies. 204 individuals attended a business briefing in 2023. The next business briefing is scheduled for Local Enterprise Week Friday 8th March at the Carlton Hotel Dublin Airport.

#### **Food Supports**



LEO Fingal is running the next Dublin region Food Starter programme in April 2024, working with small food producers who are starting out on their food business journey. The Food Starter programme is the industry specific Start Your Own Business training for the food sector. As part of the programme, businesses are given a thorough grounding in what is required to set up their business, the health and safety implications and how to capitalise on market opportunity. Participants also benefit from the network of other food businesses on the course and leave with a new set of mentors and business advisors to help them on their journey. As part of Local Enterprise Week, we are running a Meet the Food and Drink Entrepreneurs event for all Dublin food producers, featuring successful food producers who will share their experiences with the audience.

#### **Evaluations and Approvals Committee**

The Evaluation and Approvals Committee (EVAC) approved €174,990 in funding across six Business Feasibility, Priming and Expansion Grants in February 2024. Four Technical Assistance for Micro Exporters grants to the value of €10,000 and two Digital for Business grants amounting to €9,000. The next EVAC meeting will be on 20th March 2024.

### **Management Development**



# ACCELERATION



The Leadership for **Business** Acceleration Programme provides an exceptional opportunity for SME Owners and Managers to build on the necessary leadership skills and knowledge needed to successfully compete in existing, new and international markets. This highly successful "International Best Practice" training programme will run from March - May 2024 and is delivered to small groups by way of onsite skills development workshops and online workshops. As part of the programme, the owner manager participants each produce Work Based Assessments which document their strategic plan and acts as a living document as well as a point in time reference for where their business is now and the actions they need to take to grow. Applications will shortly open for the programme.

#### **Energy Efficiency Grant Scheme**



Applications are open for the Energy Efficiency Grant Scheme, the Scheme enables small businesses to invest in technologies and equipment to make their businesses more energy efficient. The grant will cover up to 50% of the costs to a maximum amount of €5,000. The goal is to reduce the impact of small businesses on the environment and help them to reduce costs to enable them to become more competitive. As part of the process, applicants complete the Green for Business Programme, a customised initiative whereby the business develops a strategy to become sustainable.

#### **Trading Online Voucher Scheme**



An initiative under the Government's National Digital Strategy, the Trading Online Voucher (TOV) scheme supports small businesses by allowing them to enhance their online offering by providing a grant of up to €2,500 for ecommerce and digital marketing activities, as well as giving businesses a better understanding of how they can exploit E-Commerce opportunities for their business. In January 2024, a total of 18 applications have been approved in the amount of €38,504. The next Trading Online Voucher seminar will be held online during Local Enterprise Week on 7th March 2024

#### **Business Advice Clinics and Mentoring**



LEO Fingal provides one to one business support services through Business Advice Clinics and a Mentoring programme, both online and in person. These services are heavily subsidised by LEO and provided free of charge to small businesses. The Fingal mentor panel consists of a variety of skilled and experienced mentors from a range of business backgrounds. So far this year, over one hundred clients have availed of one-to-one advice in our Business Advice Clinics. The Mentoring Programme has already got off to a busy start, with 63 clients receiving expert mentoring so far this year.

#### **Microfinance Ireland Loans**

LEO Fingal provides a loan scheme through its partnership with Microfinance Ireland, with loans of up to €25,000 per approved applicant. LEO Fingal is actively promoting the availability of loans from businesses that have difficulty raising finance from their bank. Applications are processed and assessed by LEO Fingal and submitted to MFI (Microfinance Ireland). Applications submitted through LEO Fingal are eligible for a reduced interest rate. LEO Fingal has processed and submitted 5 MFI loan applications to date in 2024.

#### **Training and Events**

2024 training is continuing apace with over 530 participants in events year to date. The second Start your own Business course is starts on February 29th bringing to 24 the number of participants at the multi-day event YTD. The Social Media and Digital Marketing QQI course kicked off in January and is still ongoing with a class size of 12. The second Social Media course is running in Local Enterprise Week. Fingal LEO is running a Startup Bootcamp in Local Enterprise Week which is an intensive one-day course for those who wish to invest in their training for starting their business.

#### **Internationalisation and Export Development**



Five Fingal businesses have been selected to participate in the 2024 Export Development Programme. The purpose of this new programme is to provide clients with the skills and the confidence to identify, target and exploit new business opportunities in the Benelux Region. In addition, the TAME (Exporter) grant enables small businesses to explore and develop new market opportunities by providing up to €2,500 to businesses investigating and researching export markets. Four Fingal businesses have been approved for Export Grants in 2024 to date.






## - Annual Changes in Licencing Numbers

\*sharp increase in 2020 is due to major projects being completed while roads were quieter during the COVID pandemic.







## Road Opening License's

The Licensing unit continues to process and manage the licensing system for the County. Applications are allocated by area for examination and conditioning which includes reviews of the existing carriageway, footpaths, cycleways, and grass verges. Applicants submit temporary traffic management plans for review to ensure all works are carried out safely within the public domain. Road Opening Licences are a cross functional process for the department and are essential for the asset management of Fingal County Council Road network.

**183 Licences** were granted in the month of **February**, **56%** of which were granted by way of **automation**. Clerk of Works in each area continue to carry out regular inspections following road opening works by Utilities.





## **Casual Trading License**

Fingal County Council are currently accepting renewal applications for Casual Trading Pitches throughout the Administrative Area this covers the trading of Hot Food/Tea & Coffee/Ice Cream and Flowers.

Current Casual Traders have got the opportunity to renew their licence at the same pitch for 2024 many of which have applied to do so.

Any remaining pitches are currently being advertised on the Fingal County Council website where there is a high level of interest a lottery system may be required to determine which Casual Trader will occupy a pitch.

Any further applications that come in after the 26<sup>th</sup> of February deadline are being processed on an Ad – Hoc basis.

The Castleknock/Mulhuddart Operations Department is in regular communication with our traders and area inspectors to assist in delivery of quality service and ensure compliance.

## **Street Furniture Licences**



Fingal County Council has processed a significant amount of Street Furniture Applications for 2024 and licences are in the process of been issued. Similar to 2023 there is a high level of interest in securing a Licence for 2024.

The Castleknock/Mulhuddart Operations Department will continue to carry out site inspections in the coming months to ensure compliance throughout the year.

#### **Storm Water**

## Stormwater Capital Programme 2023-2025

Fingal County Council are continuing to progress projects recently adopted in the 2024-2026 Stormwater Capital Programme. The 3-year programme includes 17 projects estimated at approximately €2.5 million with this figure under review as the projects are developed. Below is a brief update in relation to the status of some of the projects that have commenced and planned upcoming projects.

## **➤ Howth Stormwater Culvert**

All Topographical, Manhole, Flow and CCTV Surveys are complete and satisfactory. WPB Optioneering report is currently under review by the consultant after which it will be issued to FCC for review. The Consultant Roughan O Donovan is preparing contract documents for the procurement of a GPR (investigations) contractor to enable design documents to be progressed. An updated programme is due.

## > Bath Avenue Storm Water Pipe

This project involved the laying of a new Stormwater pipeline along Bath Ave in Malahide to alleviate localised flooding and allow for future capacity. In total 235m of pipe was laid, with the existing network on Grove Road connected to the new network. The new SW pipe is tied into an existing outfall on the Coast Rd. A road closure is currently in effect and additional mobility and drainage works are ongoing. Full reinstatement works by McQuillan Contractors will commence on 11/03/2024.





#### - Burrow Beach

The proposed remediation of a surface water outfall pipe on Burrow Beach was scheduled to begin following the seabird wintering season around March 2024. However, delays with procurement for the supply of anchor blocks have pushed back the start date until September 2024 or March 2025. Works will be executed by FCC Direct Labour with technical assistance to be provided by design consultants.



#### Wendell Avenue/Heather Walk

Stormwater sewer rehabilitation works in Portmarnock are now complete. In total 200m of collapsed sections of network have been replaced in the Dewberry Park, Wendell Avenue and Heather Walk estates. Trench reinstatement works are progressing. Following a tender process a contractor has now been appointed. Reinstatement works are planned for early March 2024.

## - Lusk Network Remedial Works

The above project consists of Stormwater infrastructure provision and improvement in the Lusk urban area. It will include second level/follow up investigation, surveys, non-invasive interventions jetting, root removal, pipe lining, replacement and new lay – using conventional cut and cover plus reinstatement of surface.

Currently the Direct Labour crew are upgrading sections of localised damaged pipeline. The works at the junction of **Treen Hill/Ministers Rd** are now complete. In total 60m of damaged and collapsed pipeline has been replaced with a 300mm diameter pipe, in the footway. Some reinstatement work is continuing.



Following additional CCTV surveys two sections requiring remediation along **Lusk Main St** have been identified. Works on these repairs will commence in late January. Sections of the network along **Station Rd & Dublin Rd** are currently undergoing camera survey works to examine its condition and confirm capacity. Most of the repair/replacement will be undertaken By Direct Labour with some input by contractors. The overall project is likely to take 24 months to complete.





## Clonsilla/Mulhuddart Network Improvements

Following historical reports of flooding additional CCTV surveys are being carried out to determine the condition of the Stormwater infrastructure in the **Rusheeney and Manorfield estates in D15**. So far, several large restrictions have been found and a manhole was completely blocked with household waste. Build-ups of concrete and collapsed sections have also been identified in other locations along the same network. Works are ongoing to carry out multiple trenchless repair works using a robotic cutting machine.


## - Carpenterstown Rd SW Pipe refurbishment

Following survey work and subsequent analysis completed in 2023, a Contractor will be engaged to carry out various remedial works including part liner repairs on damaged sections of the network along Carpenterstown Rd. Tender documents are currently being drafted. It is hoped to have a contract in place to allow works to start on site during April of 2024.

## - Storm Water Maintenance

Maintenance of the network and much of the capital works programme is generated by inspections which are tabulated on a Works Planner. The types and volumes of issues reported are shown in the chart.

## Storm Water Connections:

8 new connection applications including one diversion application have been processed to date in 2024.

#### Donabate

Quotations were sought to carry out maintenance work on the **Beaverstown stream** to remove restrictions and clear and overgrown ditch to create storage and to remove flow restrictions, thereby alleviating risk of road flooding. These works were undertaken in February 2024 and will enable further examination of the catchment to improve surface water management.



#### Assets

#### Ironworks

The Stormwater manhole cover and frame replacement programme for replacing assets at the end of life is ongoing. Covers and frames were recently replaced on highly trafficked locations in Lusk and Balrothery. Offline replacements were also completed in the Bun-a-Knock estate in the Naul.

## Water Quality

Balbriggan – Water Quality Improvement

A Contractor has been engaged to carry out reinstatement works following the removal of previously misconnected properties to the Surface Water network in **Flemington**. Full reinstatement is planned for completion in Q1 of 2024.

Following CCTV surveys in **Clonard Court** area of **Balbriggan** a collapsed section of pipe was found. This has since been excavated and replaced with a new section and all restrictions have been removed.





## Seagrange park

Assistance is still being given by the Storm Water Unit to *Baldoyle Tidy Towns* who had secured funding for a Biodiversity project on the Seagrange Park stream, Baldoyle.

Recent inspections have focussed on a local culvert to determine the source of contamination to the surface water network and further sampling is being carried out to support this investigation.

## **Planning Applications**

There have been 101 planning applications received from 1<sup>st</sup> January 2024 to 31<sup>st</sup> January 2024, 31 applications were invalid leaving a total of 70 valid applications. The volume of applications received by Local Electoral Area (LEA) is detailed in the table below.

From 1st January 2024 to 31st January 2024. There have been no Large-scale Residential Development (LRD) full applications made to the Local Authority in January 2024. From 1st January 2024 to 31st January 2024 two decisions have been made on Large Scale Residential Developments. Of these two decisions made, both have been to grant Permission. As these are amendments only the overall number of units granted to date remains the same (3,791 Units)

An Bord Pleanála have issued no decisions on SHD applications in the period from 1<sup>st</sup> January 2024 to 31<sup>st</sup> January 2024. There are five SHD's (4,577 units) remaining with An Bord Pleanála for decision.



## **Planning Decisions**


A total of 110 planning decisions have been issued to 31<sup>st</sup> January 2024. There have been 93 decisions to grant permission (85%) and 17 refusals of permission (15%). Included in the 93 grants there have been 7 grants of permissions in respect of single house construction, 43 grants of permission for domestic extensions/works, 16 commercial grants of permission, 3 retail grants of permission and 3 grants of permission in respect of housing developments of which 3 relate to developments of 2 – 20 units.

## **Building Control Admin**

In January 2024, there were 186 Building Control submissions made via the BCMS together with 1 hard copy FSC and 1 hard copy DAC submission. This was made up of 92 Commencement notices, 23 Compliance of Completion Certificates, 39 Fire Safety related Certificates and 32 Disability Access related Certificates.

Commencement notices and Compliance on Completion Certificates are submitted through the Projects module on BCMS. Fire Safety, Disability Access, Regularisation and Dispensation/Relaxation Certificate applications can be submitted online via the Applications module on BCMS and we are also still accepting hard copy applications directly into the office. Most applications are now being submitted via the online system.

The Building Control Admin team processed 244 decisions in January 2024 relating to Fire Safety and Disability Access Certificates. This was made up of 63 decisions to grant and 181 extensions of time.



## **Strategic Policy Unit**

Local Area Plans, Masterplans and Framework Plans

In July, the first round of Plans falling out of the development plan was agreed. This comprises Swords and Flemington LAP's, the Dunsink Plan, Kilbarrack and the Old School House Masterplans and the Stephenstown, Folkstown and Clonsilla Framework Plans.

Work has begun on the Flemington Local Area Plan and the Clonsilla Framework Plan.

## Flemington Local Area Plan

The proposed LAP boundary has been designated in the Fingal County Development Plan 2023-2029. Local Area Plans play an important role in setting the framework for the achievement of integrated and balanced communities within a specified area. They seek to provide the optimal development framework to ensure the protection enhancement of the existing areas, key features and the environment within an area, while providing for a high quality living environment through the use of robust urban design principles. Fingal County Council has commenced the consultation process which is a key feature of the Local Area Plan process. The pre-draft consultation period ran from 1st February to 1st March. A targeted workshop for local members, landowners and community groups took place on Friday 2<sup>nd</sup> February and a very well attended information drop in session for member of the public was held on 19<sup>th</sup> February, 4pm – 7pm in Bracken Court Hotel, Balbriggan.


#### Clonsilla Framework Plan

The Fingal Development Plan 2023-2029 provides for an objective to prepare a Framework Plan for lands at Clonsilla (Plan Ref. FP 13.C).

The proposed FP boundary has been designated in the Fingal County Development Plan 2023-2029 and includes an area of land south of Clonsilla Road/Larch Grove, bounded by Diswellstown Road to the east, Callaghan Bridge to the west and extends just south of the railway tracks.

The Kellystown Local Area Plan, located to the south of the Clonsilla Framework Plan area, was adopted in January 2021 and provides for the future development of that particular area. A specific and separate Masterplan will also be prepared for the Old School House area in the near future.

Public consultation is a key element in the preparation of the Clonsilla Framework Plan and the pre-draft consultation period ran from Tuesday 6<sup>th</sup> February to Tuesday 5<sup>th</sup> March. A targeted workshop for local members and community groups took place on Tuesday 6<sup>th</sup> February and a separate information drop in session for member of the public was held on 19<sup>th</sup> February, 4pm – 7pm.



#### Donabate Framework Plan

Fingal County Council has prepared and published a Draft Framework Plan for Donabate, County Dublin. The draft Plan provides a vision for the Donabate town centre which will improve and enhance the Main Street area and guide careful urban improvement. The Plan will provide an opportunity to improve the public realm and setting of the town and will guide future funding opportunities. This Plan highlights the distinctive character of Donabate, its setting on the peninsula, current issues pertinent to Donabate and, lastly, outlines a programme of actions which must be agreed with the community.

The Draft Donabate Framework Plan, including SEA Statement and Screening Report for Appropriate Assessment was on public consultation until Wednesday 21st February and is before the March meeting for agreement.

#### Residential Zoned Land Tax

The Residential Zoned Land Tax (RZLT) is a tax aimed at activating serviced and residentially zoned land for housing. Local authorities are responsible for identifying the land that is subject to RZLT.

On 1st February 2024, Fingal County Council published the annual draft maps for 2025 identifying land currently in scope for the tax, land proposed to be removed from the current scope and land proposed to be added for the first time. Landowners may make submissions and submit rezoning requests regarding land identified on these maps. 1st April 2024 is the last date to make submissions regarding removal of land from the 2025 annual draft maps if considered to be outside scope, including submissions by landowners in support of the exclusion of their land where it is identified on the annual draft map that the local authority proposes to exclude such land, or challenging the date of inclusion. Submissions may also be made recommending land be included on the maps. The 31st May 2024 is the last date to make a rezoning request regarding land identified on the 2025 annual draft map

Fingal County Council's final RZLT map for 2024 is now available on our website and at our public office at County Hall, Main Street, Swords. The map includes lands that meet the relevant criteria for inclusion on the map as set out in the current legislation.

- There were 19 Building Control Inspections in January 2024 with 31 buildings inspected.
- There were 3 developments Taken in Charge in February 2024 (Barnageeragh Cove in Skerries, Vauxhall Street in Balbriggan and Drynam Hall in Kinsealy).
- There are 4 developments scheduled for Taking in Charge in April 2024 (Riverwood Gardens Carpenterstown, Emsworth Kinsealy Lane in Malahide, Golden Ridge phase 2 in Rush and Coopers Wood in Kinsealy).
- Sustainable Drainage System (SuDS) The Fingal SuDS guidance document (Green/Blue Infrastructure for Development) has been reviewed to include changes in technical standards. This document along with the SFRA documents have been incorporated into the new development plan.

The GDSDS has outlined SuDS as a sustainable way to manage surface water as we prepare to meet the challenges of climate change. This example of Millers Glen in Swords, shows an example of surface water being held onsite, providing treatment via appropriate planting, and then discharging at greenfield runoff rate. This is a move away from the traditional method of collecting all surface water via piped systems which can often no longer manage the intense rainfall's being experienced.

Multi-Party Framework Agreement for the preparation of Surface Water Management Plans (SWMP)

The procurement process has begun for the new Multi-Party Framework Agreement for the preparation of Surface Water Management Plans (SWMP) for the new County Development Plan. The SAQ for the above framework was posted on eTenders with a closing date for tender submissions set for 30/09/2022. The tenders were assessed and a recommendation for progression to the next phase has taken place. WSFP are working with the planners to identify areas for in inclusion in the framework.

## **Transportation Planning**

## PSI 001 Snugborough Interchange upgrade

The Snugborough Interchange is currently programmed to be completed in late May 2024. The last element of the scheme to be completed will be the shared active travel route through the underpasses. The scheme has been delayed mainly due to the complexity of the scheme and the number of utility diversions involved. During Q1 refurbishment works have been carried out on the old bridge which include repairs, rewaterproofing, and some surfacing. Utility diversion works in the area near the underpasses have continued. Boundary wall construction at Waterville road, traffic signal installation and construction of footpaths have been carried out. Some of the current works which include surfacing, duct installation and road marking are being carried out in at night to limit impact on traffic flow. New traffic signals and the new junction layouts/ pedestrian crossings will be put in operation during April. Updates will be posted on the scheme web site www.snugboroughinterchange.ie



## PSI 002 Ongar Barnhill Road

Bam Civil Ltd. have completed the south abutment base and columns for the bridge over the railway line. The installation of culverts to carry a stream under the proposed road is underway. A consultation for extinguishment of public right of way on Barberstown Lane North was initiated by FCC to allow for the construction of the road Consultations | Fingal County Council Online Consultation Portal. Improvement works will be carried out to Barberstown Lane North and South during March in conjunction with the scheme. An update site briefing for local Councillors has been arranged for mid-March. ## PSI-039 R132 Connectivity Project

Consultation with the National Transport Authority and with Transport Infrastructure Ireland regarding the connection with Metro Link is ongoing with Monthly meetings. Following a meeting with a developer on a new access onto the R132. Modelling the impact of this junction is currently being undertaken by consultants. Detailed design stage is underway and progressing as programmed. Meetings continue to be held with the various department of Fingal County Council to gather information for detailed design. The tender documentations has been prepared for CCTV drainage contractor and another tender is currently been also prepared for the Ground Investigations to inform the detailed design process and de-risk the project.

PSI-005 Harry Reynolds Road Pedestrian and Cyclist Route

Construction works is progressing on the Harry Reynolds Road Pedestrian and Cyclist Route for this key infrastructure project for Balbriggan. The Project is now approx 45% completed. The work is ongoing and progressing well at three locations on the project on Hamilton Road, Harry Reynolds Road just south of the R122 and at Moylaragh Road. Additional meeting with the ESB in Feb onsite for the new connection points at 12 Controlled crossing points along the project. 

## PSI 063 Granard Bridge

A tender was published recently for Engineering Consultancy Services for a Pedestrian and Cycling bridge over the Maynooth Rail line and Royal Canal at Granard Bridge on the Castleknock Road and will form an integral part of the walking and cycling route for Blanchardstown to Phoenix Park which is a proposed route in the NTA's Greater Dublin Area Cycle Network Plan. The tender forms part of the initial project for the Engineering Consultancy Services Framework for Dublin 15 Pedestrian and Cycling Route Projects which is currently at stage 2 of the procurement process. The current closing date for submissions of tender is late March but this be extended if tenders request a extension.

PSI – 004 Royal Canal Urban Greenway

Dialogue continues to be held with key stakeholders the National Transport Authority and Waterways Ireland along the route of the greenway to ensure a coordinated, high quality final design is achieved at interfaces between existing facilities and the proposed scheme.

As the project is currently at pre-planning stage there is a requirement to ensure the project preliminary design complies with the new cycling manual which was recently published. Therefore, this has resulted in the need to revise the preliminary design drawing for the project. These changes in the preliminary design requires the need to hold additional meetings with all the relevant key stakeholders to agree the revised design. These meetings will continue over the coming monthly to ensure a coordinated, high quality final design which compiles with the new cycling manual is achieved at interfaces between existing facilities and the proposed scheme. Landowner searches and land referencing are ongoing also.

Following completion of the preliminary design, all the required documents including the Environmental Impact Assessment Report will be prepared for a planning application to An Bord Pleanála. As a result of the additional requirements the project team has carried out a re-appraisal of the timeline of the project given the additional design and meetings to be held with key stakeholders has determined a revised estimated programme for submission of a planning application to An Bord Pleanála to be in Q4 2024

## S2M Pedestrian and Cycle Scheme

The preliminary design drawings are being finalised. The recently published Cycle Design Manual has led to some improvements being incorporated into the overall scheme design including revised layouts for crossings and bus stops to comply with the new standards. A surveyor has recently completed topographical surveys of public and private lands within the proposed scheme. Ground Investigation Works will be required along the route at all locations where new structures are being proposed. These works have been procured and are scheduled for early 2024. A tree surveyor will be procured in the coming months and a survey of all trees along the proposed route will be carried out. Following this process, the preliminary design can be finalised, and documents will be prepared for a planning application to An Bord Pleanála. Engagement with potentially impacted property owners, businesses and stakeholders is ongoing. A search of unregistered lands is ongoing for production of the deposit maps for the land acquisition.





## Kinsealy Walking and Cycling Routes

The consultancy framework for various Swords & Kinsealy projects with the initial project being the Kinsealy Walking and Cycling Routes was recently awarded to Barry transportation. The appointed consultants are currently progressing the Kinsealy Walking and Cycling Routes Projects. The Options Selection phase is progressing on two routes, Kinsealy Lane and Chapel Road/Station Road to determine the draft preferred routes. Traffic surveys have been completed. Topographical surveys are ongoing which.

## Fingal Coastal Way

13 SUBMISSIONS

Meetings have commenced between the Independent Agronomist and affected landowners with farming and horticultural businesses. Searches continue for potentially affected landowners who have not been identified yet.

A local consultation remains open in the Quay Street Area of Skerries and will run to the end of March. The consultation is asking residents for their preferences on traffic management options to facilitate the Fingal Coastal Way. The responses will assist in the selection of designs to be developed further.

The topographical survey of public lands is now complete and the survey data will allow designs in the town and village centres to progress. Further local consultations will be held as details are developed.



## Broadmeadow Way Greenway

Design options for the northern causeway have been developed using recently acquired ground investigation data from the ground investigation (GI) contract conducted over the summer months. These options will then be workshopped with the NTA and Irish Rail to seek approval to proceed with single preferred design option that meets the project objectives and ensure the safety and integrity of the railway causeway.

Tender competitions are complete for a number of sub-elements of the project. Irish Rail have awarded the following contracts which will allow the construction of the main bridge across the estuary:

- OHLE strengthening works to the foundations of the overhead electrical systems associated with the Dart which must be completed in advance of the bridge and ramp construction awarded to Global Rail Services Ltd.
- Manufacture and supply of precast concrete units for the 12-span 180m long precast bridge deck units awarded to Shay Murtagh Precast Ltd.
- Main estuary bridge Civil Engineering Contract awarded to Jons Civil Engineering Ltd.

The Underwater Archaeology Unit in the Department of Local Government and Heritage have requested that Fingal County Council undertake an underwater archaeology desktop assessment as part of planning and foreshore commitments. A tender competition was for this piece of work was issued to the market and Archaeological Management Solutions were awarded the contract. The study is due to be completed by the end of March.

The Department of Housing, Local Government & Heritage has advised that the Minister has approved the granting of the Foreshore Lease, Licence and Consent and the application has now been referred to the Chief State Solicitor's Office for drafting and execution. This is the final step for Foreshore Licence Approval.

Works to strengthen the foundations of the OHLE masts have commenced at Bisset's Strand, Malahide. This work is to be completed in advance of the construction of the main estuary bridge. In accordance with the conditions of planning, monthly bird surveys are currently being carried out and will continue until April.

#### Church Fields Link Road

Works are continuing on phase 2 of the Church Fields Link Road and Cycle Network project, including the upgrade and reconfiguration of the existing Wellview Avenue, Damastown roundabout and the installation of 670m of high-quality pedestrian and cycling facilities through the eastern parklands linking up with existing networks and future proposed facilities in the vicinity.

## Turvey Avenue & Portrane Road, Donabate

Fingal County Council has lodged an application to An Bord Pleanála (ABP) for a Compulsory Purchase Order (CPO) for the Portrane Road Enhancement Project. Two landowner objections have been lodged with ABP in this regard. Further consultation regarding landowner concerns has resulted in one of the landowners withdrawing his objection. Consultation continues with the other landowner to try to reach an agreement. The project involves works to widen the existing narrow footpath on the northern side of Portrane Road in order to provide a suitably wide and safe footpath for pedestrians to use in the vicinity of two national schools (St. Patrick's Boys National School and Scoil Phádraic Cailíní).

The project also involves works to provide safe pedestrian crossings and appropriate traffic calming facilities. Subject to approval from An Bord Pleanála, the CPO will allow Fingal County Council to purchase privately-owned land that is required to widen the path and deliver the project. Fingal County Council awaits the decision of An Bord Pleanála in this regard.

Separately, Priority Construction Ltd, working on behalf of Fingal County Council, has commenced work on the Turvey Avenue Footpath Enhancement. As part of this project, a new footpath is currently being built on the northern side of the road where no footpath previously existed. The new footpath will provide a continuous and safe walking route along Turvey Avenue for pedestrians travelling to and from Donabate Village and train station. The project also includes drainage improvements, widening of an existing footpath nearby, resurfacing of the road and provision of new line markings, speed ramps and signage. Stop-Go traffic management is in place on Turvey Avenue with marshals on hand to bring vehicles and pedestrians safely around the works area. The project is due to be completed this summer.

## Donabate Pedestrian Bridge

License agreements are being finalised with the developers of adjacent lands to facilitate access to, and construction of the bridge. Procurement for a main contractor for the works is nearing completion. All necessary documents have been submitted to the NTA for approval to award the contract and for funding for 2024. Construction is expected to commence in Q1 2024.

## **Donabate Transport Projects**

Fingal County Council has appointed Roughan and O'Donovan, a leading multi-disciplinary consultancy firm, to provide engineering, planning and environmental services for the Donabate Transport Projects, which comprise a number of major projects with the objective of improving transport and active travel infrastructure and road safety on the Donabate-Portrane peninsula.

The projects include:

- Phase 2 of the Donabate Distributor Road project, to improve access to Donabate and Portrane from the M1-Lissenhall Interchange for all road users, particularly vulnerable road users such as pedestrians and cyclists;
- Blakes Cross Junction Upgrade, to provide a safer junction layout that caters for both motorised traffic and active travel modes of transport such as walking and cycling;
- A study of the M1-Lissenhall Interchange, in collaboration with TII, to assess all technical and operational traffic issues associated with this strategic motorway junction;
- 7no. Active Travel Routes which encompass a number of related local projects which aim to increase local connectivity for pedestrians and cyclists.

Work on the initial data-gathering, concept development and option assessment stages of the Donabate Transport Projects is underway including topographical surveys of relevant areas of Donabate. Fingal County Council and Roughan and O'Donovan are currently analysing traffic data and carrying out traffic modelling on the M1-Lissenhall Interchange. Separately, a number of potential route options have been identified for Phase 2 of the Donabate Distributor Road. These options are shown below and will be subject to multi-criteria assessment to determine the preferred route.



Further stages of work, relating to environmental assessment, planning consent, etc. will follow on in subsequent years as appropriate.

## Parks & Green Infrastructure Division

- The new playground at Lanesborough Park, Meakstown (illustrated below) is now at Practical Completion and will open to the public in the coming weeks.
- Hansfield Park, Clonsilla including the new playground has now been taken in charge.
- Works on the new playground and associated park improvements at Cardy Rock, Balbriggan will be completed during March.
- Works on the Library Garden and playground at Garristown will commence during March.
- Plans for the development of the Rathmore Recreational Hub in Lusk will be submitted to An Bord Pleanála for planning approval during March.
- Works on the historic Brick Arch in the Ward River Valley are now fully completed.

## **Balleally Rise, Lusk**

On February 27<sup>th</sup>, Fingal County Council announced a new affordable home purchase scheme in Balleally Rise, Lusk. ## **City to City Exchange**

Following a successful collaboration between the Housing Delivery team and the Economic, Enterprise, Tourism & Cultural Development County Council were Department, Fingal successful in an application for funding under the European Urban Initiative City-to-City exchange programme. The funding is facilitating a learning exchange between Fingal County Council and Helsinki City Council in March and May 2024. Housing Europe recommended Helsinki as an exemplar for affordable housing initiatives in Europe. The city of Helsinki has a long track record of house building with the ability to influence housing supply as well as affordability. The City Council targets a balanced range of housing options for inhabitants while not being dependent on the market for delivery and also not excluding the private sector. It also prioritises new developments to be low carbon while actively retrofitting existing housing stock to become more energy efficient.

## Housing Asset Management Report Energy Efficiency/Retrofitting Programme

Fingal County Council's Energy Efficiency Retrofit programme is progressing well. The 2024 Programme has commenced with Strandmill Phase 3.

Investigative works are ongoing in several other housing estates across the county to include them in this programme.

## **Housing Assistance Payment (HAP)**

HAP continues to be the primary source of rent support for those in private rented accommodation. Fingal County Council has set up over 48 new tenancies in 2024 to date with approximately 3975 tenancies set up since HAP began in 2017.

The HAP team is on hand to deal with any queries from applicants and landlords in person at the Housing Department in the Fingal County Council Blanchardstown Office, by phone at 01 8905000 via the CCU or through email at <a href="https://hap@fingal.ie">hap@fingal.ie</a>.

#### **Rents**

The new rent review process continues, and tenants are required to return their Rent Assessment Form with the relevant documents so that an assessment can be carried out and the correct rent charge applied to the account.

The Rent Arrears team is working methodically through accounts in substantial arrears to encourage tenants to engage with the Council in reducing their arrears. In cases where there is no engagement, despite repeated efforts. proceedings will progress through the legal arena, and to date, the Rents Section has secured two Possession orders with 5 others currently before the courts. We have recently resolved one case to a satisfactory conclusion for both the tenant and the council. Regarding the two possession orders secured, both tenants are engaging with the team to address their areas.

The Rents team encourages any tenant who is having trouble paying their rent to engage with the Council to examine possible solutions. However, there are instances where tenants do not engage or make alternative payment arrangements, and, in those situations, the Council needs to take further action.

## **Housing Loans**

The Local Authority Home Loan (LAHL) is a government-backed mortgage for first-time buyers and certain other applicants who are unable to obtain home loan financing from a commercial lender. Interest rates are fixed for the term of the loan and loan terms are available for up to 30 years. The LAHL can be used to purchase new-build homes (including affordable homes); second-hand homes & self-build.

## **Eligibility Criteria:**

- Income Limit Single Applicant = 70,000 / Joint Applicants = 85,000
- Employment 2 years continuous employment / if joint application with a second earner, second earner to be 1-year continuous employment
- Residency legal right to live & work in Ireland & be habitually resident in Ireland
- Insufficient Offers of finance from 2 commercial lenders
- 10% Deposit 3% to come from savings
- Satisfactory savings record

## **Private Rented Inspections**

The inspections programme for 2024 has commenced. The inspections team are working towards inspecting 25% of the registered tenancies which is approximately 17,000 tenancies. We anticipate specific targets for 2024 and should receive these from the Department of Housing in the coming weeks. Currently, 927 inspections have been conducted in 2024, with over 400 of them being inspected in February.

The team will continue to work this year with the contractor improving and streamlining the process and utilising all avenues to ensure that compliance improves, and the target is reached.


## **Housing Needs Assessment**

Following Circular 26/2023 as released on 5<sup>th</sup> July 2023, the Summary of Social Housing Assessment (SSHA) is due for return to the Department of Housing Local Government and Heritage by 29<sup>th</sup> November 2023.

Letters Issued to applicants on 15<sup>th</sup> September to all applicants required to complete the SSHA. Following the successful launch of the Online HNA System in 2022, applicants have been advised to complete the assessment where possible online. This system went live on Monday 18<sup>th</sup> September 2023 with initial uptake positive and was closed on Wednesday 22<sup>nd</sup> November.

The assessment was complete with the Summary Return submitted to the Department on 28<sup>th</sup> November 2023.




The above chart depicts the total number of properties allocated since the beginning of 2024.


The chart below shows the breakdown of allocations per month.





In February 2024, there were a total of 38 full homeless assessments completed – comprising 14 families and 24 singles/couples.



During January 2024, of the 38 Homeless Assessments carried out, 35 % cases resulted from a Notice to Quit (NTQ) having been served. Most of the other presentations to the Homeless Section are from family/relationship breakdown (15%), living in overcrowded conditions (9%) and state that they cannot/will not return to the property. The remaining 41% comprise various reasons outlined in the chart below

### Emergency Accommodation (including Fingal County Council Family Hubs)

There continues to be a high demand for Emergency Accommodation across the region for both families and individuals.

#### **Rough Sleepers**

The Homeless Services Team continues to liaise with the DRHE Outreach Team regarding any reports of rough sleeping, to establish their names and circumstances and to offer support. Regrettably, some rough sleepers are reluctant to engage with service providers and may refuse offers to access emergency accommodation. Any rough sleeper who is willing to engage with the Outreach Team and/ or the Council will be assisted.

The Council will carry out homeless assessments and every effort is made to encourage them to avail of homeless services.

A weekly Rough Sleepers Coordination Group monitors the reports of rough sleepers. The reports come from various outlets, including the DRHE Outreach Team, Elected Representatives, the FCC Operations Department, and the general public.

There were no reported Rough Sleeping cases over the Christmas period and 8 reports in January 2024.

5 of these reported rough sleepers have been provided with suitable accommodation.

The progress of the remaining 3 cases are being monitored until the needs of the reported rough sleepers are met and the cases can be closed

### Dublin Street Outreach Service Tel: 01 872 0185 from 7 am to 1 am

The DRHE in partnership with Dublin Simon Outreach and the PMVT Intake team are assertively working on the streets offering accommodation to all rough sleepers.

The teams are very familiar with the locations of people sleeping rough across the Dublin Region and persistently work with individuals to support them into emergency accommodation. This process can take time and multiple contacts, as some people do not want to engage but the teams persevere with every person working to achieve a successful outcome.

The service operates 365 days a year, until 1 am. The Outreach Teams also ensure that people sleeping rough are linked with other appropriate health services such as addiction and mental health services to prevent further rough sleeping. PMVT's Housing First Intake team links rough sleepers to permanent accommodation with long-term support.

All emergency accommodation is now 24-hour, with food and shower facilities provided.

### National Housing Strategy for Disabled People 2022-2027 Implementation Plan

Action 1.2.2 of the National Housing Strategy for Disabled People 2022-2027 Implementation Plan states that Local authorities and the HSE must work together to plan and deliver on housing targets for disabled people in the community (including decongregation) in line with the forthcoming Disability Services Action Plan.

The HSE Mental Health Housing Coordinator from Parkgate Hall liaises with the Homeless Services Team on a monthly basis.

Currently 11 Fingal County Council clients have been identified, one was housed in January, a second is going through the nomination process after a property has been identified and the teams continue to liaise in relation to the other clients.

#### Homeless Action Plan 2022- 2024

The DRHE, with the approval of all 4 local authorities in the Dublin region, has finalised the Homeless Action Plan Framework for Dublin 2022-2024. This Plan is the first plan to be put into operation since Ireland signed the Lisbon Declaration on combatting homelessness in June 2021, which aims to end homelessness by 2030.

It will follow on from the previous Homeless Action Plan for 2019- 2021 and continues with the three key themes of **Prevention**, **Protection and Progression**.

The Plan was developed based on a detailed consultative process including submissions from various Stakeholders, interested organisations, Service Providers, Members of SPCs of the four Local Authorities, the Dublin Joint Homelessness Consultative Forum and the Statutory Management Group.

### Preventing Homelessness, Notices to Quit and Tenant In-situ Acquisitions

Fingal County Council is aware that households in the Fingal area who may have received a notice to quit, which is also referred to as a notice of termination, from their landlord may be worried or unsure of what to do.

Fingal County Council and the Dublin Regional Homeless Executive (DRHE) would like to advise anyone affected of the services that are available to them in these circumstances.

We strongly encourage tenants residing in the Fingal area, who have been issued with a notice of termination, to contact Fingal County Council as soon as they receive a notice from their landlord. The contact details for Fingal County Council are provided at the bottom of this page.

When the tenants contact Fingal County Council, staff in the Housing Department will take note of the termination date.

The Council advises the tenant to refer the notice to Threshold, a service funded by the DRHE to provide a Tenancy Protection Service for private renters in the Dublin Region, including Fingal. Threshold can also be contacted directly on Freephone 1800 454 454 or via their website <a href="https://www.threshold.ie">www.threshold.ie</a> which contains more information and advice on the validity of your notice.

The Council's first response will be to try to prevent homelessness. This includes assessing the person's position on the social housing list, providing advice on applying for Choice Based Lettings, advising the person on the level of Housing Assistance Payment (HAP) they may be eligible to receive, and, in some cases, assessing if the Council can acquire the dwelling where the tenants reside if it is being offered for sale.

Placement in emergency accommodation will be a last resort if no other alternative can be identified.

The Council has been engaging with tenants who have been issued with a notice of termination, as well as their landlords, and following assessment, 232 tenant in-situ properties are at the sale closed stage. A total of 82 properties are at the sale agreed stage with a further 77 cases in the negotiation process. In addition, the Council is assessing a further 302 queries concerning notices of termination and tenant-in-situ acquisition.

The Council will continue to deal with notice of termination queries and cases as expeditiously as possible and progress tenant in-situ acquisitions while taking account of circulars and guidance issued by the Department of Housing, Local Government and Heritage.

Fingal County Council continues to liaise with other Dublin and neighboring local authorities to deal with tenancy issues that may require an interauthority approach. In particular, we are working closely with our colleagues in the other Dublin Local Authorities on the implementation of the Government policy and guidance, with a focus on the needs of tenants.

Whilst the Council will, in the context of current circumstances, adopt flexibility in dealing with potential acquisitions of properties with tenants in situ, any acquisition is subject to appropriate due diligence and checks before any commitment is made to acquire, including, for example, determining that a valid notice of termination is in place, the tenant has a social housing need, and the condition and valuation of the property.

The Government has put forward options to allow tenants who are not eligible for social housing to remain in their homes, including schemes to support the purchase of homes and a Cost Rental in-situ Scheme. The Cost Rental Tenant-in-Situ Scheme is available for tenants who are not eligible for social housing and are at risk of homelessness. The DHLGH has advised that local authorities are to be the first point of contact for this scheme, but it is managed by the Housing Agency. Under the scheme, the Housing Agency can purchase a property and rent it to the tenant. Fingal County Council will undertake an initial assessment of the tenant's circumstances and refer details to the Housing Agency for consideration, where the tenant is at risk of homelessness and the Cost Rental Tenant-in-Situ scheme applies. The Housing Agency will then contact the landlord about the purchase of the property.

Where a tenant wishes to purchase their home from the landlord, local authorities can provide advice about the Local Authority Home Loan scheme. The Government is examining implementing a 'right of first refusal' for tenants to purchase their homes, as well as expanding the First Home shared equity scheme. The Council will be able to provide more information on these when available.

Works around preventing homelessness, assessing notices of termination, and responding to tenant and landlord in-situ queries are being led on by the Council's Homelessness section, taking a tenant-centred approach, supported by staff dedicated to dealing with tenant in-situ housing acquisitions.

#### TRAVELLER ACCOMMODATION PROGRAMME

Refurbishment works to the 5 Bay Halting Site at St Brigid's Lawns, Porterstown, Dublin 15 is ongoing. Works include replacing the existing welfare units with new modern units and upgrades to the onsite utilities.

Work has begun preparing the Draft Traveller Accommodation Programme 2025 – 2029. Letters of intent have been issued to relevant stakeholders with further engagement anticipated to take place over the coming weeks, with public consultation anticipated to take place regarding the Draft Plan during Summer 2024.

Regular site visits by Housing Inspectors continue all Fingal County Council Traveller specific sites while checking on vulnerable residents and advising on the continued support available.

Council officials continue to liaise and engage with the Traveller Community, Traveller Advocacy Groups, Welfare Services, Child Services, Mental Health Services and other services and agencies to resolve issues when and where possible.





The Council's Fingal Ukraine Response Forum chaired by the Mayor continues to meet regularly to co-ordinate the response of the various statutory agencies and voluntary groups in the county to assist the Ukraine community with the most recent meeting held on the 26<sup>th</sup> February 2024.

#### **Liam Rodgers Rest Centre**

The centre continues to provide accommodation and support to Ukrainian Beneficiaries of Temporary protection. In the main occupants are new arrivals to the country with various statutory agencies linked with the centre to provide support to the new arrivals.

Supported by the Council and the Peter McVerry Trust (PMVT) over **460 persons** have moved from the Liam Rodgers centre to OfferAhome\pledge accommodation across the county and country with arrangements finalising concerning further moves to OfferAhome\pledge accommodation. An additional **210 persons** have moved along to varying other forms of accommodation in the main to state contracted accommodation.

#### **Vacant Homes**

The Vacant Homes Team continues to engage with owners of vacant properties to encourage owners to bring them back into use and advise of schemes that are available to assist this with on-going follow up of properties reported as vacant to the Council and those identified by way of survey.

The Croí Cónaithe Refurbishment Grant Scheme is in utilisation to address vacancy and assist citizens in getting a home with increasing enquiries, applications, and grant approvals. The grant can also be used to bring a vacant property back into use for the private rented market.

#### Croí Cónaithe Vacant Homes Refurbishment Grant

On the 1<sup>st</sup> May 2023, the scheme was further extended with the eligibility criteria now allowing for properties built pre-2008 to qualify and grants increasing to €50k (vacant) and €70k (vacant and derelict).

The scheme now also allows for a grant for approved properties to be rented on the private market when refurbishment is complete. Before this change, the grant-approved property had to be the principal private residence of the grant. **105** applications have been received under the scheme with a steady flow of new applications, **54 of** which have been approved with further applications moving to the approval stage. In addition, staff are engaging with numerous other expressions of interest which have the potential to lead to further applications.

Promotion of the scheme is ongoing by the Vacant Homes Team who have been present at various Housing Information Events most recently the event held in the Crown Plaza, Hotel, Santry on the 1st December 2023 and at Donabate Golf Club on the 7th March 2024. #### **Donabate and Swords SAMH Groups**

The Community Development Office continues to support the Substance Abuse Awareness and Mental Health (SAMH) groups in North and Mid county. Meetings of the Swords and Donabate groups took place, last month with the focus mainly on the findings of the latest Planet Youth research on the emerging needs of young people in the county on issues around vaping, drug and alcohol use and creating safe spaces for young people to express themselves.

SAMH Donabate is organising a community-focused Hello How Are you Day in May on this issue and the Swords group is liaising with the Thrive project in Balbriggan, which promotes community-wide positive mental health, with a view to being a partner in the proposed Thrive initiative planned for Swords.

#### **Mourne Estate Development Working Group**



The Community Development Office is supporting local residents from the Mourne Estate Development Working Group to acknowledge the 50<sup>th</sup> year of the Skerries Estate in 2024. Several key stakeholders have committed to the group and are meeting once a month to plan a calendar of events for the year which is collectively known as "Mourne 50".

The group consists of several local FCC Councillors and representatives from Mourne Celtic FC, Scoil Réalt Na Mara, Mourne Estate Residents Association (MERA) and Foróige. So far events planned will include Street Feast, tree planting and landscaping projects with the co-operation of FCC Operations Department, historical photographic exhibitions, talks about the estate and a Family Fun Day in July with football tournament, similar to the 2023 event successfully led by Mourne Celtic FC.

### <u>Facilities Management</u> Works on Rush Multipurpose Youth Facility



Work is continuing at pace on the Rush Multipurpose Youth Facility, which is anticipating reopening in Q2 2024.

FCC have supported the project financially, alongside funding secured from LEADER, which funded the public realm element of the contract.

The centre has been closed since late 2021 when refurbishment works commenced.

The Board of Management are liaising with the Community Facilities Management Support Unit regarding re-opening initiatives, service delivery, governance and financial support. It is anticipated that the main building works will be completed by and reopened in May 24.

The building, once complete, will be an asset to the local community.

#### **Interagency**

The Community Development office actively seek to work in collaboration with agencies to maximise service delivery and resources to communities In January/February the CDO supported the delivery of the following:

### Balbriggan Demystifying Integration Conference

The Community Development Office is supporting Balbriggan Integration Forum on the development of a conference taking place on the 13th March 2024 to highlight the importance of 'Demystifying Integration'. It seeks to provide a platform for lived experience, challenges, and discussion on the meaning of Integration. Social Justice Ireland's Susanne Rogers and practitioner/scholar Fidele Mutwarasibo will be offering insights and direction throughout the conference.

Fingal Comhairle Na nÓg



Representatives from Fingal's Comhairle Na nÓg presented to the Mayor of Fingal, Cllr. Adrian Henchy and CE AnnMarie Farrelly in the Council Chambers on 14<sup>th</sup> February as part of a visit to County Hall. Following a presentation which was delivered by two of the youth representatives, there was an engaging discussion around youth spaces in the Fingal area, which is the Comhairle's work topic for the year.

Other topics addressed during the visit included young person's involvement with Sports, Arts and Housing in the county. There were plenty of questions for both the Mayor and the CE. The group are now busy preparing for Dail na nÓg in March. Six members will attend on the day which will take place in Leinster House.

There will be more planned engagements with those seeking election and the young Comhairle Na nÓg members around local election time and with the new Council representatives later in the year. Fingal Comhairle na nÓg is the recognised voice of young people in the county and it is important that they are consulted on the development of relevant policies and plans.

#### **Local Authority Integration Team (LAIT)**

The role of the Local Authority Integration Team (LAIT) is to provide integration supports to applicants for International Protection, Programme Refugees, those with refugee status, subsidiary protection, or permission to remain status and beneficiaries of temporary protection (BOTP) to enable them to live independently in the community.



In Fingal County Council, the LAIT team is based in the Community Development Office. The team comprises four new roles, and the interview process for these positions is now finished. The LAIT Coordinator and the LAIT Administrative Support Officer took up duty in January 2024. It is anticipated that the remaining two team members, Integration Support Officers, will be in place by the end Q1 2024. The team have begun planning and putting in place systems to support the work of the service. The coordinator and senior FCC staff are working with national and regional implementation and working groups and participating in a series of training sessions relevant to the work of the service alongside colleagues in the Leinster region.



#### **Age Friendly Fingal**

Age Friendly Fingal is committed to driving a collaborative, multi-sectoral approach which supports interventions that will significantly help to improve the quality of life of the current population of older people in Fingal and future generations.

#### **Cross Border Intergenerational Project**







Participants in our Cross-Border Intergenerational Projects in Balbriggan and Mayobridge, Newry met in Bagnal's Castle, Newry on Saturday 3<sup>rd</sup> February. While the meeting provided an opportunity for both groups to give an update on their projects, it was also a chance for engagement among the groups.

An open discussion on the impact of the project was very insightful with older participants in Balbriggan commenting positively on how they enjoy seeing the younger participants around the town, who wave from a distance or spend time chatting and have even introduced them to their parents.

One younger participant, spoke about how the project has changed her opinion of older people, and said that "older people are still living their first life". Through the interactions with older people in the project, she has learned that older people are individuals who continue to learn, develop new skills and interests, and continue to participate in civic and social activities as they age, just like young people.





#### **Active Travel**

NTA funding allocations for 2024 have not yet been finalised.

#### **Protected Cycle Lanes:**

#### **BLRS Area:**

#### **R132 Blakes Cross to Quickpenny Lane**

This project that is constructing nearly 4km of protected shared pedestrian and cycle facilities on both sides of the R132 Road is progressing to the final stages of works. Over 80% of the contract is now complete with the remaining works to be implemented in March/April. The contractor is programming works with suppliers to complete drainage and road resurfacing works on Kilhedge Lane. Installation of bollards, lane separators, line markings and road signage are ongoing as works progress. The project team and Director of Services recently met with agricultural and haulage representatives to discuss concerns raised in recent protest in relation to traffic lanes narrowed and difficulty large farming machinery is having navigating sections of the scheme. Engagement is ongoing with the local community and designers are reviewing issues raised and possible solutions. Weekly updates are provided to local councillors and through social media outlets.

#### **Seatown Road Swords:**

The Engineering Consultant is currently working with the Project Team to finalise the Non-Statutory Public Consultation Report, the Options report and detailed drawings and screenings on the final option. Once the documents have been finalised, it will be published on the Consultation Portal in the coming weeks. The project team are working towards going to the market in the coming months for a Contractor to progress to the Construction stage in 2024, subject to NTA approvals. This project will provide segregated walking and cycling infrastructure from the R132 at Swords through to the estuary and connectivity to Malahide along the estuary.

#### **Donabate Portrane R126 cycle paths:**

The Project Team are continuing to work collaboratively with our property section to progress the potential acquisition of lands along a section of the route to facilitate the progression of the proposed walking and cycling infrastructure from the end of the distributor road in Donabate along the R126 through to the coast at Portrane. Details of the preferred option are being finalised and once completed will be presented to the members at local ACM. Additional surveys are being carried out to establish further details to inform the design process.

#### Coney Hill Balbriggan R132 cycle paths:

The Engineering Consultant is currently working with the Project Team to finalise concept designs and options report to assist with stakeholder engagement. Further Topographical Surveys are underway to assist with the decision-making process on the preferred option.

This is a complex section of road as the road widths are narrow and confined. All options are being considered at present so that the preferred option can be established. Further details will be presented to Cllr's later in the year.

#### Pathfinder Pinnock Hill to Airport cycle paths:

The Engineering Consultant has developed Options Report and initial concept designs for review and agreement with relevant stakeholders before moving to the next steps. The appointed traffic survey consultant has completed the traffic survey to inform the design process. Consultation is ongoing with the relevant stakeholders including the DAA, NTA and Bus Connects project team. Further updates will be provided over the coming months, through this report and at ACM level.

### Howth-Malahide Area:

### **Baldoyle-Howth Protected Cycle Lane Scheme Phase 2**

The Active Travel Unit is currently reviewing funding requests for the 2024-2025 programme, including for a review of the existing road network in Baldoyle. This will include Willie Nolan Road, Brookstone Road and Main Street. It will comprise an advancement of a previous study for the improvement of pedestrian and cycle facilities on the existing road network. A brief will be developed for consultants in the coming months, in line with the Fingal County Development Plan, the Climate Action Plan and an Active Travel Strategy for Fingal.

Once a further study and preferred option has emerged from the process, it is envisaged that the scheme will progress, subject to funding from the National Transport Authority (NTA).

### Paddy's Hill to Broomfield via Naomh Mearnóg

The design brief for 'Concept Development and Options Selection' has been finalised for this connectivity project. Internal consultation with other FCC departments has taken place. The remaining tender documents are being finalised by the Active Travel Unit.

When these are finalised, the next step will be to run a tender competition to appoint a design consultant for the 'Concept Development and Options Selection' Selection.

Enabling works have been completed to provide connectivity from Paddy's Hill Car Park to St. Helen's Junior School and Limetree Avenue. This included tree surgeon works, footpath works, new access points to the school, ramps, table-top crossings, dropped kerbs and ramps on the carriageway on Paddy's Hill.

#### **Seapark Hill to Old Golf Course Link Park**

A brief, and tender documents are currently being prepared by the Active Travel Unit to progress this project from the design phases through to completion as soon as possible.

The design will incorporate feedback from internal FCC stakeholders and the local Resident's Association.

A temporary footpath has been constructed in December 2023, to provide safe access to the Old Golf Links site and paths through the park, providing safe connectivity to Seamount Heights.

The Developer on the Seamount Road side as recently reopened the access, which is now through the new development, closing the temporary footpath.

#### **Feltrim Road Cycle Infrastructure**

A design brief has been completed to bring this project from the 'Concept Development and Options Stage' to completion.

The remaining tender documents are substantially complete and are under review.

It is expected that the works will go to tender for a design consultant n Q1, 2024.

The route of the Feltrim cycle scheme is shown on the map below, commencing at Kettles Lane, along the Feltrim Road to Mountgorry Way and on up to the Swords Road Roundabout.

The Active Travel Unit of Fingal County Council proposes to engage a consultant to provide multi-disciplinary consultancy services for the provision and improvement of infrastructure for pedestrians, people on cycles and other vulnerable road users.

The study area is from the Mountgorry Way/Swords Road roundabout via Mountgorry Way and Feltrim Road, tying into the Feltrim Road/Kettle's Lane junction. An indicative route for illustrative purposes is provided below.

This map outlines the route of the proposed improved active travel infrastructure with the addition of a pedestrian crossing facility to be provided at/near the entrance to Kettles Park on Kettles Lane, and treatment of the three roundabouts at Swords Road/Mountgorry Way, Mountgorry Way/Feltrirm Road, and Drinan Enterprise Centre/Liam Rogers Centre/MPETSS.

The tender for consultants is due to be issued in March 2024. With an anticipated concept and preliminary design completion by Q4 2024.



# Scoil an Duinninigh to Waterside Footpath and Cycleway

Planning permission has been granted for the school and the Department of Education is to engage with Fingal County Council in relation to pedestrian access as a condition of the granted Planning Permission. In the interim, a footpath, dropped kerbs with tactile paving have been provided on the route to/from the school and the Feltrim Road.

#### BMCO Area:

#### **Snugborough Road - NAC to Ongar**

The options report for the project has been completed after internal reviews by the Active Travel team and a workshop with the NTA. A Gateway 2 Report has been issued to the NTA and approval to proceed to the preliminary design phase of the project has been received.

The consultant is now engaging road safety audits and environmental screening on the emerging preferred option. Stakeholder engagement continues with the Bus Connects project team for a proposed new signalised junction at Waterville. A draft preliminary design report has been issued to the Active Travel Unit for comment. Further updates will be provided over the coming months, through this report and at ACM level.

#### **Clonee to Blanchardstown Shopping Centre**

All data collection has been collated and has informed the initial development of the options report. The design consultant has been issued with an updated review of the draft Options report and drawings following input from the Active Travel team. Further engagement with Meath County Council and the TII has taken place. Once reviewed a workshop will be held with the NTA.

#### **Castleknock to Dunsink Lane**

This project is now focusing on Auburn Avenue linking into the Royal Canal at the 12th Lock along the Old Navan Road. The Options Report and relevant drawings for Auburn Avenue have been reviewed and approved by the NTA in compliance with the Gateway 2 Hold Point requirements.

A stage 1 road safety audit has been carried out and comments taken into consideration with drawings updated accordingly. Photomontages of the emerging preferred option have been prepared in advance of a public consultation.

A presentation will be given to the ACM in March 2024.

#### Hartstown/Huntstown/Mountview Road

It is proposed to use a newly formed Single Party Framework to progress design from earlier work carried out by the Cycle Design Office. A tender competition has been published to engage the design consultant for phase 2b in this regard. Fingal County Council will progress on finalising the detailed design for roundabout and junction upgrades. This is subject to revision of design standards to ensure compliance with the new National Cycle Manual.

#### Castleknock to Blanchardstown via Farmleigh

Stage 2 of the tender competition for a design consultant and assessment has been completed. Contract documents have been signed and sealed and a commencement meeting has taken place. The feasibility study has started, and traffic and drone surveys have taken place which will help inform the study.

#### **Towns & Villages**

Works are continuing in the development of an Active Travel Plan for a number of our Towns & Villages. Details are outlined below.

#### **New Street**

The Chief Executives report for the Part VIII is has been presented to the area committee meeting and full Council in January 2024. The Part 8 Planning Permissions was passed by a vote of the full council. Development of the brief and tender documents for the detailed design are ongoing at present. It is expected to commence detailed design in Q1 2024.

#### **Balrothery Active Travel Plan**

The design Consultant is in the process of information gathering and have presented their initial findings to the Active Travel team. The consultant will conduct data collection and initial surveys in Q1, 2024. A non statutory public consultation was held on the 20<sup>th</sup> February in Balrothery Heritage centre. The purpose of this non statutory consultation was to gain insights from the public of issues experienced and what they would like to see in their village.

The consultation was attended by a significant number of people from 3pm to 8pm, and included a class from St Oliver Plunketts National School, members from community, recreational, agricultural, and business community groups, as well as members of the public and their families of all ages. It was a very successful engagement. The consultants are in the process of analysing the feedback from that engagement and to assess the opportunities and challenges to be considered in the project.

#### **Skerries Active Travel Plan**

The project team are currently developing tender documents and a consultant's brief for Stage 2 of the tender process to appoint an Integrated Design Team to deliver active travel town plans across the county. The first project to be developed from this consultancy framework will be Skerries Town. It is anticipated to publish Stage 2 tender documents by the end of March. The three shortlisted tenderers from Stage 1 will have approximately 4-weeks to submit a tender response for assessment. The evaluation board will evaluate the tenders received and aim to appoint a consultant to commence services in May 2024 for this framework.

#### **Skerries Harbour Road:**

The Preliminary Design documentation and environmental reports for this project are with the Planning Authority for pre-planning consultation and assessment. The outcome of this will establish the governance and planning route for the project with a decision expected in March 2024. Further meetings will be arranged to update the elected members on the next steps and timelines involved.

#### **Connectivity/Permeability**

We are continuing to receive various requests for Permeability and Connectivity improvements from various stakeholders across the county. These requests are being recorded in detail for evaluation through a multi criteria analysis.

The projects are then reviewed across the departments to identify if an appropriate means of delivery can be established on the ground.

Several projects identified through this process are being developed through the design phases for execution on the ground.

Other projects are being progressed in the areas at either design or construction stage. These Connectivity and Permeability improvements are being delivered in cooperation with our Operations Department. These projects will enhance local communities and provide improved walking and cycling infrastructure within the county.

Greenway connectivity support teams have been convened to review, design, and deliver active travel infrastructure that will enhance accessibility between the proposed strategic greenways and residential, educational, amenity and commercial zones. These support projects have been set up for Fingal Coastal Way, Broadmeadow Way/Sutton to Malahide Greenway and Royal Canal Greenway. This will help to optimise the use of the proposed greenway by both leisure and commuter users.

#### **Newtown Bridge, Balheary Road:**

The Engineering Consultant is currently working with the Project Team to finalise the Non-Statutory Public Consultation Report, the Options report and detailed drawings and screenings on the final option. Once the report has been finalised, it will be published on the Consultation Portal. The project team are working towards going to the market in the coming months for a Contractor to progress to the Construction stage in 2024, subject to approvals.

#### **Rush South Beach:**

The project team and the Engineering consultant have prepared concept design and options report for new universal access path. Discussions with landowners are ongoing, with further meetings in the coming weeks.

We are working collaboratively with the property owners to find an optimal solution that caters for everyone's needs.

#### **Beaverstown Road, Donabate:**

Active Travel is currently at Construction stage for the provision of footpath to link up to existing footpath along Beaverstown Road in Donabate. These works commenced on the 19<sup>th</sup> February and is expected to last 3-4 weeks in total.

Over the past two weeks site clearance works, including the removal of vegetation and setting out of sight lines for the new footpath and fencing has been conducted. The new fencing will be erected over the next week along with the planting of new trees and some landscaping. On completion of these works the new footpath will be installed including the provision of tactile paving and the appropriate dishing at the end of the new path section.



### Balgriffin Park Shared Pedestrian and Cycle Path:

This connectivity piece provides a shared pedestrian and cycle path from the county boundary with Dublin City on Balgriffin Park, to the junction with the R123. This will provide a pedestrian and cycling connection for many dwellings on/near Balgriffin Park to the newly constructed pedestrian and cycling facilities on the R123. Works are substantially complete and snagging is due to take place.









#### **Howth Summit Inn to Bus Stop 567:**

Dropped kerbs with tactile paving have been provided on the route between the Summit Inn and Bus Stop 567. This work has been completed.

#### Offington, Howth:

Junction tightening and provision of tactile paving is complete at three junctions in Offington, Howth: The two junctions of Offington Drive with Offington Avenue and the junction of Offington Lawn with Offington Avenue are complete. This will slow turning movements by motorised vehicles while providing a shorter crossing distance for pedestrians and other vulnerable road users. Grassed areas are also being provided in the new pavement, which will provide additional greening and drainage.

#### **Secure Bicycle Parking Infrastructure**

The Contractor is currently progressing works to install a number of bicycle parking facilities across the Dublin 15 and Swords Areas. Further works are planned in Skerries and Balbriggan in the coming weeks.

18 bicycle parking spaces have been provided in the Dublin 15 Area. Bicycle Parking Sheffield Stands have been installed at the following locations:

- Hazelbury Park, Huntstown, Dublin 15
- Bus Stop 6113, Ongar Distributor Road, Dublin 15
- Bus Stop 7219, Blanchardstown Road South, Dublin 15
- Bus Stop 1902, Orchard Court, Clonsilla Road, Dublin 15

#### Safe Routes to School Round 1 – Tranche 1

The works contractor for the Safe Routes to School Tranche 1 contract is finalising snags at each of the 5 schools. A brief update is provided below for each school site and associated construction works completed to date since the appointment of the works contractor.

#### **Rush and Lusk Educate Together**

Works are now completed on this SRTS Project. The contractor has recently carried out some snagging and maintenance work to the rain gardens and addressed issues that were identified through the independent Road Safety Audit.

#### Castaheany ETNS / St.Benedict's NS

Works are now completed at the school site. The contractor has carried out minor snagging and maintenance on rain gardens. The Stage 3 Road Safety Audit has been completed by an independent auditor.





#### **Bayside Junior & Senior School**

Works are now completed at the school site. The contractor has carried out minor snagging and maintenance on rain gardens. The Stage 3 Road Safety Audit has been completed by an independent auditor. It is anticipated that the Belisha beacons at the zebra crossing will be connected in Q1, 2024.





#### **Scoil Choilm CNS**

Installation of flexible bollards on Porterstown Rd outside the school entrance is complete. These initial works took place before the new school year starts to alleviate poor parking near the school gates. The main works are due to start during Q1 2024.



#### Round 1 - Tranche 2

Detailed Design is complete for the Tranche 2 schools (4 no.) and a tender competition for the construction works has been published with a view to start on site in Q1 2024. This tender is now closed and has been assessed with contract documents issued for signing.

#### Round 2

In mid-December, An Taisce announced Round 2 of the Safer Routes to School programme, with the following Fingal schools selected:

- Holy Family Junior National School, Forest Fields, Swords
- Scoil Bhríde Buachaillí, Church Avenue, Blanchardstown
- Scoil Bhríde Cailíní, Church Avenue, Blanchardstown
- St Helen's SNS, Limetree Avenue, Portmarnock
- St. Colmcille's Girls' National School, Chapel Lane, Swords

The Active Travel team are working closely with An Taisce in relation to data collection and engagement with the schools to develop delivery plans to enable the designers and contractors to carry out the works.

An Taisce are due to provide the delivery plans for each of the schools in the new year that will inform the design process. Fingal County Council has procured the services of a consultants' team that will be working on the designs for these schools.

#### Rush National School:

Active Travel together with Operations have recently launched two public consultations connected to road safety measures in Rush. A School Street initiative for Rush National School and a junction upgrade adjacent to the school are now open for public feedback.

The public has been invited to review plans for changes at Rush National School on the Fingal consultation portal. A proposal has been brought forward by the council's Active Travel unit to provide a School Street in the area. This initiative is being paired with a proposal from the council's Operations unit who have proposed junction upgrade measures at the nearby 5-arm junction at Millbank Road, Chapel Road and Whitestown Road which forms part of the 2024 Programme of Works. Together these upgrades will reduce traffic speeds in the area and provide children walking or wheeling to school with a much safer environment, at and on the approach to the school gate.

#### **TY Girl's Bike Mechanics Course**

We recently rolled out a Bike Mechanics & Safe Cycling Workshops for TY girls, with training led by the Bike Hub, with the first course held at St Mary's secondary school in Baldoyle from 21-23 February. The course was a great success with 24 TY students participating. The rate of Irish secondary school girls who cycle is very low when compared to the number of boys who cycle. The workshops aim to address Ireland's teenage cycling gender gap, increase interest in cycling and normalise cycling amongst teen girls.





#### **Learn 2 Cycle with a Disability**

Our Learn 2 Cycle with a Disability lesson continue to be extremely popular. We are continuing to roll these lessons out across County Fingal, with two more courses starting this March; one in Corduff Sports Centre starting on Saturday 2 March. and another in Luttrelstown community centre starting on Monday 11 March.

Our course in Flemington recently ended and the final lesson in Rivervalley will be held on Monday 26 February. We are putting emphasis on making sure these lessons are promoted across as many channels as possible, to support this we recently shot a promotional video for the course, which we look forward to sharing once the final editing is completed.

During the Winter Period TIER have taken a commercial decision to alter their service provision in areas with limited or no usage. This will enable them to maximise efficiencies in areas of high demand.

Swords, Howth, Malahide and Skerries will see a reduction in eBikes from January to April

Donabate, Rush, Lusk and Loughshinny will see a pausing of the service until the beginning of April 2024.

Dublin 15 will see an increase in the number of eBikes in areas previously underserved. We are currently preparing full tenders for both Pedal and eBikes and we would hope to have these in place by the start of Q2 2024.

#### **ENVIRONMENT**

#### **Climate Action**

The Climate Action Plan 2024-2029 was adopted by the Members at the Council meeting on February 12th, 2024. Section 16 of the Climate Action and Low Carbon (Amendment) Act 2021 states that no more than 30 days after a local authority climate action plan is approved, the local authority shall publish the local authority climate action plan in such a manner as the local authority consider appropriate. The climate action plan along supporting documentation including the SEA and AA Reports, the CE Report, the SEA Statement and Notice of Adoption will be published and available for viewing by members of the public in County Hall, Swords, Civic Office, Blanchardstown and online from Monday 11th March to Friday 12th April 2024.

#### **Community Climate Action Fingal**

The Community Climate Action Fingal Grant application process closed on 28th February. A total of 25 applications were received through the online portal. These applications represent inputs from community groups all over Fingal, many in partnership arrangements, representing climate action initiatives to the value of 1.6m Euro. The Community Climate Action Officer worked with applicants to ensure that the applications included all the relevant quotations and information necessary for assessment. The Council is required to assess the applications and present a portfolio to the Department of the Environment, Climate and Communications before the end of April.

#### **Climate Awareness**

Two Climate Action awareness programmes are being delivered to secondary school students in Fingal. Susan Adams, environmentalist, TED speaker, educator in conservation and founder of non-profit social enterprise Education for Sustainability is on board to deliver an 8-week Climate Literacy Programme to students.

The programme aims to increase climate literacy, foster behavioural change in students, and covers 8 different environmental topics such as climate justice, sustainable development, sustainable transport, and biodiversity loss, among others.

The programme educates young people about the climate crisis and equips them with the knowledge, skills, and tools to take climate action and live sustainably. One of the unique elements of this programme is that it provides training and resources to teachers to enable them to deliver the programme to subsequent year groups.

Students undertake a class action project at the end of the programme to improve their school or local community. Initiatives in Fingal schools so far have included creation of a biodiversity garden, tackling fast fashion through clothes swap shops and 1 school has become plastic free!

Rubbish Film Festival, an exciting digital arts education initiative is also on board to raise climate awareness among secondary school students. Students receive training and support to create short films highlighting climate change and climate action issues. An awards ceremony will be held for best film followed by a regional final. 12 other local authorities are involved in rolling out this programme currently.

#### **Environmental Awareness**

#### **Green Schools**

Currently 26 schools in Fingal County are undergoing assessments for their Green School Flag, a prestigious recognition of their commitment to environmental sustainability.

The Green Schools Programme supports a student lead approach in encouraging school communities to adopt eco-friendly practices and educates young people about environmental issues, while building a sense of citizenship through participation. The assessments this year are focusing on the themes of Bio Diversity, Litter and Waste, Travel and Water and are being carried out by the Environmental Awareness Officer in conjunction with An Taisce. Below is more information regarding the six themes Green Schools covers.



#### Litter and Waste

Examines the impact of litter and waste on the environment and explores practical means for reducing and minimising the amount of litter and waste produced by the school.



#### Energy

Suggests ways in which all members of the school can work together to increase awareness of energy issues and to improve energy efficiency within the school.



#### Water

Provides an introduction to the importance of water both locally and globally and raises awareness of how simple actions can substantially cut down water use.



#### Trave

Suggests ways for pupils, staff and local government to work together to raise awareness of transport issues and come up with practical solutions that will make a real difference to pupils' everyday lives.



#### Biodiversity

Examines the flora and fauna present in the school environment and suggests ways to increase the levels of biodiversity around the school and raises the pupils awareness of biodiversity and nature.



#### Global Citizenship Litter & Waste

Examines what our rights and responsibilities are on a National, European and Global scale and encourages staff, students and parents to look at the impacts our consumptions habits have on other parts of the world.

The purpose of assessments is for schools to highlight the work of their Green School committee and for An Taisce and the Environmental Awareness Officer to make recommendations to support schools on achieving green flag status. From reducing waste to promoting active travel, these assessments highlight the incredible efforts of the schools in Fingal to create a greener communities and provide a platform to showcase Fingal's next generation of environmentally conscious citizens. Best of luck to all schools involved!

The Environmental Awareness Office also sponsored the ECO UNESCO Young Environmentalist Awards.

Over the years a number of schools in Fingal have taken part in the programme, this year involving Pobalscoil Neasáin and Skerries Community College. Castleknock Educate Together were granted funds to cover the costs of biodiversity signage. The Blakestown Mountview Youth Initiative were granted funding for a hot-bin composter at their facility.

#### **Litter Management**

The Litter Wardens carrying out inspection on large scale dumping in the Fingal area. They also continued with their daily patrols and carried out 276 inspections on all known litter black spots in Fingal.









The Litter warden continued to receive several complaints regarding muck on the roads from building sites. They carried out inspections and ensured that the roads were being keep clean of muck and that the building sites had a road sweeper in operation.

They also followed up on reports to ensure farmers were ensuring the roads were keep clean of muck.



The Litter warden continued to raise awareness of the issue of dog fouling on beaches, paths, and green areas in Fingal. They engaged with dog owners and dispensing dog poo bags, making people aware of their responsibilities to clean up after their dogs. They also erected anti dog fouling signage in areas where complaints were received.



The Litter Warden conducted walking patrols, engaging with business regarding their responsibilities to keep outside their premises clean and free of litter. They also checked to see if any issues have arisen for the Operations crews, and they carried out inspections and followed up with fines/warning notice if evidence found.

All the bring banks in the Fingal area were inspected daily to ensure that there was no dumping. Any evidence found was dealt with under the Litter Pollution Acts.



The Litter Warden also investigated reports of abandoned cars, taking photographs and updating the litter app and the CRM system.

There were 12 cases before the district court in February 2024.

#### **Dog Warden Service**

The dog wardens continue to carry out enforcement in relation to breaches of the Control of Dogs Act 1986, Control of Dog Regulations 1998, Parks and Open Spaces byelaws and Beach and Foreshore byelaws. They also educate dog owners on the responsibilities of keeping a dog and remind owners to pick up after their pets when in public places. The dog wardens also increase their patrols of the beaches during the summer months to optimise bathing water quality and retain the status of Fingal's Blue Flag beaches.

The dog wardens are continuing with door-to-door licence checks. Dog owners should ensure that they hold a valid licence for their dog and if issued with a 10-day notice by the dog wardens, should present their licence to <a href="mailto:controlofdogs@fingal.ie">controlofdogs@fingal.ie</a> within the 10 days provided on the notice. Failure to do so may result in a fine being issued for failing to produce a dog licence when requested to do so by a dog warden and keeping a dog without a valid licence. The fine per offence is €100.

There were 297 x 10 Day Notices and 38 Fines issued by the dog wardens during February 2024.

#### **Dog Shelter Service**

Dublin County Dog Shelter holds "Meet and Greet" visits for anyone looking to rehome a dog. Visits can be arranged by calling the shelter and arranging an appointment. These visits can be arranged from Monday - Friday from 11am to 1pm and from 2pm to 3.30pm. The shelter is also open on Saturday from 11am - 1pm. The shelter is closed to the public on Sundays. The dog shelter holds stray dogs picked up by the dog warden and dogs who have been surrendered by their owners either to the dog wardens or directly to the shelter. At the beginning of February there were 27 dogs in the shelter. During February 2024, 13 dogs were brought to the shelter by the dog wardens as stray or surrenders and 2 dogs was surrendered by a members of the public. Of these 27 dogs, 2 has been reclaimed by their owner, 10 dogs have been rehomed to rescue, 3 have been rehomed to members of the public and 6 were PTS. At the end of February there are 21 dogs remaining in the shelter. The shelter has a Facebook page Dublin County Dog Shelter and Instagram Account **@dublincountydogshelter** which they actively update with strays and dogs wishing to be rehomed.



- In Ireland, if you keep, sell, purchase or rehome a dog, your dog must be microchipped and registered on a database approved by the Department of Agriculture, Food and the Marine.
- If your dog goes missing, there is a greater chance of being reunited if your dog is microchipped.
- Please contact your vet for information on microchipping.

The Control of Dogs Section has launched a campaign to circulate leaflets on Responsible Dog Ownership throughout the Fingal area. The leaflet has been shared on our website and has been circulated on social media and will also be distributed to all vets in the Fingal area. The leaflet will also be circulated by our dog wardens where they see a need to issue further information to dog owners. In addition, it has been issued to our Housing Department to give to new tenants with dogs. We will also provide a link in our emails to the public as it covers all aspects of responsible dog ownership.





#### Horses

Weekly welfare inspections continue on Dunsink Landfill to monitor the numbers and welfare of the horses onsite. There are 15 hay feeders being filled by the Operations Department on a weekly basis to ensure adequate forage for the horses on the landfill. Two horses which were removed from the landfill and were returned to their owner at a registered equine premises.





### Environmental Inspection Plan 2023 & 2024 (RMCEI)

An Inspection Plan under the Recommended Minimum Criteria for Environmental Investigations (RMECI) for 2024 is currently being prepared with input from the litter management, environmental awareness, water pollution, air & noise and waste enforcement sections. The 2024 plan sets out targets for the year ahead, taking into account the National Enforcement Priorities agreed by the EPA and other relevant stakeholders for the period 2022-2024.

The plan was due to be submitted to the EPA by the end of February 2024, but a late notification from the EPA to the Local Authorities of the number of farm inspections allocated to each Local Authority in 2024 and 2025 under the National Agricultural Inspection Programme meant that the deadline was extended to facilitate the planning and incorporation of this work into the 2024 inspection plan.

Statistics on environmental complaints and inspections carried out in 2023 have been submitted online to the EPA. A summary of which is produced in Appendix XX.

In addition, a 2023 progress report on the National Enforcement Priorities was prepared by the Water Pollution, Air & Noise and Waste Enforcement & Regulations sections, and submitted to the EPA by the 29<sup>th</sup> February 2024 deadline. The progress report details the work carried out by each of the sections towards each of the National Enforcement Priorities.

The combination of these 3 reports is used by the EPA every year to carry out an evaluation of each local authority performance under the Local Authority Performance Framework. This evaluation for 2023 will be published by the EPA towards the end of the year 2024.

#### **Waste Management Planning**

The chief executives of the 31 local authorities have made the national waste management plan for a circular waste management plan 2024-2030 in accordance with national waste policy "A waste action plan for a circular economy" published by the government in 2020. A briefing meeting was held on February 27th for members to inform them of the steps in making the plan and the contents of the plan. The making of a waste management plan is an executive function (Waste Management Act 1996- 2011 section 22(10)d)

#### Waste Enforcement - CCTV

The commencement orders referred to in last month CE report have now been signed by the Minister.

A total of 18 waste Waste Complaints complaints were recorded for the month of February. Waste complaints investigated primarily related to the illegal backyard storage of waste and the backyard burning of waste. Awareness and education around the management of domestic waste in a sustainable and environmentally safe manner is crucial to ensure all households participate in a waste collection service as per the waste presentation bye-laws and use the three-bin system (black, green and brown) to manage their waste. Waste Prosecutions

In January 2024, Fingal County Council's Waste Environment and Regulation Section successfully prosecuted an individual for the illegal storage of waste in the Dublin District Court. The individual was prosecuted under Section 14 and Section 32 of the Waste Management Act 1996, as amended for failing to comply with a direction to cease storing waste and for illegally holding waste in a manner that was likely to cause environmental pollution.

Additionally, the individual was prosecuted under Section 205(1) of The Local Government Act 2001 for breaches in The Fingal County Councils Segregation, Storage and Presentation of Household and Commercial Waste Bye-Laws 2020.


This was for not having a contract in place with an authorised waste collector for the removal of household waste or providing documentary evidence of how they managed their waste in compliance with this bye-law.

It was a successful prosecution for Fingal County Council as the individual was convicted on all 3 counts and given a global fine of €1,500 and costs of €2,720.

**Waste Facility Permits** - Below is a summary of the activity on waste facility permits in the first 2 months of the year.

A new Waste Facility Permit WFP-FG-23-0002-01 was granted to J. Ryan Haulage Limited for soil recovery at the Barnhill-Ongar Distributor Road. The permit allows for the importation of 25,000 tonnes of waste soil and stone, to be used to raise ground levels to enable the installation of a bridge over the railway line in the construction of the new distributor road.

A reviewed Waste Facility Permit WFP-FG-18-0001-02 was granted to Gannons City Recovery & Recycling Services Limited for the continued operation of their Authorised Treatment Facility at Unit 7 Roseville Industrial Park, Turvey Avenue, Donabate Co Dublin.

There have been several complaints regarding noise from drone deliveries in Dublin 15 following the licensing of Manna to undertake drone deliveries. Fingal County Council do not regulate the drones (outside of parks where the park byelaws apply) which are a matter for the Irish Aviation Authority

Works in relation to the decommissioning of the on-site leachate tanks and reconditioning of the leachate balancing tank and pump works are ongoing with an estimated completion date of 3 months. Pictures above detail the new pumpset and electrical kiosk that will service the new pumping arrangements.

#### **EU** Water Framework Directive (WFD):

Fingal County Council carried out 2 GAP inspections on two farms in the River Delvin and Palmerstown Catchment. The results of the inspections are under review to determine whether the inspected farms are fully compliant with the GAP.



#### **Environmental Inspections for Water**

Water Quality Complaints and Inspections are detailed in the attached Appendix 4.

Inspections of Farmyards: 20 GAP Inspections carried out in farmyards within the functional area of Fingal resulting in enforcement notices and cross reports to the DAFM for non-compliances.

Fingal County Council also carried out reconnaissance land spreading surveys during the land spreading closed season with non-compliant farm operators cross reported to DAFM.

Domestic Wastewater Treatment Systems (DWWTS): The National Inspection Plan sets out a requirement to carry out assessments of 63 DWWTS under the National Inspection Plan 2022-2026.

Fingal County Council assessed 13 DWWTS in 2023 which resulted in the issue of an advisory notice to 1 non- compliant property owner who is required to rectify all non-compliant matters by April 2024.

Section 4 Trade Effluent Discharge Licences: Fingal County Council carried out 64 inspections of the 18 Section 4 licensed facilities in 2023. Non-compliant operators were notified of the exceedance and directed to have each exceedance investigated and resolved. Fingal County Council also initiated a review of 3 Section 4 licences where a licence review is required to ensure the licence addresses the requirements of latest surface water and groundwater regulations.

# **Bathing Water:**

In preparation for the 2024 Fingal County Council has drafted and submitted Beach Management Plans for the Balbriggan and Loughshinny designated bathing areas. The Beach Management Plans sets out a list of measures which Fingal intends to carry out to protect bathing water quality during the bathing water season.

In addition to the beach management plans Investigative monitoring and sampling of the Bracken River continues as part of the out of season management of bathing water at Balbriggan.

The tutor on the evening was Brian Pentony and participants went through a wide range of First Aid scenarios that impact cyclists and coaches. Many of the 15 participants now hope to complete the Accredited Defibrillator Training also organised by the Sports Office in the coming months.





## **SportsCon Teacher Training**

The Sports Office PDP Training for teachers continued with another workshop in St.Francis Xavier SNS Coolmine. 20 teachers took part in the training which complemented the recent MarathonKids, Sports Con and Try Track and Field Programmes delivered in the school. The staff and students now have the skillset to participate and mentor in club and community-based activity programmes in the area.





### **Fingal Athletics League**

This year's Fingal Athletics League launched in February with 62 primary schools and over 2,700 students participating in the cross-country running programme. Schools have been training over the past 6 weeks in preparation for the race meets and the first meet for Dublin 15 schools took place in Porterstown Park on 27th February with 3rd, 4th, 5th & 6th class students from 26 local schools coming together to compete. The first race meet for North County schools took place in Newbridge 29th February with House on students representing 36 schools. The second round of race meets is scheduled for 19th & 21st March followed by the grand finale at ALSAA Sports Complex on 24th April.

#### Parent & Toddler - Holywell

Another initiative run in conjunction with the local residents association in Hoywell the new Parent & Toddler programme started on the Tuesday morning the 20th of February in Holywell Community Centre. The programme incorporates fundamental movement and games for both parent and toddler. The initial eight-week programme is led by a Fingal funded coach qualified in fundamental movement and yoga. The programme received a big uptake from the local residents with over twenty parents their toddlers registered for the initial eight weeks. Showing the demand in the area for activities for this each group.



### **Inclusive Dance - Baldoyle**

Fingal Sport Office have started a block of inclusive dance classes for children with additional needs to attend two primary schools. The sessions are in Baldoyle community hall and fully funded by Fingal Sport. Approximately 15 children between the age of 7 and 10 years are taking part, each supported by their teachers and SNA's. This class will run for 4 weeks.



#### **Coastal CDNT**

The Sport Inclusion Officer for Fingal Sport attended the Parents Forum for the Coastal Area Childrens Disability Network Team. They have a presentation about the SPort Office and the work done by Fingal in the area of Sport Inclusion as well as signposting parents of children with disabilities to the various activities going on locally they may not be aware of. There was a very good response form parents who were delighted to be presented with the information.

#### **Ultimate Frisbee Blitz**

Fingal Sport Office supported Dublin Youth Ultimate with their Girls Cup Ultimate Frisbee Blitz. 150 secondary school girls attended the blitz. As it was an all-girls event, there was a workshop on exercise through your menstrual cycle which each school attended individually. This offered an excellent opportunity for girls to ask questions to a qualified physiotherapist and athlete who could share her experiences of taking part in sport and physical activity throughout various stages of your menstrual cycle.





# **Yoga For Newbies in Balbriggan**

Fingal Sports Office launched an eight-week programme targeting men and women who had never ventured into yoga before, inviting them to join and experience it for the first time alongside peers in similar circumstances. With 18 participants, feedback has been very positive for yoga first timers.



# **Fingal HomeFit Yoga**

The 6-week Fingal HomeFit Yoga programme concluded on February 27th. Between 50 and 150 participants logged on every Tuesday evening and hundreds watched the recordings through our YouTube channel. Participants logged in to learn about the benefits of yoga through breath work, yoga postures, and relaxation.

# Swords Castle Conservation - Presentation to BLFI

At a recent event hosted by Building Limes Forum Ireland (BLFI), Fingal Architects Department presented an overview of the conservation works completed at Swords Castle from 2015-2023. The presentation was made to the BLFI in the context of traditional building methods and materials employed in the conservation process.

### **Building Limes Forum Ireland, BLFI**

The Building Limes Forum Ireland, BLFI, brings together all those involved in the use of natural lime in the building industry from built heritage to sustainable new build. The BLFI provides information on all aspects of lime and its uses and offers a platform for discussion, sharing experiences and knowledge.



#### **Swords Castle**

The works completed in the period from 2015 to 2023 were a culmination of several projects starting in 1985 when Dublin County Council obtained the lands from the Cobbe family. The presentation commenced with a synopsis of the castle history, conservation works completed prior to 2015 as well as the Swords Castle Conservation Plan 2014. It was also outlined how the castle was an integral part of the Sword Cultural Quarter.

## The Project - 2015 To Present

Our presenter at the BLFI event, Brian O'Connor, Executive Architect went on to detail the works completed over the period from 2015 to 2023.

#### 2015 - Activities

Enabling Works started in 2015 with the first removal of vegetation. The grounds were opened to the public in March of that year and public access was maintained throughout the works.

Archaeological digs and mortar sampling were conducted in order that subsequent works were conducted responsibly and in sympathy with the structures' original construction and materials. The National Monuments Service were consulted during this phase as part of the process to get approval on the planned building materials and processes.

#### 2016 Activities - Phase 1

In 2016 there was further vegetation removal on the site and the main areas focussed on were:

- The consolidation of the gatehouse to provide access & protection.
- Old workshop was demolished to provide a new area as a reception/ interpretation pavilion.
- Landscaping & site lighting works completed to facilitate public access to the grounds.
- North Street demolitions & creation of access to the East Wall.
- o East tower temporary bracing installed.
