Future Fingal: An Economic Development Strategy builds on the socio-economic profile prepared as part of the Fingal Local Economic & Community Plan 2023 – 2028 process, and outlines actions to support the local economy over a time horizon of 15 years.

The Strategy has analysed global megatrends and the approaches of other areas in Ireland and across Europe to economic development to identify best practice which has informed Fingal's Strategy. A SWOT analysis of the Fingal local economy has been conducted, with key sectors identified and prioritised to determine what approach the Council should take to support these sectors to grow and develop in a sustainable way.

The Strategy sets out six opportunities, nineteen objectives and an action plan to help realise the Strategy's *vision*, "Fingal's economy will be dynamic, sustainable and inclusive, enabled by strong infrastructure, collaboration and skills."

This vision builds on Fingal's significant existing economic advantages and infrastructural assets, which contribute to national economic performance, including Dublin Airport, proximity to Dublin City and the Port

Tunnel, excellent connections to national road and rail infrastructure and a strategic location on the Dublin–Belfast Economic Corridor.

The County has experienced substantial population and economic growth over the last number of years and we are home to a growing, young, diverse and highly-skilled population. This Strategy will help us sustain and grow our strong economic base and help instil resilience in the local economy in the event of economic shocks such as COVID-19, Brexit and the war in Ukraine. The Council will take a proactive and collaborative approach to the implementation of this Strategy and the delivery of a Marketing Plan for the County which will raise Fingal's profile both nationally and internationally and cement our reputation as an innovative and leading-edge Local Authority in the field of economic development.

This Strategy aims to attract inward investment, stimulate job creation and allow us to develop and retain our highly-skilled local talent. I look forward to working with stakeholders to implement the Strategy and together creating a dynamic, sustainable and inclusive economy, which is resilient in the face of economic and environment challenges and provides a high quality of life for all citizens.

The Vision for Fingal's Future Economy

"Fingal's economy will be dynamic, sustainable and inclusive, enabled by strong infrastructure, collaboration, and skills."

Fingal is a driving force in the Irish economy. The county is home to a burgeoning and well educated population, key infrastructural assets, and sectors of scope and scale – each of which contribute significantly to national economic performance.

Fingal's economy has developed over many decades and is now at a juncture where considerable opportunities for further evolution are present, notably relating to:

- Forecasted expansions in the county's population;
- Sectors of existing strength, and emerging sectors, which have potential for substantial future growth;
- Seizing the opportunity from global megatrends such as Artificial Intelligence and place management, which will be influential; and
- The advance of sustainability as an imperative for societies globally.

While these factors present opportunities for Fingal, they also constitute challenges in terms of planning and providing for the future. This includes ensuring that the county has the local labour pool, infrastructure, and business supports in place to stimulate and support growth. It also extends to building Fingal's interconnectedness domestically and internationally, and raising the county's profile as an economic force.

This Economic Development Strategy pulls these strands together, and plots the course for the Fingal economy

over the next 15 years. The strategy – which is to be reviewed at two year intervals in line with Local Economic & Community Plan implementation revisions – has been devised under the stewardship of the Economic, Enterprise, Tourism and Cultural Development Department of Fingal County Council – based on a rigorous process of key stakeholder engagement and primary and secondary research which encompassed:

- Socio-economic profiling of the county based on latest available Census data;
- 2. An assessment of policies and global megatrends which will influence aspects of the Fingal economy's evolution:
- 3. Consultations with over 30 stakeholders from across the local economy;
- 4. Surveys of both residents and businesses;
- 5. Analysis of economic development initiatives in eight other jurisdictions;
- 6. Engagements with Councillors and Council subcommittees; and
- 7. The contents of this strategy are the culmination of the consultations and research undertaken.

Fingal's vision encapsulates the opportunities and challenges which Fingal faces over the coming years. Developing and maintaining a dynamic, inclusive and future-proofed economy will require ongoing investment in skills and infrastructure (in all forms including transport), and targeted supports for areas of disadvantage.

Collaboration will be a key theme as it is inherently unrealistic that Fingal County Council can unilaterally execute on this economic development strategy. Buy-in and partnership with multiple stakeholder groups – including the private sector, central government, state bodies, representative groups, and education providers – is hence essential.

In sum, Fingal is seeking to sustainably develop its economy, thus providing opportunities for all residents and businesses to excel over the coming 15 years, while remaining cognisant of the climate and biodiversity challenges which currently exist.



Fingal's Grand OpportunitiesA Thematic Approach

In order to pursue Fingal's vision for its future economy, a series of 'grand opportunities' have been identified. Each grand challenge, outlined below, represents an opportunity for Fingal to further improve as a place to invest, work and operate. **Sustainability** is an overarching challenge which affects economies globally and will continue to be influential over all aspects of economic development in the decades ahead. For the Fingal economy, developing **skills** which are appropriate for present and future needs is essential, especially as new technologies impact many occupations.

Developing **vibrant places**, both in urban and rural areas, is a further grand challenge so that all residents and businesses in the county have the conditions to thrive. This extends to how Fingal can **grow & attract** enterprises of all sizes with supports and cluster development. **Infrastructure** provision will be central, especially in relation to housing, business infrastructure, public transport and energy over the forthcoming years. Finally, Fingal competes in a global economy and so developing its international presence and brand is a challenge, specifically with regards to investment and tourism.

Sustainability

Fingal's economy will be developed in accordance with a broadened Sustainable Fingal Initiative which facilitates and supports businesses and sectors in the transition to a Net Zero county, and maximises the opportunities which energy presents.

Skills

Fingal will build a deep labour force with skills which are appropriate for businesses' needs and adaptable for the county's future economy.

Fingal's Grand Opportunities Opportunity 1: Sustainability

Fingal's economy will be developed in accordance with a broadened Sustainable Fingal Initiative which facilitates and supports businesses and sectors in the transition to a Net Zero county, and maximises the opportunities which energy presents.

The environmental and biodiversity issues which currently exist present the greatest global challenge of our time. The need for immediate action is clear, and is iterated across government levels from the United Nations Sustainable Development Goals (SDGs) to Fingal's Climate Action Plan.

Stakeholders in the Fingal economy fully recognise that further action is needed now and in to the future to ensure that the Fingal economy develops sustainably.

Objectives 1.1 and 1.2 summarise the high level sustainability objectives for Fingal's economy. The broadening of the Sustainable Fingal Initiative is an objective aimed at capturing in granular detail the specific actions, milestones, responsible parties, and timelines involved in moving towards a Net Zero county – in lockstep with the Fingal Climate Action Plan.

While representing only one aspect of the sustainability challenge, energy is a key area of opportunity for Fingal. Offshore wind power in the Irish Sea, and the potential impact of alternative energies, are just two examples of where the county can rise to the fore in decarbonising energy.

Fingal's Grand OpportunitiesOpportunity 2: Skills

Fingal will build a deep labour force with skills which are appropriate for businesses' needs and adaptable for the county's future economy, in alignment with the Fingal Skills Strategy.

Labour and skills availability are two of the biggest challenges currently facing the Fingal economy. This applies across sectors – from construction and retail to hospitality and pharmaceuticals. While there will be undulations in the labour market over the coming years, and 'full employment' will come to an end, global megatrends and changes in businesses' needs will drive demands for new and improved skillsets across the labour pool in the county.

Per Objective 2.1, the frequent compilation of **Labour Market Intelligence** on businesses' skills needs is an important first step so as to ensure education and training initiatives are addressing areas of need.

Enabling the economically inactive to (re) enter employment is a means to both contribute towards tackling disadvantage, and broaden the labour market, and can be targeted via employability interventions as set out in Objective 2.2.

The reality that the economy will change dramatically over the coming decades through climate change and automation/Al presents a **re-skilling/up-skilling** challenge. Objective 2.3 is a further means to support this transition and broaden the talent pool.

The provision of further education options is an additional means via which the skills base in Fingal can be strengthened. Dublin and Dún Laoghaire ETB's (DDLETB) plans for a **College of The Future in Swords** are central to this, and are supported under Objective 2.4.

Fingal's Grand Opportunities Opportunity 3: Vibrant Places

Fingal's economy will be supported to maximise growth opportunities across geographic areas.

Fingal's towns, villages, rural and coastal areas are all vital to the current and future economic performance of the county. Stimulating greater local economic activity is a means to support balanced growth across the county. This includes providing greater access and infrastructure, and ensuring Fingal's towns and villages remain vital components of the local economy – in spite of challenges in recent years related to footfall as online and shopping centre retail options have combined to 'hollow out' activity in conurbations such as Balbriggan and Swords.

For all geographic areas, Objective 3.1 underlines how innovative and collaborative initiatives to boost local economic activity and spending will be central to the future development of **vibrant places** in Fingal. This will include initiatives to support retail, local supply chains, the night-time economy, rural diversification, and remote working – the latter of which is seen as an area of potential as fewer residents are now required to travel outside the county for work purposes.

Objective 3.1 Vibrant Places

Support rejuvenation across all geographic areas of Fingal through collaboration and the implementation of innovative and targeted solutions which boost economic activity.



Fingal's Grand Opportunities Opportunity 4: Grow & Attract

Fingal will support enterprises of all sizes to grow and will develop clusters which further expand the influence of key sectors in the county.

Fingal's economy benefits massively from a broad sectoral mix of businesses; from large international-focused industries such as life sciences and aviation, to more localised sectors in retail and hospitality. It is evident that businesses of all sizes in the county require supports of some form in order to thrive, with certain sectors needing specific interventions to spur further expansion.



Business supports and engagement are common needs across the board, so that businesses have the resources to succeed, and the fora to voice concerns and build relations with key local stakeholder groups. These are the focus of Objective 4.1.

The development of more formalised cluster structures is central to Objective 4.2, and will focus on a select number of sectors which have the scale to excel both nationally and internationally.

Objective 4.3 centres on tourism which has the potential to grow over the coming years if initiatives are implemented to promote the county appropriately and make it more accessible for tourists.

Agri-food faces challenges in terms of sustainability and career development, and is hence captured under objective 4.4. Tapping in to close-proximity supply chains and setting clearer career pathways are means to further growing the sector in future.

The Vision for Fingal's Future Economy Opportunity 5: Infrastructure

Fingal's economy will be supported by business, transport and other physical infrastructure which makes it a more attractive place to invest, operate, visit, live and work.

While Fingal's infrastructure network is strong – with notable emphasis on the airport, motorway and rail network – further investment will be required to facilitate the future economy and population of the county, in alignment with the Fingal Development Plan 2023-2029. Infrastructure is a key concern and priority area for businesses in Fingal, with housing raised as a major issue during the research phase of this strategy.

Fingal has tracts of **economic land** available.
Undertaking assessments and devising appropriate plans to activate key sites are captured under Objective 5.1

The enhanced provision of **enterprise units**, along with curated networks and a range of business supports including access to expertise which enable small businesses to grow is the focus of Objective 5.2, along with making greater use of the existing remote working units which are available in the county.

The Fingal Development Plan provides a framework for the provision of **housing** across the County, and Objective 5.3 centres on further promoting the needs of businesses and residents with regards to the location, scale and scope of housing development.

Connectivity mainly focusses on public and road transport under Objective 5.4. Championing MetroLink is essential in this regard. Dart+, BusConnects, road improvements in specific locations, and active travel/ greenway projects are also central – while connectivity in the form of broadband availability must be addressed in the shorter-term.

Objective 5.5 centres on **Dublin Airport** and the support of its balanced development in accordance with the applicable National Aviation Policy, County Development Plan, Local Area Plan, legislation and permissions.

Fingal's Grand Opportunities Opportunity 6: International

Fingal will build its international presence through networks, trade, and promoting its unique economic offering as a means to develop tourism and attract foreign direct investment.

Fingal is to the fore in terms of economic development in Ireland, yet could further broaden its appeal internationally. While Dublin and Ireland are recognised across the globe – to the benefit of all Local Authority areas in Dublin it must be iterated – differentiation of Fingal is a means to attract further investment and tourism in particular.

The **brand/promotion** of Fingal is vital. The Marketing Plan which accompanies this Economic Development Strategy sets out clear steps to heightening Fingal's profile for investors and tourists, and addressing Objective 6.1.

Trade is a further objective. Brexit remains an issue for businesses in the county and continuing to provide supports for traders is essential. The Dublin-Belfast Economic Corridor provides further scope for increased cross-border trading and is a means for Fingal to broaden its trade volumes and profile under objective 6.2.

International **networks** also present an opportunity for Fingal to raise its profile. European Union inter-regional working groups are one example of fora via which the 'pros' of Fingal can be promoted. This also applies to engagements with the likes of IDA Ireland to ensure that Fingal continues to develop in accordance with the needs and expectations of foreign direct investors, and is continually promoted as a destination.

1. **Short term:** 1-2 years (2024 & 2025) **2. Medium term:** 3-6 years (2026 – 2029) **3. Long term:** 7-15 years (2030 – 2038)

The Government's multibillion euro housing plan for 2021 to 2030 to address current and future housing shortages and challenges via the delivery of an average of 33,000 new homes each year.

Leader Developme Strategy 2023

A multi-annual programme for rural development co-funded by the EU through the Common Agricultural Policy Strategic Plan, it plays an important role in supporting communities and enterprises in progressing job creation, social inclusion and environmental projects at a local level.

Regional and Local —

Eastern and Midland Regional Assembly Regional Spatial & Economic Strategy

Sets out spatial and economic growth plans for 2019 to 2031 covering infrastructure development, education, housing, access and balanced sustainable growth.

Dublin Regional Enterprise Plan

To stimulate collaborative initiatives to help deliver enterprise growth across Ireland, it aims to promote coherence and collaboration including economies of scale and place-based perspective.

Fingal County Development Plan 2023 – 2029

Centred around economic prosperity, the plan focuses on areas including housing, economic development, sustainability, rural and urban development, and climate change.

Megatrends

Global trends of greatest direct relevance to Fingal's future economy

Changing Demographics

Fingal has experienced rapid population growth and boasts the youngest average age (36.2) in Ireland. It will be essential to develop strategies to facilitate sustainable growth and foster social cohesion.

Skills

Skills required for successful economies are everchanging. Technology skills advancements, critical thinking/problem solving, emotional intelligence, innovation, adaptability and skills in the green economy are critical for Fingal's economic growth.

Smart Cities

Rapid urbanisation and technology advancements are stimulating smart city developments. Concerns over energy and reducing carbon will further push the need and adoption of smart city infrastructure over the coming years in Fingal.

Place Management

As one of the fastest growing counties in Ireland, creating or enhancing assets to improve Fingal's 'liveability' and attractiveness will be paramount.

Foreign Direct Investment

While 'traditional' FDI sectors will remain to the fore and are key economic drivers, Fingal can avail of potential future drivers which include cybersecurity, Al, Blockchain, Fintech, Cleantech, Agritech, disposable medical products and E-commerce.

Shifting Supply Chains

Economic, political and sustainability factors are placing emphasis on shorter regional supply chains. Fingal's location on the Dublin-Belfast Economic Corridor, and its proximity to Dublin Airport and Port, make it a key location for supply chains.

New Economy

Technological innovation is moving quicker than ever across areas including machine learning, artificial intelligence (AI), automation, robotics, blockchain, DNA sequencing and material science.

Net Zero 50

To combat climate change and achieve carbon neutrality by 2050, Fingal County Council's Climate Change Action Plan sets out how it will cut the county's emissions in half by 2030, helping Ireland to reach Net Zero by 2050.

Sector Prioritisation Sectors of Focus for Fingal's economy

Focus and step change: These are 'critical for growth' sectors which are considered likely to have the potential to support significant economic growth. Such sectors are of key economic development opportunity for Fingal, and should be prioritised for the allocation of resources and effort.

Transport and Storage

Already one of the largest sectors in Fingal, Transport and Storage will play a key role in the future growth of the county. The sector can take advantage of the shift of supply chains from global to 'closer to home', and the impact of localism on the economy. The county will benefit from the close proximity of Dublin Airport and Port, and should also look to avail of its unique position on the Dublin-Belfast Economic Corridor in the post-Brexit era.

ICT

The ICT sector is one Fingal should continue to invest heavily in, given the rate of technological innovation. Industry 4.0 and 5.0 are driving the manufacturing space, with ICT key to the transition. Challenges of automation, digitalisation, climate change and the importance of data suggests significant forthcoming growth in ICT. Technology is changing the skills profiles required in the workforce across all sectors including

manufacturing ecosystems. Therefore it is essential that adequate skills are in place. This further aligns with Ireland's Industry 4.0 Strategy 2020-2025.

Circular Economy

Future Fingal: An Economic Development Strategy / February 2024

The circular economy is a sector for focus, especially in the context of Fingal's plans to become a leader in promoting circular principles and practices in the county. Given the importance of sustainability and the environment to the local economy and society, alongside energy targets, the circular economy is of upmost importance. Ensuring adequate resources, skills and education routes are in place are key for growth in this sector, with Fingal having already adopted various strategies and action plans, and participation in the Circular Cities Declaration network.

Life Sciences

Fingal currently boasts a large pharmaceutical cluster, hosting many multinational companies. Further growth can be derived from the demand for medical technologies and the growing need for research innovation around the life sciences sector. Fingal can also take advantage of its strong ecosystem of life sciences and technology, with the potential to become a leader in the Digital Health sector by drawing on existing talent and capabilities.

Sector PrioritisationSectors of Focus for Fingal's economy

Sustain and Grow: These are core sectors for Fingal's economic development, each with the scope to enable (potentially significant) incremental growth. These sectors should be cultivated and nurtured to support future economic expansion.

Tourism

Fingal's proximity to Dublin Airport, its cultural assets, coastal towns and heritage can sustain and grow the tourism sector in the county, with the aid of appropriate transport access and promotion. Given its strong agricultural presence, agri-food tourism has been identified as a further growth opportunity – with agriculture, food and tourism working collectively.

Agri-Food

Agriculture has been and remains a mainstay of the Fingal economy, especially in rural and northern parts of the county. The sector is a vital employer, and has scope to further expand over the coming years. Climate change will play an influential role and adaptation will be required in order to fully maximise opportunities which agri-food and food tourism present. The sector can also benefit from localism, to the benefit of local producers and the environment, in alignment with the new Fingal Food & Drink Policy 2023 – 2029.

Financial Services

Financial Services is an established sector in Fingal and plays a key role in the local economy. It is a sector which the county should look to sustain, especially given its importance as an employer. To further grow the sector, Fingal should exploit opportunities relating to Fintech by combining its existing financial services and ICT strengths. This is particularly the case given that Fintech globally is expected to become a \$1.5 trillion industry by 2030.

Sector Prioritisation Sectors of Focus for Fingal's economy

Monitor and Intervene: These are sectors which, while important to the local economy, may not produce sustained growth over the coming years. As such, these sectors should be monitored on an ongoing basis to ensure growth opportunities are taken as they arise.

Retail (Town Centre First)

The retail sector is traditionally market-led, with success being closely aligned with consumer confidence. The ramifications of Covid-19 and rising inflation have led to cut-backs in discretional spend and reductions in consumer confidence.

The regeneration of town centres will be key to the rejuvenation of the sector locally. Fingal should look to intervene in this sector where issues arise i.e. connectivity and access to labour.

Construction

Construction is traditionally a boom and bust sector, market-led, and aligned to investor and developer confidence and the availability of capital. As such, there are limited levers for Fingal policy makers to directly support this sector, but as a major enabler of other economic activity, close monitoring is required. Projects including 'Our Balbriggan', a potential College of the Future in Swords, varied housing developments, and MetroLink will all require significant construction capacity availability – and hence potential intervention on the part of Fingal County Council.



Key Topics for Fingal Economic StakeholdersFeedback received

As part of the consultation process for this Economic Development Strategy, more than 30 stakeholders were engaged via one-to-one engagements, with 150 taking a survey on local economic development.

These stakeholders were from diverse backgrounds including:

- · Local Government;
- Private sector companies;
- · Education providers;
- · Representative bodies; and
- · State bodies.

Feedback received was wide-ranging, yet a series of common topics arose. The infograph shows 12 key topics which were raised by stakeholders. While all topics were raised in numerous instances, the following were most prevalent and pressing for those consulted:

- 1. Housing;
- 2. Infrastructure and planning;
- 3. Labour market and skills; and
- 4. Sustainability.

Not all of the above aspects can be directly tackled via this economic development strategy, but – at a minimum – objectives have been included which provide the grounds for constructive action to be taken.
