Updates from the International Prtoection Office

Implementation of Paperless Procedure

• The IPO is adopting a digital first approach, phasing out the use of paper files. This will improve the service to applicants and help the IPO to speed up processing times to give people decisions on their cases as quickly as possible. With effect from 1 September 2023, all correspondence must be submitted by email only to info@ipo.gov.ie unless the IPO has specifically requested the submission of original copies of official documents by post. The IPO will return all unsolicited documents sent by post to sender and will not take any action in relation to them. Applicants and their representatives may continue to submit any documentation they wish by e-mail.

Update from the Ukraine Crisis Temporary Accommodation Team

Addendum to the Absence Protocol for BOTP Christmas 2024

It has been agreed that for the period of 23 December 2024 - 08

January 2025 BOTPs will not be subject to the Absence

Protocol and may travel freely (applications to UCTAT do not need to be made in advance). BOTPs must have returned to their State funded temporary accommodation by 08 January 2025, or risk losing that accommodation. During this time BOTPs must continue paying the mandatory contribution charge to their accommodation provider.
