CASUAL TRADING APPLICATIONS 2025

Fingal County Council invites applications from interested traders for unoccupied Casual Trading Pitches for the period **1st March 2025 – 28th February 2026**.

Casual Trading Areas are designated under the Casual Trading Bye-laws 2021 which allows for the sale of specified goods at a place (including a public road) to which the public have access as of right and any other place that is a designated Casual Trading Area.

The Casual Trading Bye-laws cover the control, regulation, supervision and administration of casual trading in the Fingal area.

The closing date for receipt of Applications is **Wednesday the 26th February 2025 at 4pm.**
