- Portrane Road, Donabate, Co Dublin. 1 No. Raised Uncontrolled Crossing.
- Gaelscoil Na Mara, Donabate, Co. Dublin. 1 No. Flat Top Traffic Calming Ramp.
- Cianlea, Swords, Co. Dublin. 2 No. Round Top Traffic Calming Ramps.
- Holywell, Swords, Co. Dublin. 1 No. Bus Friendly Ramp with Zebra Crossing Road Markings.
- Flemington Lane Balbriggan, Co. Dublin. 11 No. Round Top Traffic Calming Ramps.
