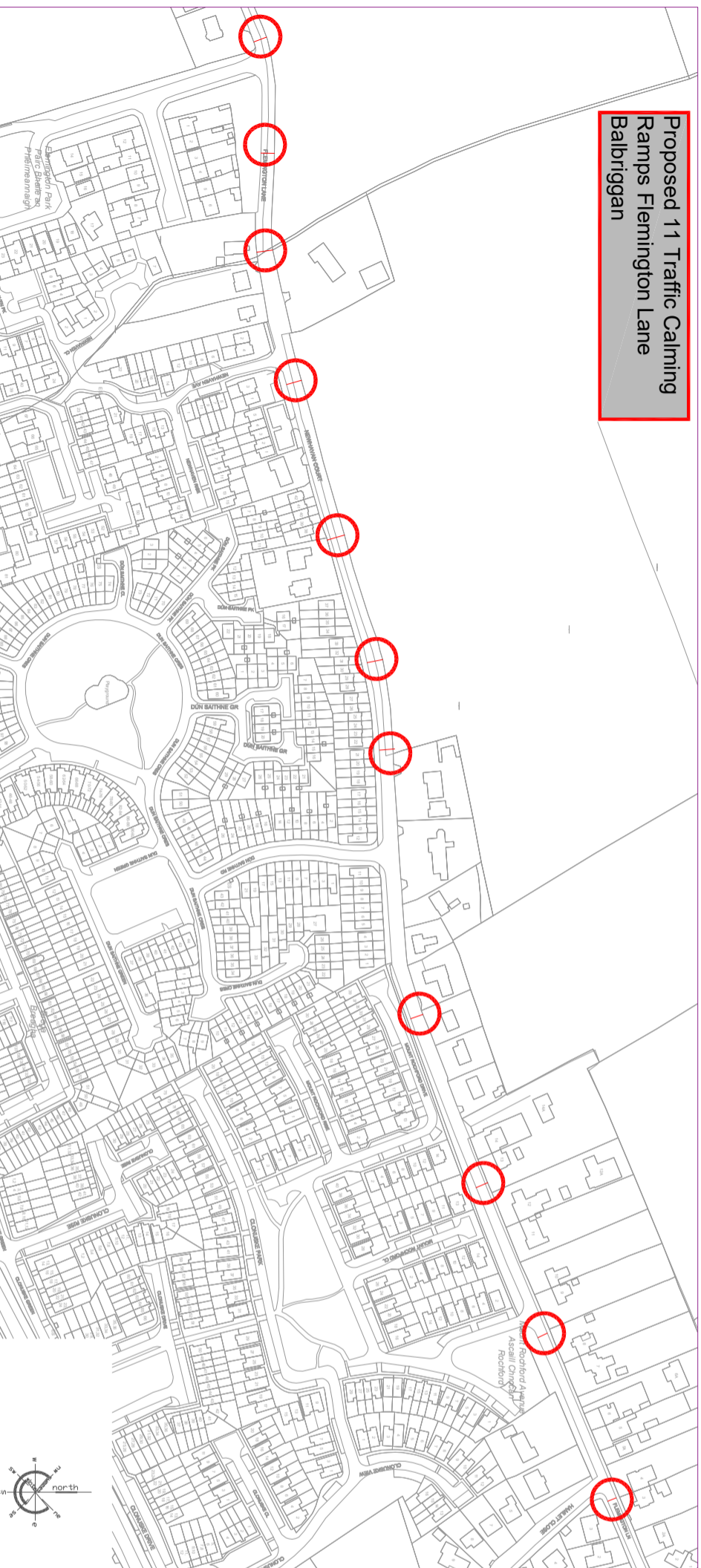
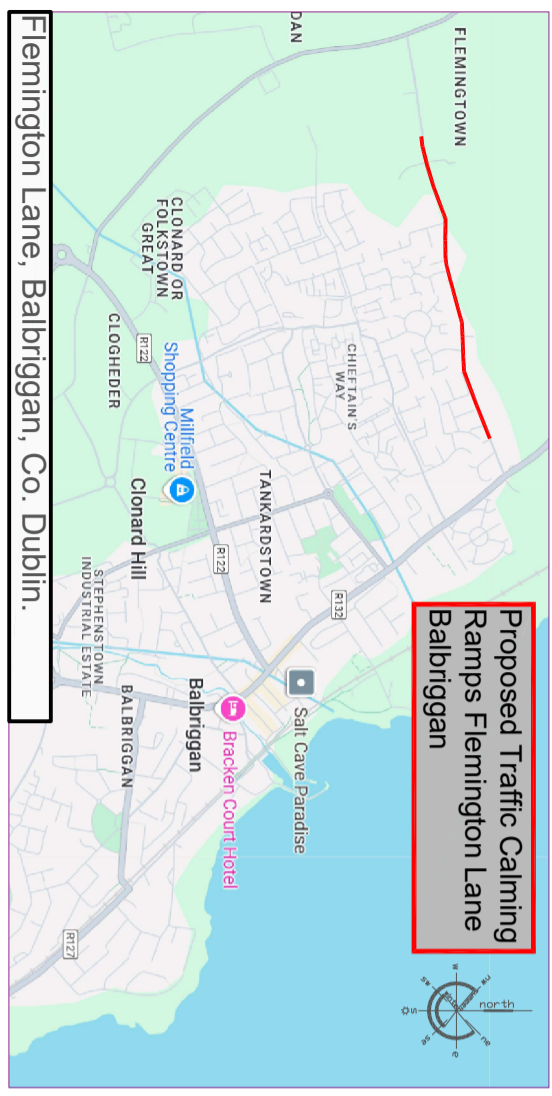


Proposed 11 Traffic Calming Ramps Flemingington Lane Balbriggan

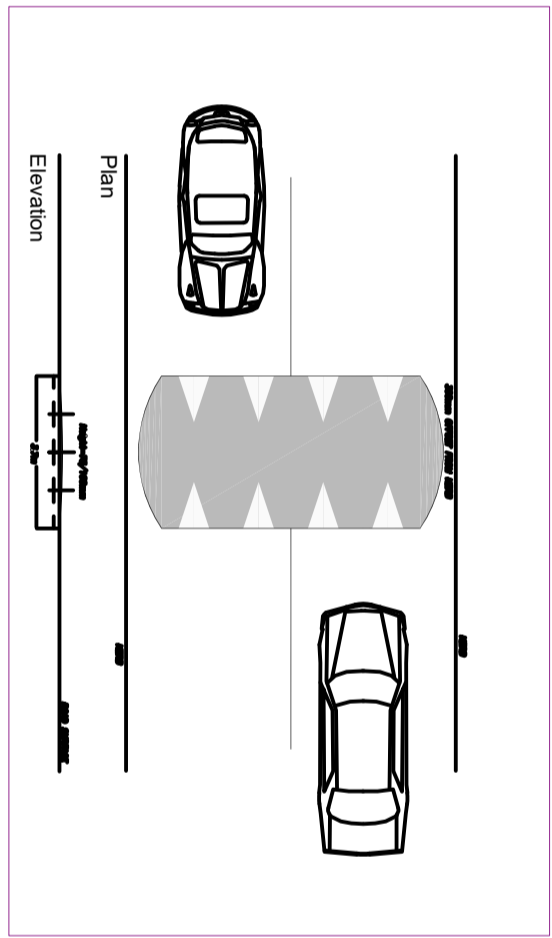


Site Layout

Fingal County Council in exercise of the powers conferred under Section 38 of the Road Traffic Act, 1994 and Section 46 of the Public Transport Regulation Act, 2009 hereby gives notice that it has prepared a Scheme for the provision of traffic calming measures at the following locations:

- Portrane Rd Donabate, Co Dublin. - 1 No. Bus Friendly Ramp Traffic Calming Ramp.
- Gaelscoil Na Mara, Donabate, Co. Dublin. - 1 No. Flat Top Traffic Calming Ramp.
- Clanlea, Swords, Co. Dublin. - 2 No. Round Top Traffic Calming Ramps.
- Holywell, Swords, Co. Dublin. - 1 No. Bus Friendly Ramp with Zebra Crossing Road Markings.
- Flemingington Lane, Balbriggan, Co. Dublin. - 11 No. Round Top Traffic Calming Ramps.

The scheme includes the provision of traffic calming ramps, appropriate road signage and road markings where necessary. Plans and particulars of the Scheme as shown on Drawing Numbers 2025-PD-TC-BRLS-001 to 2025-PD-TC-BRLS-005, are available for inspection from Thursday 13th March 2025 as follows:-
